# **Background**

In today's interconnected world, where conflicts occur in several parts of the world and also on European soil, legal practitioners play a crucial role in upholding justice, promoting accountability, and safeguarding the rights of individuals affected by armed conflicts and crises.

The contemporary legal landscape is marked by intricate challenges arising from armed conflicts, humanitarian crises, and human rights abuses. European countries are signatories to numerous international treaties and conventions governing human rights and humanitarian affairs. It is incumbent upon legal professionals to ensure compliance with these obligations, both at the domestic and international levels. By fostering expertise in international humanitarian law (IHL) and international human rights law (HRL), legal practitioners can contribute to upholding their countries' commitments under international law and promoting a culture of respect for human dignity. Moreover, by promoting adherence to legal norms, legal professionals can contribute to preventing future violations and fostering sustainable peace and justice.

Since February 2022, Ukraine has faced the Russian Federation's brutal and unprovoked military aggression. As gross violations of IHL and IHRL are committed by the Russian military forces and other armed groups controlled by the said state on Ukrainian soil, there is a strong need for training of European legal practitioners (prosecutors, investigators, lawyers, academics and students) on (i) IHL - the legal framework applicable to situations of armed conflict and occupation and which aims, for humanitarian reasons, to limit the effects of the said conflict and (ii) related standards of the IHRL, and in particular the ECHR, as the protection afforded does not cease in the case of armed conflict, as confirmed by the ICJ and ECtHR. Aligned with the Committee of Ministers' decision CM/Del/Dec(2022)1442/2.3, it emphasises the prevention of impunity and further violations.

Training on international humanitarian law and human rights is not only justified but imperative in the current context. By equipping legal professionals with the knowledge, skills, and tools necessary to address complex legal challenges, uphold human rights, and promote accountability, such initiatives contribute to the advancement of justice, peace, and respect for human dignity within European societies and beyond.

#### About the HELP course

The course unfolds how human rights law continues to apply in situations of armed conflict alongside international humanitarian law - a special regime in public international law designed to protect the basic values of humanity during the war. It explains the interplay between the two branches of law, exploring how they are applied in practice when it comes to key human rights, such as right to life, the absolute prohibition of torture and other forms of ill-treatment, right to liberty, right to a fair trial and so forth. The course pays special

attention to the implementation of human rights law and international humanitarian law at the domestic and international levels, as well as to the ways of ensuring accountability for their violation. It also presents the relevant case-law of the European Court of Human Rights and international criminal tribunals.

This HELP course was developed in 2024 by the Council of Europe HELP programme, within the framework of the Project "HELP (Human Rights Education for Legal Professionals) for Ukraine, including during wartime", implemented as a part of the Council of Europe Action Plan for Ukraine "Resilience, Recovery and Reconstruction" (2023-2026).

The course is primarily addressed to legal and justice professionals (judges, prosecutors, lawyers) wishing to enhance their knowledge on international humanitarian law and its interplay with human rights law. The course can also be used by anyone interested in the topic.
