#### General remarks

The officials responsible for the public companies and private institutions in charge of communications will have to:

1.- Give all the facilities so that the measures ordered by the competent Judge become effective.

2.- Abide by the court order, in such a way that the execution of the ordered measure is not delayed, hindered or impeded. (Ley sobre Registro, Secuestro y Examen de Documentos Privados e Intervención de las Telecomunicaciones 7425 de 9 de agosto de 1994 Artículo 23).

##### **General remarks**

Ley sobre Registro, Secuestro y Examen de Documentos Privados e Intervención de las Telecomunicaciones 7425 de 9 de agosto de 1994

Artículo 2.- Atribuciones del Juez.

Judge may order at the request of the police authority in charge of the investigation, the Public Ministry or any of the parties to the process, the registration and examination of any private document, as long as it can serve as indispensable proof of the commission of some criminal conduct. The Judge will personally carry out the procedure, except in exceptional cases, in which, according to his criteria, he may be delegated to members of the Judicial Investigation Agency or the Public Ministry, who must inform him of the result of the procedure.

##### **Competent Authorities**

The competent authority to investigate crimes in Costa Rica is the Ministerio Público (Public Prosecutor) with the support of the Judicial Police.

ARTÍCULO 65.- Cooperación internacional Cuando las actividades delictivas se realicen, en todo o en parte, fuera del territorio nacional, o se les atribuyan a personas ligadas a una organización de carácter regional o internacional, en los casos en que deba aplicarse la legislación penal costarricense, el Ministerio Público podrá formar equipos conjuntos de investigación con instituciones extranjeras o internacionales. Los acuerdos de investigación conjunta deberán ser aprobados y supervisados por el Fiscal General.

The official authorities and channels for international extradition are the Office of the Attorney General (Procuraduría General de la República) and the Ministry of Foreign Affairs (Ministerio de Relaciones Exteriores de la República de Costa Rica).
