# Structure of the draft Guidelines on Men and Boys 22th GEC meeting, 16-18.11.2022

## Structure of the draft guidelines (1)

- ✓ **Preamble:** paragraphs 1 to 16
- ✓ **Operative part:** paragraph 17
- ✓ **Part I “Objectives and fundamental principles”**  
(paragraphs 18 to 29): explaining the political framework and context
- ✓ **Part II “Proposed measures for member states”:**  
an introduction and 5 thematic sections:
  1. **Care issues** (§32 to 45)
  2. Men and boys as **agents of change** and countering resistance to GE (§46 to 62)

## Structure of the draft guidelines (2)

3. Reducing the negative **impacts of gender stereotypes on men and boys** (§ 63 to 76)
  4. Strengthening the role of men and boys in **combating violence against women** (§77 to 90)
  5. **Research** and data collection (§91 to 99)
- ✓ For each of the 5 thematic policy sections, introductory **paragraphs explain the context** for the proposed measures
  - ✓ **Part III “Reporting and evaluation”**

## Formatting of the consolidated document (1)

- ✓ **Only formal amendments** were included in the consolidated document, not comments
- ✓ **Name** of proposer before the amendment and between brackets [ ]
- ✓ **Proposed added text** is underlined & **bold**
- ✓ **Proposed Deletions** are ~~crossed out~~ and **bold**
- ✓ **Some paragraphs are repeated** when there too many amendment on the same paragraph
- ✓ New proposals are numbered with “bis” or “ter”

## Formatting of the consolidated document (2)

- ✓ Some **amendments are repeated** throughout the document and could be decided upon once
- ✓ The **consolidated text will be projected on screen** and edited during the meeting
- ✓ The **original text** adopted by the Working Group will be **distributed in the room**
- ✓ **The order of the sections** may be changed at a later stage (care issues moved as third section instead of first)
