









1. Judicial organisation in Ireland (2022 data)

In Ireland, there are only three first instance courts (as legal entities) exercising general jurisdiction for the entire State (the High Court, the Circuit Court and the District Court). Each of those three courts has a single court president only, who exercises a nationwide remit for his/her court. The number of geographic locations reflects the physical location serving as seats or venues for the three jurisdictions.

Evolution of total number of courts










The distribution between first instance general jurisdiction courts and first instance specialised courts in Ireland is 60,0% - 40,0% which indicates higher representation of specialised courts than the distribution tendency in EU that shows ratio 72,8% - 27,2%.

There are currently two Special Criminal Courts in Ireland who (in general) deal with crimes relating to terrorism and organised crime: Special Criminal Court No. 1 and Special Criminal Court No. 2. The latter was established in October 2015 and came into operation, sitting for the first time, in 2016.

Other than distinctions between jurisdictional levels there is no specialisation - all judges within a court jurisdiction may be allocated to any category of case falling within the jurisdictional remit of the court concerned. Starting in 2013 a new cadre of specialist judges was created in the Circuit Court with specific jurisdiction in relation to certain types of personal insolvency remedy and certain pre-trial order making powers.

Ireland has a specialist regime for the trial of commercial proceedings in the form of the Commercial List of the High Court (known as the 'Commercial Court') but, as it is not a separate legal entity, being a list within and formally a part of the High Court, it is not included as a specialist court as such.


Furthermore, there are other tribunals or bodies outside of the court system which have powers to make determinations in some of the matters in the table (e.g., the Labour Court and Military Courts) but these tribunals are not within the courts system.






According to 2022 data, the total number of professional judges sitting in courts (all instances) in Ireland is 171, which is 0,6% more than in previous cycle.



In this cycle, the total number of female professional judges (all instances) is 73, which represents 42,7% of the total number of judges.

The total number of judges is distributed among the different judicial instances in the following way: 146 are sitting in the first instance courts (of which 61 are female); 16 are sitting in the second instance courts (of which 9 are female) and 9 are sitting at the Supreme Court (of which 3 are female).

Compared with the EU distribution of professional judges per instance, Ireland shows a larger percentage of judges in the first instance courts (85,4% compared with 73,8%), and significantly lower number of second instance judges (9,4% compared to 23.2%). The percentage of judges at the Supreme court level is slightly higher than EU median (5,3% compared to 4,0%).

As regards the distribution male/female, it has to be specified that female judges represent minority in courts when observing the total number of judges. It is peculiar to note, however, that although female judges take less than half positions in the first instance and supreme court, they are majority in the second instance with 56,3%

While in some courts, most notably the High Court and the Circuit Court, judges may be assigned to specific cases for a period, nonetheless, all judges can deal with all types of cases within their jurisdiction.

Distribution of court presidents by gender and by instance in Ireland




In this cycle, the total number of female court presidents (all instances) is 1, which represents 20,0% of the total number of court presidents.

In 2022, Ireland has 1 253 non-judge staff (of which 756 are Female). The total number of non-judge staff in comparison with the previous cycle reveals an increase of 9,4%.

In 2022, the number of non-judge staff per 100 000 inhabitants has increased (from 22,3 in 2021 to 24,3 in 2022).

During the same period, the number of judges per 100 000 inhabitants remained on the same level of 3,3 judges per 100 000 inhabitants.

Professional judges and non-judge staff per 100 000 inhabitants, and their ratio



Evolution of the ratio between professional judges and non-judge staff





In this cycle, the total number of Female prosecutors (all instances) is 88, which represents 64,2% of the total number of prosecutors.

As regards the distribution of the number of prosecutors among the different judicial instances, Ireland presents some peculiarities which should be mentioned. Allocation of prosecutors' work is not in all instances divided as per CEPEJ categories since the categories of first, second and third instance do not apply in the Irish system. The public prosecution has a number of grades for prosecutors which are different from the categories above, they include Prosecutor, Senior Prosecutor, Principal Prosecutor, Senior Principal Prosecutor, Assistant Director of Public Prosecutions, Deputy Chief Prosecutor. There is one Director of Public Prosecutions and one Deputy Director of Public Prosecutions.








The non-public prosecutors include specialists in the following areas: Human resources and organisational development, finance, ICT, facilities, media and communications, corporate governance, procurement, strategic management including risk management, Freedom of Information, quality assurance and internal audit. There is a Policy and Research Unit supported by knowledge management and research function and librarian. All legal sections are supported by a team of administrative staff who are considered to be generalist.

Public prosecutors and non-prosecutor staff per 100 000 inhabitants, and their ratio




In 2022, there are 14 177 lawyers, which is 5,5% more than in 2021. There are 7 167 female lawyers which is 51% of the total.

Ireland has 275,3 lawyers per 100 000 inhabitants, which is above the EU median of 132,1 lawyers per 100 000 inhabitants.

In the European Union, the absolute gross salary for a judge at the beginning of career ranges from a minimum of 26 931€ to a maximum of 140 244€.

According to 2022 data, the absolute gross salary of a judge at the beginning of his/her career in Ireland is 139 917€, which is more than double the EU median of 54 224€ (158% above).

Compared with the annual average salary in the country, the salary for a judge at the beginning of his/her career is 3,1 times higher (the EU median is 1,9).

At the highest level, the range of the EU absolute gross salary for a judge is from 53 144€ to 261 648€. Ireland's absolute gross salaries for judges at the highest level is 142% above the EU median of 106 533€.

For the public prosecutors, the range for the absolute gross salary at the beginning of career is from a minimum of 24 609€ to a maximum of 96 084€.

In 2022, the absolute gross salary of a public prosecutor at the beginning of his/her career in Ireland of 36 450€ is rather below the EU median of 48 728€ (-25% below).

The salary for a public prosecutors at the beginning of his/her career is slightly lower than the annual average salary in the country (the ratio is 0,8, while the EU median is 1,7).

At the highest level, the minimum absolute gross salary for prosecutors in the European Union is 44 880€ and the maximum is 194 005€.


Clearance Rate (CR) and Disposition Time (DT)

The Clearance Rate shows the capacity of a judicial system to deal with the incoming cases. A Clearance Rate of 100% and higher does not generate backlog.

The Disposition Time determines the estimated number of days necessary for a pending case to be solved in a court.

Regarding data for Ireland, historically the number of pending civil cases has not been recorded in caseload data, as many cases initiated before the Irish courts either settle out of court or are not proceeded with by the plaintiff/applicant without there being any procedural requirement that the parties inform the court of either a settlement or an intention not to proceed with the case. Consequently, number of resolved cases appears lower and number of pending cases is not available (NA). For this reason, CR shows lower values and DT cannot be calculated which imposes limitations on the efficiency analysis. The mentioned characteristics of the system have to be taken into account whenever analysing available data for Ireland (see sections below).

Due to the above reasons, no comprehensive analysis of overall efficiency could be provided.


The data on pending cases are available only for the third instance cases which allows analysis of efficiency indicators for the Supreme Court level. However, it should be noted that administrative law cases are included in the number of Civil (and commercial) litigious cases so no separate analysis could be provided for administrative law matters.

Looking at the clearance rate in the third instance, it could be concluded that this indicator was much above 100% threshold and EU median for civil and commercial cases but not for criminal law cases where Ireland recorded 84,8%. Similarly, Ireland has a disposition time below EU median value in third instance civil and commercial litigious cases, 142 compared to 216 days, whereas in third instance criminal cases disposition time was two times higher compared to EU median, 274 days compared to 126 days. These two indicators imply that Ireland achieves good efficiency results in dealing with civil and commercial cases at the highest instance, but faces challenges when it comes to criminal law cases.

First instance Civil (and commercial) litigious cases



As many of the cases are prosecuted by State Solicitors, Ireland couldn't collect any data on the status of a case between the time the direction is issued and the final outcome. This is relevant for matters on indictment. For summary cases outside of Dublin, there is rarely an information on the outcome as these directions are passed on to the police by the State Solicitor and the police execute the direction to prosecute without reference to the State Solicitor. This may change in the future if outcome data is exchange using the Criminal Justice Operational Hub. Summary cases outside of Dublin would make up a significant proportion of the files given in the figures above.

Cases are counted per prosecution file which could include more than one suspect and multiple charges preferred. Therefore, the figure given for 'Discontinued' in line 3.1 is the number of distinct files where a suspect was directed for 'no prosecution'. In some of these files, other suspects on the file may have been prosecuted in the courts.



Allocation of files happens in some divisions but not all, and not all prosecutors are assigned a specific number of files per week. Unit Heads assign a number of files to each Prosecutor depending on ability or grade. This might not mean that "targets" are set. The targets for the Office are ultimately greatly impacted by external factors like the amount of investigation files that are submitted to the office, the availability of court dates to process cases and the fact that the size and complexity of files varies.
