Other relevant information

In 2022 Aet Kukk was honored with the Order of the White Star Fifth Class from the president of Estonia for her work with human rights.

Additionally, in 2013 she received an honorary order from the Ministry of Foreign Affairs in Estonia for their cooperation over the years.

She has worked for a long time in the field of human rights in Estonia and in international cooperation projects abroad. In recent years, she has organised the commemoration days of deportees and boat refugees conducted in March, June and September on Liberty Square, in Tallinn.

She serves as a Member of the Council of the Estonian Institute of Historical Memory, and as a Council member of the MA Programme in International Law and Human Rights at the University of Tartu School of Law. She has previously worked in the private and public sectors in advertising and public relations.
