Dear Secretary-General,

I refer to our meeting in Geneva on 27 February during which we discussed the Council of Europe's contribution to the implementation of UN 2030 Agenda for Sustainable Development. I am pleased to enclose the latest version of our document, which takes into account developments within our Organisation (since the previous version which I addressed to your predecessor on 29 May 2015).

I also enclose a copy of my 2017 Report "State of democracy, human rights and the rule of law in Europe". This Report constitutes a very pertinent contribution to the Agenda 2030 process, as it demonstrates that States' performances in a number of sectors relating to human rights, democracy and the rule of law are "measurable". It identifies key parameters of positive performance which have an effective, meaningful, concrete and lasting effect on the compliance with relevant legal standards. Through these annual reports, we have introduced a method, a "yardstick", to evaluate developments, as well as our findings based on this method covering the member states of the Council of Europe.

The Council of Europe is an organisation founded on the universal values of human rights, democracy and the rule of law. Our contribution must therefore focus on these values. They are not only values in their own right, but important factors of sustainability for any societal model.

By definition, our philosophy is that most, if not all of the organisation's activities are relevant and contribute to the implementation of Agenda 2030. In this context, as of the next biennium (2018-2019), the Council of Europe's programme of activities and budget will indicate links, where relevant, to specific Sustainable Development Goals.
