In a time when society face new and complex challenges, the regions of Europe are becoming more and more important. Regions hold important keys to cooperation and problem solving for municipalities and individuals in evolving areas.

That is also at the core of my interests as President of the board for Sweden's largest hospital, Sahlgrenska University hospital where I have been a member of the board the last 10 years.

The Council of Europe safeguards respect for human rights, democracy and the rule of law. The regions of the member states have responsibilities and opportunities to be tools for a positive development for our societies. Seeking inclusion rather than exclusion, cooperation rather than division in a time when polarization is creating a political climate of conflict rather than cooperation. The Chamber of Regionshave a serious role to play in the developing situation in Europe.

I am experienced and motivated for the Presidency of the Chamber of Regions of the Congress of Local and Regional Authorities of the Council of Europe. My political background as member of the group of Socialists, Social Democrats, Greens and Progressives, will be the cornerstone of my aspiration.
