List of decisions adopted at the 35th meeting (24-27 March 2025)

The adopted agenda of the 35th meeting is set out in the Appendix.

1. Agenda Item 2: Adoption of the agenda and order of business

GREVIO adopted its draft agenda (see appendix) and draft order of business.

2. Agenda item 5: Adoption of the report of GREVIO's 34th meeting and matters arising

GREVIO adopted the draft report of its 34th meeting (document GREVIO(2024) RAP34-prov). The final meeting report appears as document GREVIO(2024)RAP34.

3. Agenda item 8: Approval of the preliminary draft thematic evaluation report on the Netherlands

GREVIO approved the preliminary draft thematic evaluation report subject to a number of modifications. In accordance with Article 68, paragraph 10 of the convention, the draft report will be transmitted to the national authorities for comments. In addition, and in accordance with its Rules of Procedure (Rule 43), GREVIO agreed to set a time-limit of two months to receive comments.

4. Agenda item 9: Approval of the preliminary draft thematic evaluation report on France

GREVIO approved the preliminary draft thematic evaluation report subject to a number of modifications. In accordance with Article 68, paragraph 10 of the convention, the draft report will be transmitted to the national authorities for comments. In accordance with GREVIO's Rules of Procedure (Rule 44 – Report and conclusions), the report will be transmitted to the national authorities, who will be invited to submit any final comments. The report and any comments received from the national authorities will be made public and sent to the Committee of the Parties.

7. Agenda item 12: Adoption of the final thematic evaluation report on Portugal

GREVIO adopted its final thematic evaluation report on Portugal as amended in the light of the comments received from the national authorities. In accordance with GREVIO's Rules of

Procedure (Rule 44 – Report and conclusions), the report will be transmitted to the national authorities, who will be invited to submit any final comments. The report and any comments received from the national authorities will be made public and sent to the Committee of the Parties.

8. Agenda item 17: Adoption of the 6th activity report

GREVIO approved its sixth general report of activities, covering the period from 1 January to 31 December 2024. The report will be published in the course of 2025.

9. Agenda item 19: Terms of reference for a working group on GREVIO's General Recommendation No 2.

GREVIO unanimously approved the terms of reference for a working group of its General Recommendation No. 2 on Preventing and combating Gender-related Killings of Women and Girls (GREVIO-GT-FEM). A working group was established consisting of the following GREVIO members: Pascale Franck, Olena Kharytonova, Pille Tsopp-Pagan, Grzegorz Wrona, and Angelina Zaporozjan-Pirgari. Laura Albu was appointed as substitute member.

10. Agenda item 22: Representation/participation of members of GREVIO and the Secretariat in events of interest to GREVIO

In response to an invitation received, GREVIO decided to designate Marie-Claude Hofner as member and Pille Tsopp-Pagan as substitute to represent GREVIO in the Council of Europe Drafting Committee on Human Rights and Drug Policies (DH-PDA), set up by decision of the Committee of Ministers at its 1519th meeting, held on 12 February 2025, to serve under the authority of the Steering Committee for Human Rights (CDDH).

Furthermore, GREVIO decided to designate Ellen O'Malley Dunlop and Pascale Franck (as substitute) to follow the work of the Council of Europe Committee of Experts on the prevention of violence (ENF-VAE), set up under the supervision of the Steering Committee for the Rights of the Child (CDENF).

11. Agenda item 27: Dates of the next meeting

GREVIO decided to hold its 36th meeting from 30 June to 3 July 2025, and its 37th meeting from 13 to 16 October 2025 in Strasbourg.
