1. Agenda Item 3: Adoption of the agenda and order of business

The term of office of the President and the first Vice-President starts on 30 June 2025, for two years.

The term of office of the second Vice-President starts on 30 June 2025, for one year.

GREVIO decided to hold its 37th meeting from 13 to 16 October 2025, its 38th meeting from 23 to 26 March 2026 and its 39th meeting from 29 June to 2 July 2026 in Strasbourg.
