12th meeting of the EPAS Governing Board (joint meeting with the EPAS Consultative Committee)

Monday 14 May (10.00-12.30) First part of the meeting (*in camera*)

1. Opening of the meeting

The meeting was opened by Mr Zoran Verovnik, Chair of the Governing Board. The full list of participants appears in Appendix I to this report.

2. Adoption of the agenda

The Governing Board adopted the agenda as it appears in Appendix II to this report.

3. Update on accession of new members to EPAS

The secretariat informed the Governing Board that no new concrete requests for membership had been received. Contacts with authorities from Spain, Turkey, Italy and Germany were being pursued: Spain has launched a national campaign based on the Start to Talk initiative, and so co-operation is currently at a high level with membership being discussed; Turkey's membership is now going through the final stages of the national parliamentary process for decision; there was good co-operation with Italy, but the changing political situation made it difficult to finalise the decision within the parliamentary procedure; Germany (previously reluctant to join) held high-level talks with the Deputy Secretary General following a recent exchange of views between the Committee of Ministers and the German Director for Sport, Ralf Goebel, and Germany will put the issue back on the table with an aim for membership in 2019.

The Chair appealed to all current member states to use any bilateral meetings they have with non-member states to encourage them to join (in particular with the large contributors, such as the UK, Germany and Italy, who would undoubtedly strengthen the work of EPAS).

Concerning membership of the Consultative Committee (CC), the Board took note of recent decision by the Committee of Ministers to accept the applications from EUSA (European University Sports Association) and ENSE (European Network of Sport Education).

The secretariat was in contact with GAISF (previously SportAccord), the European Athletics Federation and the European Handball Federation, who had all shown interest in joining the Consultative Committee. The secretariat would welcome suggestions from the Governing Board regarding other NGOs or federations from the sport movement (particularly those covering winter sports) who could be approached in this respect.

4. Statutory issues

4.1 Issues concerning membership of the Consultative Committee

a. Renewals of membership

The Governing Board took note of the requests for renewal by five organisations whose memberships will expire in 2018 (ENGSO, UEFA, TAFISA Europe, EGLSF and Peace and Sport); it also noted that two further organisations whose memberships were due to expire (FISU and Rugby Europe) had not submitted renewal requests this time.

<u>DECISION</u>: the Governing Board <u>approved</u> the membership renewals of five organisations: ENGSO, UEFA, TAFISA Europe, EGLSF and Peace and Sport.

4.2 Preparation of the next meeting of the Statutory Committee (September 2018)

The Governing Board took note of the presentation by the Secretariat (available on the restricted website), explaining the different financial procedures and types of accounts linked to EPAS funds, and how the budgets could be managed in case of new projects requiring immediate financing (see document EPAS(2018)29).

The Governing Board raised the issue of whether such a well-funded Special Account could in fact lead to member states questioning the size of their financial contributions (that they would contributing too much and the funds were not being spent). The secretariat reiterated that despite extensive use not being made of the Special Account to date, it was nevertheless a good fund to have in order to give an extra push to certain activities that the Governing Board considers important.

DECISION: the Governing Board:

- agreed to transfer up to €25K from the EPAS 2018 ordinary budget to the EPAS special account;
- <u>confirmed</u> that the amount on the Budget Head 2291 of the Special Account (€ 5 463.19) can be used by the Executive Secretary – upon prior consultation with the Chair of the Governing Board - to face urgent needs or to optimise the use of the EPAS liquidity;
- <u>confirmed</u> that the amounts on the Budget Head 9000 of the Special Account (€ 35 880.65), may be allocated to the Budget Head 2291 upon founded proposals by the Executive Secretary and upon decision by the EPAS Governing Board or its Bureau.

5. Elections

After clarifying that the process was in accordance with the Rules of Procedure, the Chair gave the floor to the representatives from Bulgaria and France, who were candidate or representing a candidate for election. The Governing Board proceeded with the election of candidates to the two vacant positions within its Bureau (region 1 and region 4).

<u>DECISION</u>: the Board <u>elected</u> Mrs Madeleine Delaperrière (France) and Mrs Viktoria Rancheva-Slavkova (Bulgaria) to the Bureau of the Governing Board until the end of the Bureau's current mandate (June 2019), thus confirming its composition as follows:

- Zoran Verovnik (Slovenia), Chair
- Alexey Morozov (Russian Federation), Vice-Chair
- Madeleine Delaperrière (France), Region 1
- Óskar Ármannsson (Iceland), Region 2
- Marija Crnković (Croatia), Region 3
- Viktoria Racheva-Slavkova (Bulgaria), Region 4
- Manana Kavtaradze (Georgia), Host state of next Conference of Ministers

6. Evaluation visits (recent and foreseen)

The Governing Board noted that the visits to Georgia and Norway had taken place on 28 February-1 March and 20-21 March 2018 respectively, and while waiting for the reports to be drafted, took note of the secretariat's presentation on what the main recommendations and outcomes were from these two visits.

The Governing Board also noted that the visit scheduled to Iceland would take place in the autumn of 2018 with the exact date still to be fixed.

For 2019, the secretariat added that more visits could be organised. Despite such visits not being particularly expensive budget-wise (both for EPAS and the host country), they are quite time-intensive in terms of human resources.

The experts from Norway and Georgia both confirmed the visits were a valuable and constructive experience, and that getting a third-party opinion on how to improve sport policies was an important step in strategy-related terms.

<u>DECISION</u>: the Governing Board <u>decided</u> that the secretariat should circulate a call to those states which had already expressed an interest in holding a visit in 2019 in order to fix possible dates, and then launch a general call for 2020.

7. Partnerships

i. Memorandums of Understanding (UEFA and FIFA)

The Governing Board took note of the background and update provided by the secretariat concerning the state of play of these MoUs with the Council of Europe, and in particular that the MoU with UEFA would be signed on 30 May in Strasbourg by Secretary General Jagland and President Čeferin. The date for the signing of the FIFA one was less certain.

The secretariat reiterated that the MoUs were political documents of the Council of Europe (and not just EPAS), and that they covered co-operation opportunities on wider issues other than diversity, governance and sport for all. The three CoE Sport Conventions were also covered as well as issues referring to co-operation policies on corruption (with GRECO) and anti-discrimination (with ECRI).

As it was a process completely run by the Committee of Ministers (and therefore consultation of member states via the GR-C and Ministers' Deputies), the MoUs had been restricted documents. However, as they had been adopted by the Committee of Ministers only on 9 May 2018, the secretariat was allowed to distribute paper copies to the Governing Board during the meeting.

ii. MESGO project

Given the unavailability of the representatives from the Centre for law and economy of sport, Limoges University, to attend the meeting, the Governing Board took note of the update on this MESGO project as given by the secretariat. The Governing Board discussed the content of the programme, the recognition of its diploma and the fact that it was centred towards potential students from public authorities (hence opening it up to EPAS member states).

The Governing Board also raised the question of how this university was chosen and how EPAS should react if another university was to make a similar approach offering reduced enrollment rates for a similar course. It considered it would be useful for the Bureau to prepare a strategy on how EPAS could handle such approaches, to avoid decisions being taken on an ad hoc basis.

The Chair stressed that the Limoges University had initiated the approach to EPAS (it was not "chosen") and that the Bureau had agreed to take up the opportunity as a pilot project. A period of assessment and evaluation of the course and its effectiveness will take place before signing any agreement on this MESGO project. He said that there was no budget impact on this trial partnership and that the Governing Board would be informed of any evaluation results before taking any decision.

<u>DECISION</u>: the Governing Board <u>took note</u> of the pilot projet with MESGO and <u>recommended</u> that the Bureau consider preparing a strategy on accepting such proposals in the future.

8. Reports and recent news

8.1 Oral update by Jens Sejer Andersen, Chair of the Consultative Committee, on the outcomes of its plenary meeting held earlier

The Governing Board took note of the oral update, which focused in particular on the outcome of the Consultative Committee's Bureau elections and discussions on the committee's Terms of Reference.

The committees took note of these reports without comment.

8.3 News from the Council of Europe

The committees took note of the oral update by the Secretariat on the latest developments within the Council of Europe, including the political and budgetary situations (e.g. Turkey and Russian Federation); the Secretariat members in charge of the three sport conventions gave updates on their respective activities. The Executive Secretary took the opportunity to introduce the committees to each member of the EPAS team present.

9. Conferences of Ministers responsible for Sport

9.1 Follow-up to the 14th Council of Europe Conference of Ministers responsible for Sport, Budapest, 29 November 2016

The committees took note of the updated actions on implementation of the resolutions from the Budapest conference and that the vast majority of activities were at a well-advanced stage, if not achieved.

9.2 15th Council of Europe Conference of Ministers responsible for Sport, Tbilisi, Georgia, 16 October 2018

- a) Programme of the 3 days of meetings (15, 16, 17 October)
- b) Draft Resolutions

The committees took note of the presentation made by the Secretariat on the structure of the three days' meetings in Tbilisi and on the content of the draft resolutions.

The Chair opened the floor for comments and questions, indicating that the process for comments in writing on the resolutions could continue until the end of May, and that further consultations could be launched, if necessary, until the end of August.

The Chair of the Consultative Committee asked if it would be possible to add an extraordinary meeting of the Consultative Committee into the schedule for the 15th October, providing a meeting room was available. The Secretariat agreed to clarify the logistical matters with the Georgian authorities and inform the Consultative Committee accordingly.

The representative from the Parliamentary Assembly noted with disappointment that the resolution did not consider the content of the texts and reports which the Assembly had adopted in January.

Several delegations noted that the resolution on corruption issues was very detailed in terms of IPACS but that the other issues were skimmed over in a more general way. The Secretariat took note and would address this imbalance in the next draft and sharpen up the texts according to the comments made.

The committees decided not to include a reference in the resolution to a possible convention on good governance.

No comments were made on the resolution on sport and human rights.

c) Preparation schedule

The Secretariat agreed to update the draft resolutions according to the comments made and that a written procedure would be opened for wider consultation to include those CoE states not member of EPAS.

The background documents did not require adoption by the Governing Board and therefore these would be approved by the Bureau before being published at the end of the summer.

d) Organisational aspects

The committees took note of the presentation made by the Georgian expert on the organisational and logistical issues of the conference.

9.3 Informal networking event (on the occasion of the FIFA World Cup, Moscow, 14 June 2018)

The Governing Board took note of the update by the Secretariat regarding the uncertainty around this event. Since the Russian authorities were still not in a position to invite ministers to attend the opening match, EPAS was unable to step in and invite them to a networking event. The Russian authorities were in contact with FIFA to secure tickets for the ministers, and were confident the event could go ahead.

The Governing Board noted that, should the event be confirmed, that the theme of the discussions would be centred around promoting ratifications of the Macolin Convention and its crucial entry into force.

10.2 Sport website

The committees took note of the update by the Secretariat regarding the state of play of the different ongoing publications, and the presentation of the new Sport website which was launched in October 2017.

11. Programme of activities: 2019

The committees took note of the presentation by the Secretariat on the proposed priorities within the 2019 draft Programme of Activities. Comments were welcomed and considered before the approval of the final version under item 12.5 of the agenda.

<u>Tuesday 15 May</u>: 9.00 - 16.00 Second part of the meeting (continued)

12. Programme of Activities: 2018-2019

(Calendar of activities 2018)

The Secretariat gave an update on the 2018 programme of activities at it appeared in document EPAS(2017)33rev1. No general points were raised by the Governing Board or the Consultative Committee.

12.1 PILLAR 1: ETHICAL SPORT

a) Tackling corruption / Promoting good governance

i. IPACS partnership

The committees took note of the information provided by the Secretariat on the set up of IPACS and the role of EPAS in its different bodies. The Secretariat addressed, in particular, the importance of inclusiveness and balanced representation in the work of IPACS and that organising a plenary meeting would allow for a wider group of stakeholders to be involved.

The PACE representative emphasised this importance of being inclusive and she recommended the inclusion of PACE in the work of IPACS. She also mentioned PACE's intention to set up an interparliamentary alliance against corruption in sport. Other delegations underlined the crucial aspect of inclusiveness, and recommended the national sport movement not be forgotten.

The Secretariat pointed out that the Council of Europe is a member of IPACS and that the PACE could be part of its delegation, as well as any other relevant bodies. It also said that the national sport movement was already represented in IPACS via the Association of National Olympic Committees. The Secretariat took note of the comments and would consult with other members of IPACS on organising a plenary meeting.

ii. Kazan Action Plan – European Contact Group

The committees took note of the information provided by the Secretariat on the implementation of the Kazan Action Plan and the role of the Council of Europe as coordinator of Working Group 3, which should draft guidelines on unifying and developing international standards in the field of sport integrity. The committees noted that the first meeting of the working group had taken place on 25 April and that 65 participants had taken part.

iii. Draft Recommendation of the Committee of Ministers

The Secretariat referred to document EPAS(2017)26rev1 and discussed the draft recommendation with the delegations. With some proposals from the Luxembourg

delegation, the Governing Board supported the proposed procedure for the final adoption by the Committee of Ministers.

<u>DECISION</u>: the Governing Board <u>approved</u> the next steps in the procedure (written consultation of non-member states, legal opinion of DLAPIL and submission to the Committee of Ministers).

iv. Reports by the Parliamentary Assembly

The committees held an exchange of views with Anne Brasseur following her presentation of the two latest sport-related reports by PACE. Mrs Brasseur appealed to the Governing Board members to support ratifications of the Macolin Convention.

The Governing Board and the Consultative Committee congratulated Mrs Brasseur on her report.

v. GRECO Summary Analysis of Selected Private Sector Bribery Cases

The committees took note of the short presentation by Gianluca Esposito, Executive Secretary of GRECO, on the above-mentioned summary analysis, in which he highlighted the difficulties related to the sport sector (e.g. that the notion of breach of duty is hard to prove) and that the legislation differs from country to country.

vi. Sports Governance Observer II

The committees took note of the short presentation by Jens Sejer Anderson (Play the Game) who briefly explained the objectives of the follow-up project SGO II, which was inspiring national sports organisations to raise the quality of their governance practices.

vii. Database on alleged cases of corruption in sport (DACCS)

The committees took note of the update provided by the Secretariat, which was currently developing the software to be able to better identify and catalogue corruption cases in sport by extracting relevant information from DACCS and transferring it to an Excel database.

b) Sport and Human Rights

i. Mega Sporting Events Platform for Human Rights (<u>MSE platform</u>) and its development into a Centre for Sport and Human Rights

The committees took note of the short presentation by Guido Battaglia, Institute for Human Rights and Business, regarding the strategy plan being developed.

The Governing Board was in favour of being updated on a regular basis on the developments of this Centre, given that human rights is a cross-cutting theme within the Council of Europe. It also agreed that other departments within the Council, in addition to EPAS, should be involved.

12.2 PILLAR 2: INCLUSIVE SPORT

a) Promoting diversity and fighting against discrimination

i. Priority theme for 2019:

The committees took note of the impact assessment papers provided on the two topics and the discussions which took place showed that the Governing Board was predominantly in favour of option 1 on gender equality and the #metoo campaign.

b) Combating hate speech in sport

i. Workshop in Sarajevo, 21-22 November 2017

The Secretariat gave an oral report of the successful workshop in which experts from public authorities and sports organisations from the Western Balkan region participated, and who expressed an interest in similar follow-up events.

The committees congratulated EPAS and the host country Bosnia and Herzegovina on the organisation of this important event.

c) Migrants and their integration through sport

i. Interactive platform

The Secretariat presented the interactive platform which had been created as a follow-up measure to the EPAS annual conference of 2016 in Vienna on sport and migrants. The platform now collected some 40 projects from across Europe aimed at migrant inclusion in European societies via sport.

The committees noted that the Secretariat hoped to hold an event in 2018 to which all the project managers would be invited, so that they could share information and experience, as well as exchange good practices in this area.

d) Gender equality in sport

i. New EU/CoE joint project: "ALL IN – towards gender balance in sport" (1 March 2018 – 31 October 2019)

The committees took note of the presentation by Clotilde Talleu, ALL IN Project Manager, on the aims and content of this new joint project.

12.3 PILLAR 3: SAFE SPORT

a) Martial Arts and Combat Activities

i. Draft Recommendation of the Committee of Ministers

The committees took note of the explanations by the Secretariat on the revisions made to the text, following the previous discussions in Eindhoven.

The expert from Luxembourg had doubts as to the clarity of the title with reference to the word "extreme" and pointed out a discrepancy in this respect between the English and French texts. He also felt there was a lack of coherence in the links with organised crime and the launching of a study on this.

<u>DECISION</u>: the Governing Board <u>approved</u> the next steps in the procedure (written consultation of non-member states, legal opinion of DLAPIL and submission to the Committee of Ministers), once bilateral consultations would be held between Luxembourg and the Secretariat, and a consensus reached to find the correct phrasing.

b) Inclusion of children and their protection in sport

i. Follow-up to PSS+ project and presentation of the "Start to talk" initiative

The Committees took note of the presentation by Elda Moreno, Head of the Children's Rights and Sport Values Department, on the Start to Talk initiative, in which she outlined its aims to develop tools that any stakeholder could use.

She said that given the positive reaction to the video, the Secretariat was rather overwhelmed with requests of interest, and therefore a call for voluntary contributions was being launched to help finance the initiative.

Delegations showed readiness to co-operate, including UEFA which is committed to this particular topic, and PACE which intended to organize a side event on Start to Talk for its parliamentary members.

<u>DECISION</u>: the Governing Board <u>asked</u> the Secretariat to send out all the details by Circular Letter on how states can get involved.

12.4 ACTIVITIES COVERING ALL THREE PILLARS

a) Sport for All

i. <u>European Sports Charter</u> and its potential revision

The Chair of the Governing Board reminded delegations that the European Sports Charter was the basis for the organisation of Evaluation Visits and the recommendations made thereafter. He said that a call had been made to renew it, improve it, or event completely renovate it into a convention.

The Chair of the Consultative Committee introduced the reasons why the Consultative Committee felt the Charter needs revamping – it is outdated and, for example, does not cover the more contemporary issues that today's digital age has raised, nor does it cover sports facilities, urban planning, criminal practices or integrity. He suggested starting an inclusive process, perhaps aligning to other reference documents such as the Sustainable Development Goals, Kazan Action Plan, EU White paper, etc.

Most delegations agreed a change was required, but that it should not be done in haste. An assessment or a feasibility study would first be needed before any decision was taken.

<u>DECISION</u>: the Governing Board <u>asked</u> the Secretariat to make a reference to a possible feasibility study in one of the draft resolutions for adoption at the Ministerial Conference, and recommended that the Bureau continue to discuss this and follow developments with regard to possible scope and schedule.

ii. UEFA GROW SROI Project: measuring the social return on investment from football mass participation

The committees took note of the presentation by Liam McGroarty, Business Development Manager at UEFA, and held an exchange of views with him on this subject.

12.5 PRIORITIES FOR THE 2019 PROGRAMME OF ACTIVITIES

Programme of activities: 2019

<u>DECISION</u>: the Governing Board <u>adopted</u> the list of activities and draft budget for 2019, as presented under item 11 of the agenda.

The Governing Board <u>delegated</u> responsibility to its Bureau for any decisions concerning follow-up, implementation and update of this programme of activities.

13. Any other business

None.

14. Date and place of the next meeting

<u>DECISION</u>: the Governing Board <u>asked</u> the Secretariat to find an appropriate date for the next joint meeting in June 2019, and to subsequently send a "save the date" message to all delegations as soon as possible.
