Agenda item 1. Opening of the meeting and adoption of the agenda

The Committee adopted the draft agenda as it appears in document IC-CP(2023)OJ14 prov rev.

Agenda item 4. Election of ten members of GREVIO

The Committee declared the following candidates for GREVIO membership elected:

In accordance with paragraph 2 of Article 66 of the Istanbul Convention and Rule 14 of the Committee of Ministers' Resolution CM/Res(2014)43, the Committee decided that the mandate of these ten members of GREVIO shall start on the 1st of June 2023, for a duration of four years, renewable once.

Agenda item 7. Supervising the implementation of recommendations issued by the Committee of the Parties

On the basis of the framework for supervising the implementation of recommendations addressed to states parties, as set out in document IC-CP(2021)2 prov, the Committee adopted conclusions on the implementation of recommendations in respect of Finland, France, Italy, the Netherlands, and Serbia. The conclusions are set out in documents IC-CP/Inf(2023)7, IC-CP/Inf(2023)8, IC-CP/Inf(2023)9, IC-CP/Inf(2023)10, and IC-CP/Inf(2023)11.

Agenda item 8. Exchange of views on the Rules of Procedure of the Committee of the Parties regarding the implications of the forthcoming ratification of the Istanbul Convention by the EU

The Committee instructed the Secretariat to prepare an information document on the consequences of the EU accession to the Istanbul Convention and to circulate it together with a proposal to amend the Rules of Procedure of the Committee of the Parties. The Committee also instructed the Secretariat to rapidly propose an informal information and consultation procedure on this topic.

Agenda item 9. Date of next meeting

The Committee decided to hold its next meeting on 5 December 2023.

Agenda item 10. Other business

Taking into account the difficulties encountered during the procedure to elect GREVIO members, the Committee instructed the Secretariat to prepare a proposal for a possible review of the Rules of Procedure of the Committee of the Parties regarding the election procedure of GREVIO members, and of the Committee of Minister Resolution CM/Res(2014)43.
