¹ Any member who has not submitted an annual declaration of interests for the relevant year shall not be entitled to apply for, be granted, or to continue to hold, any specific office within the Assembly including President or Vice-President of the Assembly, chairperson or vice-chairperson of a committee, sub-committee, network, platform or alliance, rapporteur (including general rapporteur, youth rapporteur or co-rapporteurs), member of an ad-hoc committee for the observation of elections, member of an ad hoc committee of the Bureau, or a role representing the Assembly or a committee. In case of the late submission of a declaration, this prohibition shall cease two months after the submission of that member's declaration for that year. (§19, Code of conduct for members of the Parliamentary Assembly, Annex II, Rules of Procedure).

If intervening in a debate, a member who has not submitted an annual declaration of interests for the relevant year must start their intervention with an oral declaration of interests. (§20, Code of conduct for members of the Parliamentary Assembly, Annex II, Rules of Procedure).

Tout membre qui n'a pas soumis de déclaration d'intérêts annuelle pour l'année concernée ne peut prétendre à se voir accorder ou continuer à exercer une fonction spécifique au sein de l'Assemblée, y compris celles de Président ou de Vice-Président de l'Assemblée, de président ou de vice-président d'une commission, d'une sous-commission, d'un réseau, d'une plateforme ou d'une alliance, de rapporteur (y compris de rapporteur général, de rapporteur pour la jeunesse ou de co-rapporteur), de membre d'une commission ad hoc pour l'observation des élections, de membre d'une commission ad hoc du Bureau, ou de représentant de l'Assemblée ou d'une commission. En cas de soumission tardive d'une déclaration, cette interdiction prend fin deux mois après la soumission de la déclaration de ce membre. (§19, code de conduite des membres de l'Assemblée parlementaire, Annexe II, Règlement).

S'il intervient dans un débat, un membre qui n'a pas soumis de déclaration d'intérêts annuelle pour l'année concernée doit commencer son intervention par une déclaration d'intérêts orale. (§20, code de conduite des membres de l'Assemblée parlementaire, Annexe II, Règlement).
