








Incoming cases per 100 inhabitants

1. Judicial organisation in Luxembourg (2021 data)

In Luxembourg in 2021, the number of courts considered as legal entities is 13. Namely, there are 7 courts of general jurisdiction and 6 specialised courts.


The 7 legal entities of general jurisdiction encompass 5 first instance courts, namely 3 Justices of the peace and 2 District courts, one Appellate court and one Cassation Court. It is noteworthy that the Court of appeal and the Court of cassation are both part of the Supreme Court of Justice.

Among the 6 specialised courts, 3 act at first instance and 3 are higher instance courts (see below for more details).

In terms of geographic locations, there are 8 courts among which 3 are of first instance.




Evolution of number of first instance courts



The distribution between first instance general jurisdiction courts and first instance specialised courts is 62,5% - 37,5% which is somewhat different from the distribution tendency in EU: 72,8% - 27,2%.


In Luxembourg, courts of general jurisdiction are organized into specialized sections. For example, the commercial courts (which also deal with insolvency cases) are specialized sections of the district court. Only the administrative, military and social security courts of first instance are autonomous. In administrative matters, there is no cassation possibility against the decisions of the administrative court of appeal.






According to 2021 data, the total number of professional judges sitting in courts (all instances) in Luxembourg is 230, which is 0,4% more than in previous cycle.

More precisely, in Luxembourg, there are 35,64 professional judges per 100 000 inhabitants (this figure is above the EU median of 24,11 judges per 100 000 inhabitants) and about 1,04 non-judge staff per judge.


There has been a significant increase compared with previous cycle when this ratio was at 0,97 non-judge staff per judge.

In this cycle, the total number of Female professional judges (all instances) is 166, which represents 72,2% of the total number of judges.

The total number of judges is distributed among the different judicial instances in the following way: 174 are sitting in first instance courts (of which 130 are Female); 51 are sitting in second instance courts (of which 33 are Female) and 5 are sitting in Supreme Court (of which 3 are Female).

Compared with the EU distribution of professional judges per instance, a similar trend is observed in Luxembourg, with very closed values for first and second instance judges, while third instance judges are less numerous in Luxembourg.

As regards the distribution of the number of judges among the different judicial instances, Luxembourg presents some peculiarities which should be mentioned. Indeed, the number of first instance professional judges includes judges of the district courts, judges of the peace and judges of the administrative tribunal. The number of second instance professional judges includes judges of the Court of appeal of the Superior court of justice and judges of the Administrative court. The number of professional judges at the Supreme court level includes only judges of the Court of cassation.

As regards the distribution Male/Female, it has to be pointed out that female judges have a large majority at all instances.





In 2021, Luxembourg has 239 non-judge staff (of which 152 are Female). The total number of non-judge staff in comparison with the previous cycle reveals an increase of 7,2%.

In 2021, the number of non-judge staff per 100 000 inhabitants has increased (from 35,1 in 2020 to 37,0 in 2021).

During the same period, the number of judges per 100 000 inhabitants evolved from 36,1 judges per 100 000 inhabitants in 2020 to 35,6 in 2021.

In this cycle, the non-judge staff is broken down as follows:

- 224 non-judge staff whose task is to assist the judges such as registrars (of which 144 are Female);
- 3 staff in charge of different administrative tasks and of the court management (of which 1 are Female);
- 3 technical staff (of which 0 are Female);
- ∘ 9 other (of which 7 are Female);

It is noteworthy that in Luxembourg, all non-judge staff is in charge of assisting judges (except at the administrative courts). Therefore, starting from 2017, the distinction between staff in charge of administrative tasks and staff assisting judges is no more carried out. Only at the administrative courts there are few persons not assisting judges.

The category "other non-judge staff" refers to the "référendaires" and the data protection compliance officer of the administrative courts.

The number of "other non-judge staff" has increased with 5 persons, representing 5 posts of "référendaires". Judicial and administrative courts are making greater use of "référendaires" to relieve judges of certain tasks.


Professional judges and non-judge staff per 100 000 inhabitants, and their ratio


Evolution of the ratio between professional judges and non-judge staff





In this cycle, the total number of Female prosecutors (all instances) is 30, which represents 47,6% of the total number of prosecutors.


The total number of prosecutors is distributed among the different judicial instances in the following way: 48 in first instance (of which 21 are Female) and 15 in final instance (of which 9 are Female).

As regards the distribution of the number of prosecutors among the different judicial instances, Luxembourg presents some peculiarities which should be mentioned. Namely, the figure with regard to public prosecutors at the Supreme court level includes both second instance and Supreme Court prosecutors, as they are grouped together in the Superior Court of Justice, which is subdivided into the Court of Appeal and the Court of Cassation.

As regards the distribution Male/Female, it has to be specified that female prosecutors have the majority at high instances which is not the case at first instance.

Ratio between non-prosecutor staff and public prosecutors




In 2021, there are 3 247 lawyers, which is 5,4% more than in 2020.

The 2021 data cannot be broken down by gender. Indeed, the Diekirch Bar did not provide details on the breakdown of the number of lawyers by gender. Among lawyers registered at the Luxembourg Bar, who represent 98% of the lawyers registered at the two Luxembourg Bars, 52% were male and 48% were female in 2021.

Luxembourg has 503,1 lawyers per 100 000 inhabitants, which is above the EU median of 122,4 lawyers per 100 000 inhabitants.

According to 2021 data, the absolute gross salary of a judge at the beginning of his/her career in Luxembourg of 92 591€ is more than 50% above when compared to the EU median of 52 534€. However, as a ratio with the annual average salary of the country, the salary of a judge at the beginning of his/her career is 1,37 which is below the EU median of 1,91.

As a starting salary (professional judge of first instance or prosecutor) the salary of the "attachés de justice" after their first appointment has been communicated. The salary scale judges provides for 380 index points as a basis, a possible professional experience can be added to it but is not taken into account in the calculations.

As a theoretical basic salary of a judge or prosecutor at the Court of Appeal the grade M4, level 4 is taken into consideration, which corresponds to 455 points and to the average seniority of a magistrate appointed to the Court (Court and General Prosecutor's Office). However, it should be taken into account that this salary is strongly influenced by the family situation of the person concerned.

To calculate the annual salary, these points must be multiplied by the value of the index point. Between January and September 2021, the value of the index point for a civil servant was 20.17893; after 1 October, the value of the index point was 20.6831871. Taking into consideration these elements, a 12-month salary corresponds to 92 591€ for a first instance professional judge, respectively a salary of 110 865€ for a judge or prosecutor at the Supreme Court. These figures do not include any bonuses, allowances or benefits that may be added to the basic salary depending on the magistrate concerned. 

The amended Law of 10 August 1991 on the profession of lawyer (Art. 37 and 37-1) and, more specifically, the amended Regulation of the Grand-Duché of 18 September 1995 on legal aid (Art. 8) include "fees and costs of bailiffs" among the amounts that may be covered by legal aid.

The Diekirch Bar did not provide details on the legal matter of the cases that were granted with legal aid. Among the cases that received legal aid at the Luxembourg Bar, which corresponds to 85% of the total number of cases granted with legal aid, 27% were criminal cases and 73% were other than criminal cases.

According to the Luxembourg Bar Association the average response time to an application for legal aid (LA) is impossible to determine. Indeed, the majority of the applications for legal aid received are incomplete and will have to be returned before a final decision can be taken. The date of this decision depends on how quickly the applicant responds. The Bar association does not have statistics on this point. The processing time of an application for legal aid by the Legal Aid Department of the Luxembourg Bar is on average +/- 1 month, i.e. after receipt of an application for legal aid until a decision is taken, which can be either an approval or a refusal or a return in case of an incomplete application. However, it should be noted that urgent requests are treated as a priority by the service.

The Clearance Rate shows the capacity of a judicial system to deal with the incoming cases. A Clearance Rate of 100% and higher does not generate backlog.


The Disposition Time determines the estimated number of days necessary for a pending case to be solved in a court.

At the outset, it should be recalled that in Luxembourg data on criminal law cases are partial. Namely, the Clearance Rate indicator cannot be calculated at first instance, while the Disposition Time can be calculated only at the level of the Supreme court and its value for 2021 is quite above the EU median.


In 2021, in Luxembourg, civil litigious cases appear longer than administrative cases. However, analyses by instance show that the highest Disposition Time in Luxembourg in 2021 is calculated for first instance administrative cases, despite the slight increase of the Clearance Rate which remained below the 100% threshold.

Conversely, in civil matters, first instance courts prove to be the most efficient instance with a Clearance Rate close to the 100% threshold and a Disposition Time below the EU median and constituting the lowest value for Luxembourg among all matters and all instances. As to second instance civil cases, the court of appeal encountered some difficulties in 2021, the Clearance Rate having dropped below the 100% threshold (a decrease of 7 percentage points). If the increase of the Disposition Time was slight, its value is considerably above the EU median. As to third instance civil litigious cases, the Disposition Time indicator is still higher than the EU median, but is should be highlighted that it decreased by 15% between 2020 and 2021, while the Clearance rate of the Supreme court knows a positive upward trend since 2017, having considerably exceeded the 100% threshold in 2021.



















The Clearance Rate and the Disposition Time indicators of first instance total criminal law cases cannot be calculated.

The unavailability of the number of pending and incoming criminal cases is explained by the specific organisation of the workflow between courts and prosecution offices. Cases are only transferred to the courts shortly before the hearing and, if a case is not heard on the given date, it is physically returned to the prosecution until the new hearing date. Thus, there are - with a few exceptions - no cases pending before the criminal courts over a long period of time, and the number of incoming cases is more or less equal to the number of resolved cases.

Minor criminal cases represent all cases resolved by criminal order in the Police court and the district court. Severe criminal cases represent all cases resolved by a judgment at first instance in the Police, Correctional or Criminal court. "Other criminal cases" are cases that are dealt with by the investigating office.





In respect of the category "Discontinued for other reasons", it should be mentioned that these are essentially two specific measures: firstly, in the area of traffic, the obligation to follow a driving course and, only for young offenders of full age, participation in a course in the Choice 18+ program for the prevention of drug addiction (https://www.solina.lu/fr/facilities/impuls/). Due to the continuing pandemic in 2021, no "Choice18+" measures could be initiated, nor processed, during this year. Similarly, driving courses were suspended due to the pandemic and did not resume until October 2021.

The increase in the number of cases concluded by a penalty or a measure imposed or negotiated by the public prosecutor between 2020 and 2021 cannot be explained by a single event. The increase is mainly due to the growing number of warnings issued by the prosecution service, which is on the one hand the result of punctual measures related to the health crisis and on the other hand depends on the subject matter of the cases dealt with, as warnings are usually issued in less serious cases.


