




# Gross salaries of judges and prosecutors vs average annual salary in 2022





## 1. Judicial organisation in Luxembourg (2022 data)

In Luxembourg in 2022, the number of courts considered as legal entities is 13. Namely, there are 7 courts of general jurisdiction and 6 specialised courts.


The 7 legal entities of general jurisdiction encompass 5 first instance courts, namely 3 Justices of the peace and 2 District courts, one Appellate court and one Cassation Court. It is noteworthy that the Court of appeal and the Court of cassation are both part of the Supreme Court of Justice.

Among the 6 specialised courts, 3 act at first instance and 3 are higher instance courts.

In terms of geographic locations, there are 8 courts among which 3 are of first instance.







According to 2022 data, the total number of professional judges sitting in courts (all instances) in Luxembourg is 232, which is 0,9% more than in previous cycle.

More precisely, in Luxembourg, there are 35,1 professional judges per 100 000 inhabitants (this figure is above the EU median of 22,9 judges per 100 000 inhabitants)

In this cycle, the total number of female professional judges (all instances) is 167, which represents 72,0% of the total number of judges.

The total number of judges is distributed among the different judicial instances in the following way: 173 are sitting in the first instance courts (of which 130 are female); 54 are sitting in the second instance courts (of which 35 are female) and 5 are sitting at the Supreme Court (of which 2 are female).

1st instance

Compared with the EU distribution of professional judges per instance, a similar trend is observed in Luxembourg, with very close values for first and second instance judges, while third instance judges are less numerous in Luxembourg.

As regards the distribution of the number of judges among the different judicial instances, Luxembourg presents some peculiarities which should be mentioned. Namely, the number of first instance professional judges includes judges of the district courts, judges of the peace and judges of the administrative tribunal. The number of second instance professional judges includes judges of the Court of appeal of the Superior court of justice and judges of the Administrative court. The number of professional judges at the Supreme court level includes only judges of the Court of cassation.

As regards the distribution male/Female, it has to be specified female judges have a large majority at first and second instances.





Distribution of court presidents by gender and by instance in Luxembourg




In this cycle, the total number of female court presidents (all instances) is 4, which represents 44,4% of the total number of court presidents.

The total number of court presidents is distributed among the different judicial instances in the following way: 6 are sitting in first instance courts (of which 4 are female); 2 are sitting in second instance courts (none of which is female) and 1 are sitting in Supreme Court (none of which is female).

Relatively speaking, the ratio of presidents in the first instance courts changed significantly since the 2020-2022 assessment. This variation is attributed to changes observed within the six first instance courts. In first instance, the number of male presidents has decreased from 3 to 2 (-33%), while the number of female presidents has increased from 3 to 4 (+33%).

In 2022, Luxembourg has 248 non-judge staff (of which 158 are Female). The total number of non-judge staff in comparison with the previous cycle reveals an increase of 3,8%.

In 2022, the number of non-judge staff per 100 000 inhabitants has increased (from 37,0 in 2021 to 37,5 in 2022).

During the same period, the number of judges per 100 000 inhabitants evolved from 35,6 judges per 100 000 inhabitants in 2021 to 35,1 in 2022.




In this cycle, the non-judge staff is broken down as follows:

- 230 non-judge staff whose task is to assist the judges such as registrars (of which 148 are Female);
- $\circ$  3 staff in charge of different administrative tasks and of the court management (of which 1 are Female);
- 4 technical staff (none of which is Female);
- 11 other (of which 9 are Female);

The "Other non-judge staff" comprises the legal clerks and a data protection compliance officer from the administrative courts.

## Ratio between professional judges and non-judge staff






In Luxembourg, there are 35,1 professional judges per 100 000 inhabitants (this figure is above the EU median of 22,9 judges per 100 000 inhabitants) and about 1,1 non-judge staff per judge.





In this cycle, the total number of female prosecutors (all instances) is 34, which represents 52,3% of the total number of prosecutors.

The total number of prosecutors is distributed among the different judicial instances in the following way: 48 in first instance (of which 22 are female) and 17 in final instance (of which 12 are female).

As regards the distribution of the number of prosecutors among the different judicial instances, Luxembourg presents some peculiarities which should be mentioned. Namely, the figure with regard to public prosecutors at the Supreme court level includes both second instance and Supreme Court prosecutors, as they are grouped together in the Superior Court of Justice, which is subdivided into the Court of Appeal and the Court of Cassation.


As regards the distribution male/Female, it has to be specified that female prosecutors have the majority at the highest instance, but not in first instance.

Distribution of Heads of prosecution services by gender and by instance in Luxembourg





### Ratio between non-prosecutor staff and public prosecutors


Public prosecutors and non-prosecutor staff per 100 000 inhabitants, and their ratio






In 2022, in Luxembourg, the ratio between non-prosecutor staff and prosecutors of 2,9 was more than 50% above the EU median of 0,9.


In 2022, there are 3 255 lawyers, which is 0,2% more than in 2021.


There are 1 581 female lawyers which is 49% of the total.

Luxembourg has 492,6 lawyers per 100 000 inhabitants, which is significantly above the EU median of 132,1 lawyers per 100 000 inhabitants.

The number of individual lawyers, amounting to 3202, includes those individual lawyers who represent legal entities. The number of law firms, totalling 207, encompasses the registered law firms listed in the Bar Association's registry. Presently, the Diekirch Bar has 53 individual lawyers and 4 law firms (4 from list V and 1 from list VI) represented by individual lawyers. Therefore, in 2022, there was a total of 3255 individual lawyers including those representing the 211 legal entities.

## Salaries of professional judges and prosecutors at beginning of a career and at the highest instance





In the European Union, the absolute gross salary for a judge at the beginning of career ranges from a minimum of 26 931€ to a maximum of 140 244€.

According to 2022 data, the absolute gross salary of a judge at the beginning of his/her career in Luxembourg is 96 084€, which is significantly above the EU median of 54 224€ (77% above).

Compared with the annual average salary in the country, the salary for a judge at the beginning of his/her career is 1,4 times higher (the EU median is 1,9).

At the highest level, the range of the EU absolute gross salary for a judge is from 53 144€ to 261 648€. Luxembourg's absolute gross salaries for judges at the highest level is 59% above the EU median of 106 533€.

For the public prosecutors, the range for the absolute gross salary at the beginning of career is from a minimum of 24 609€ to a maximum of 96 084€.

In 2022, the absolute gross salary of a public prosecutor at the beginning of his/her career in Luxembourg of 96 084€ is significantly above the EU median of 48 728€. Luxembourg is the country with the maximum absolute gross salary in the EU.

Compared with the annual average salary in the country, the salary for a public prosecutors at the beginning of his/her career is 1,4 times higher (the EU median is 1,7).

At the highest level, the minimum absolute gross salary for prosecutors in the European Union is 44 880€ and the maximum is 194 005€. Luxembourg's absolute gross salaries for prosecutors at the highest level is 95% above the EU median of 87 247€.

As an initial career salary (professional judge of first instance or prosecutor), the salary of the "attachés de justice" after their first appointment has been communicated. The judges' salary scale provides for 380 index points as a basis, a possible professional experience can be added to it but is not taken into account in the calculations.

As the theoretical basic salary for a judge or prosecutor at the Court of Appeal, the grade M4, level 4 is taken into consideration, which corresponds to 455 points and the average seniority of a magistrate appointed to the Court (Court and General Prosecutor's Office). However, it should be noted that this salary is heavily influenced by the family situation of the person concerned. To calculate annual salary, these points must be multiplied by the value of one index point. Between January and March 2022, the value of one index point for a civil servant was 20.6831871; after 1 April 2022, its value increased to 21.2002547. Taking these elements into consideration, an annual salary corresponds to €96,084 for a first instance professional judge, respectively a salary of €115048€ for judges or prosecutors at the Supreme Court.

These figures do not include any potential bonuses allowances or benefits that may be added to the basic salary depending on the magistrate concerned.

According to comments provided by Luxembourg, the Law of 1 September 1988 on the civil liability of the State and public collectivities allows the State to be held civilly liable before the ordinary courts if a litigant believes that he or she has been the victim of a dysfunction of the judicial bodies. Excessive length of proceedings or a condemnation resulting from such a dysfunction could be grounds for such a claim. Such complaints are lodged with the courts of first instance. However, complaints concerning excessive length of proceedings may also be brought before the European Court of Human Rights (violation of article 6 of the ConvEDH) or result in a procedural sanction during the proceedings. However, these latter approaches do not appear in the systems of Luxembourg. Thus, the diversity of the actors involved makes it difficult to identify claims and compensation decisions for the various categories, and prevents from providing figures that reflect reality. The figures available for compensation for wrongful arrest represent claims and decisions awarding compensation for inoperative review detentions (IRD), as well as the total amount paid out. It should be pointed out, however, that under the Law of December 30 1981, the right term is "administrative decisions" and not "condemnations".


Clearance Rate (CR) and Disposition Time (DT)

The Clearance Rate shows the capacity of a judicial system to deal with the incoming cases. A Clearance Rate of 100% and higher does not generate backlog.

The Disposition Time determines the estimated number of days necessary for a pending case to be solved in a court.

At the outset, it should be recalled that in Luxembourg data on criminal law cases are partial. Namely, the Clearance Rate indicator cannot be calculated at first instance, while the Disposition Time can be calculated only at the level of the Supreme court.

At first instance, the Clearance rate indicator is closer to the 100% threshold for civil litigious cases (98,3%), however for administrative law cases it appears lower (91,6%). The Disposition Time is below the EU median for civil cases, but well above the EU median for administrative law cases.


In the second instance, courts seem to be more efficient in civil litigious and administrative law cases as the Clearance Rate is above the 100% threshold (104,2% and 103,0% respectively). However, the Clearance rate is 87,4% in criminal law cases, which might imply certain challenges in processing these cases. The Disposition Time is significantly higher than the EU median for civil litigious cases, but slightly lower for administrative law cases.

For the third instance, courts seem to be able to efficiently deal with cases, both in civil litigious cases (Clearance rate of 135,5%) and in criminal law cases (Clearance rate of 112,8%). The Disposition Time equals to the EU median for civil litigious cases, while being higher for criminal law cases.









The Clearance Rate and the Disposition Time indicators of first instance total criminal law cases cannot be calculated.

The unavailability of the number of pending and incoming criminal cases is explained by the specific organisation of the workflow between courts and prosecution offices. Cases are only transferred to the courts shortly before the hearing and, if a case is not heard on the given date, it is physically returned to the prosecution until the new hearing date. Thus, there are - with a few exceptions - no cases pending before the criminal courts over a long period of time, and the number of incoming cases is more or less equal to the number of resolved cases.

Minor criminal cases represent all cases resolved by criminal order in the Police court and the district court. Severe criminal cases represent all cases resolved by a judgment at first instance in the Police, Correctional or Criminal court. "Other criminal cases" are cases that are dealt with by the investigating office.

## Public prosecution implemented budget

The budget of public prosecution services cannot be distinguished from the budget of courts.





In case of non-compliance, public prosecution resumes.





In 2022, there are 270 accredited or registered mediators who practise court related mediation which represents 40,9 accredited or registered mediators per 100 000 inhabitants.

The variation of the number of mediators between 2021 and 2022 is about 10,2%.

The figures provided represent the total number of accredited mediators as of 31 December of the reference year (in civil, commercial and criminal matters) without taking into account mediators who have ceased their activity.

While no detailed analysis has been conducted on this matter, the use of mediation has emerged in recent years as a preferable alternative for resolving minor cases, such as disputes between neighbours. The increase observed since 2020 in the number of criminal cases where parties agree to initiate mediation could be attributed to positive experiences with the mediation centre, particularly with a view to avoiding such matters being referred to already burdened courts, notably following the health crisis.
