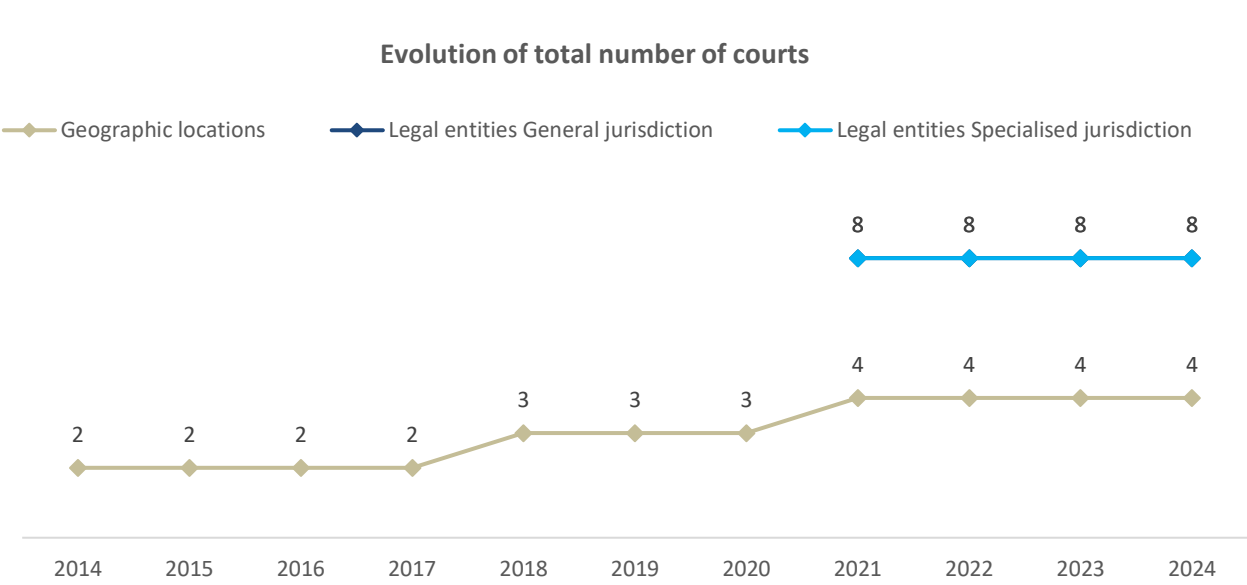
1. Judicial organisation in Malta (2024 data)

The Maltese judicial system consists of 16 courts in total, divided into first and second instances. The 4 first-instance courts of general jurisdiction include the Court of Magistrates (Civil and Criminal Jurisdiction), the Criminal Court, and the Civil Court, First Hall. Additionally, there are 7 specialised first-instance boards and tribunals, such as the Rent Regulation Board, Land Arbitration Board, Rural Leases Control Board, Small Claims Tribunal, Court of Voluntary Jurisdiction, Administrative Review Tribunal, and the Juvenile Court. The Constitutional Court serves as a specialised second instance court.

The system operates with two levels of jurisdiction, with the second instance being the highest. There are 4 second instance courts of general jurisdiction.

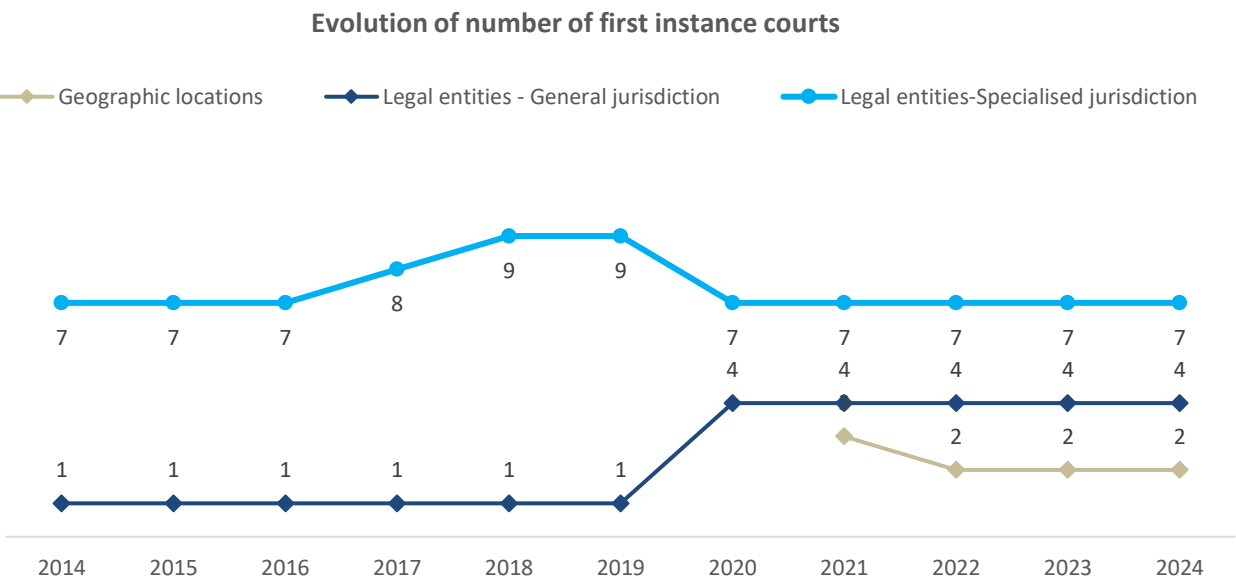

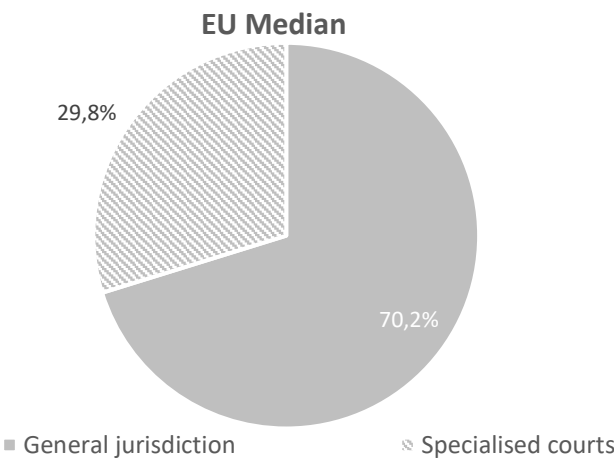
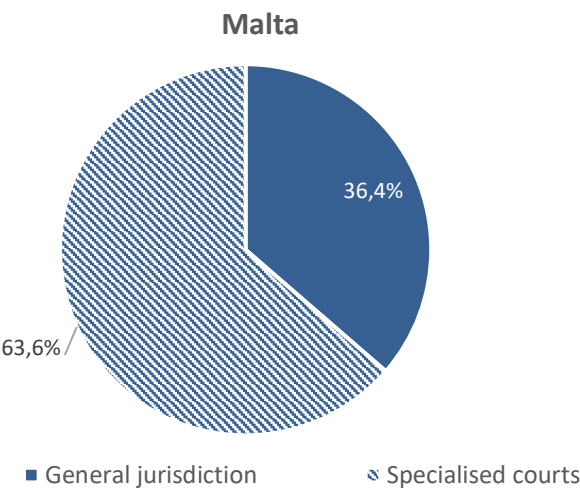

The distribution between first instance general jurisdiction courts and first instance specialised courts in Malta is 36,4% - 63,6% (distribution tendency in EU: 70,2% - 29,8%).

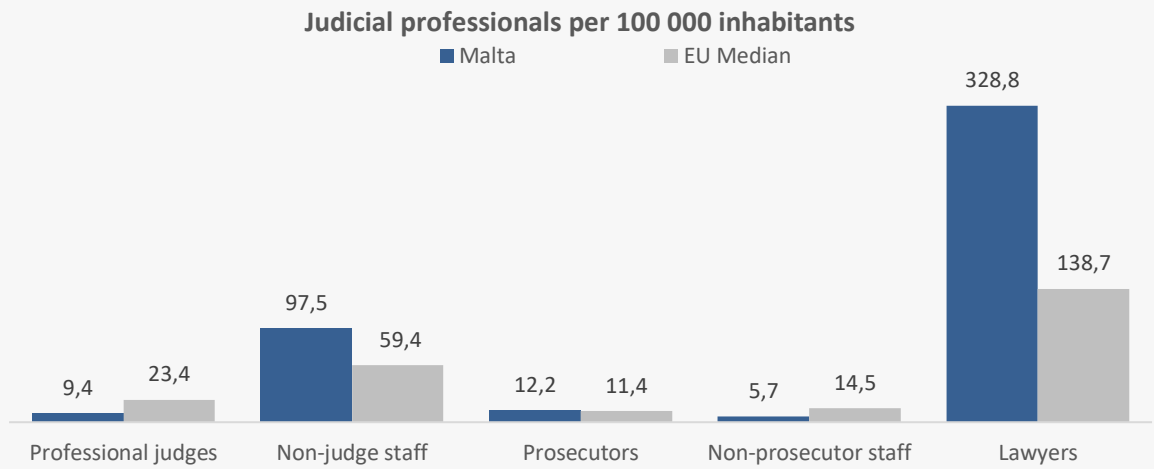

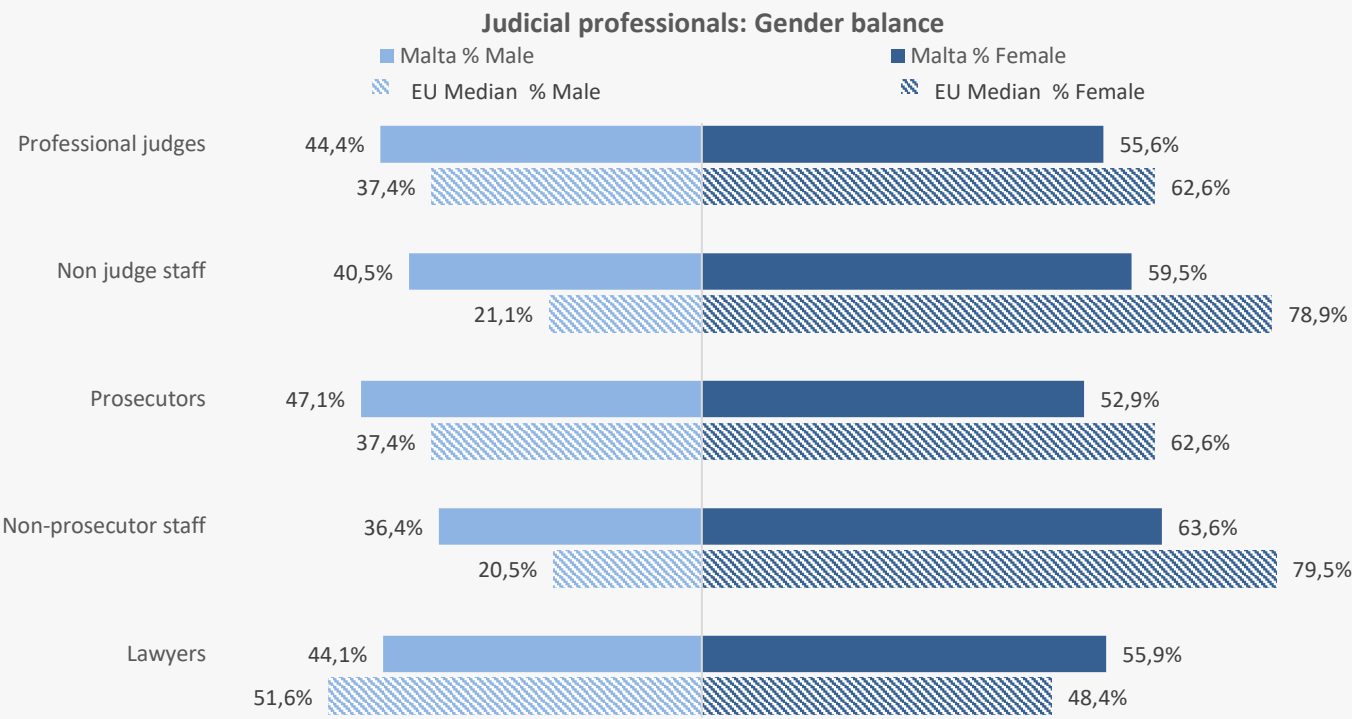

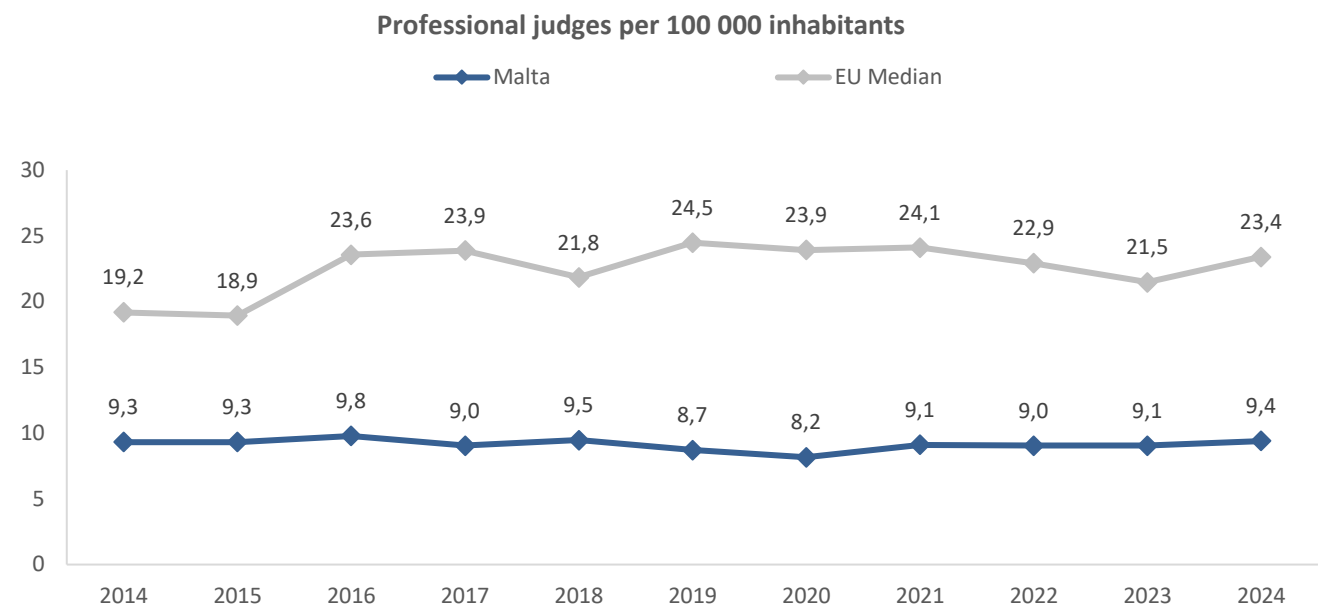

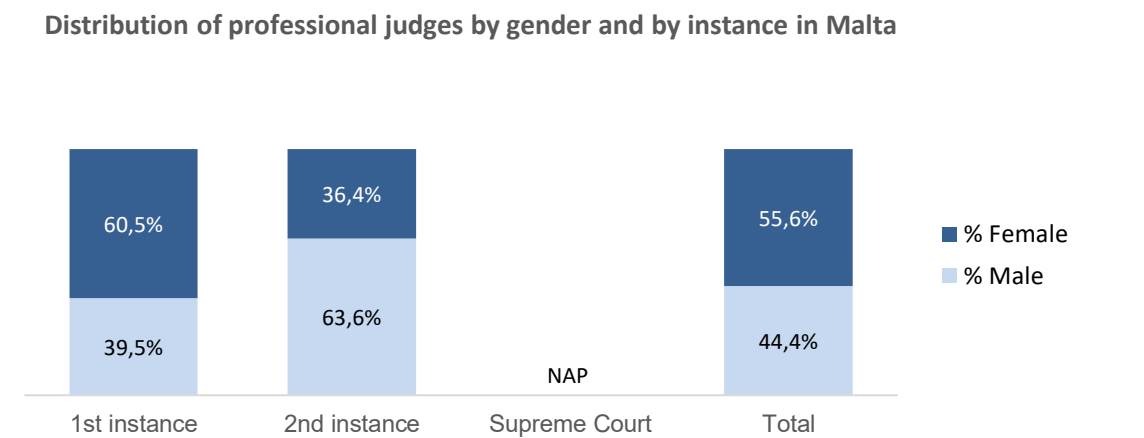
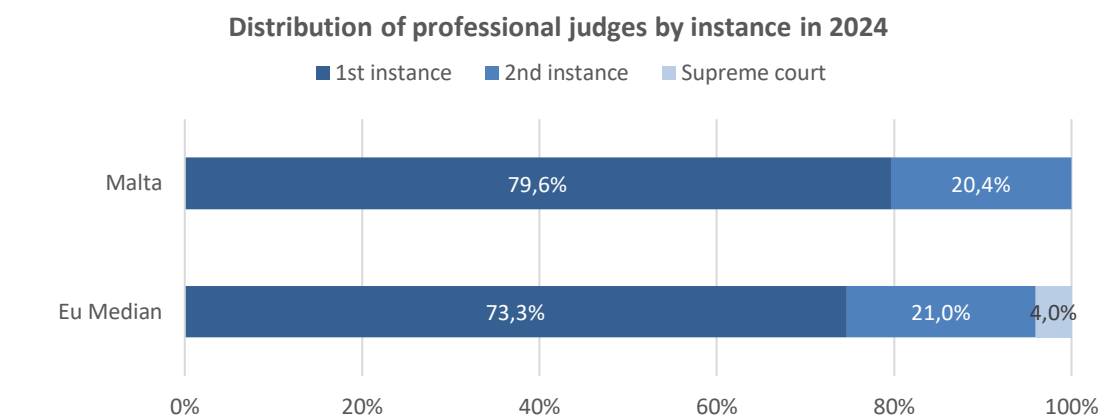


According to the 2024 data, the total number of professional judges sitting in courts (all instances) in Malta is 54, which is 5,9% more than in previous cycle (taking into account the small numerical values).

More precisely, in Malta, there are 9,4 professional judges per 100 000 inhabitants (this figure is below the EU median of 23,4 judges per 100 000 inhabitants).

In this cycle, the total number of female professional judges (all instances) is 30, which represents 55,6% of the total number of judges.

The total number of judges is distributed among the different judicial instances in the following way: 43 are sitting in the first instance courts (of whom 26 are female) and 11 are sitting in the second instance courts (of whom 4 are female). In Malta there is no Supreme Court, the Court of Appeal being the Court of second instance.

Compared with the EU distribution of professional judges per instance the trend in Malta is similar. The number of judges at first instance is predominant, while judges at second instance are less numerous.

As regards the methodology of presentation of data in respect of the number of judges, it should be noted that The number of first Instance judges also includes magistrates that preside over first Instance Courts.

As regards the distribution male/Female, it has to be specified that although females judges represent 60,5% of professional judges at first instance, their percentage is lower at second instance with 36,4%. In the total of professional judges 55,6% are female.

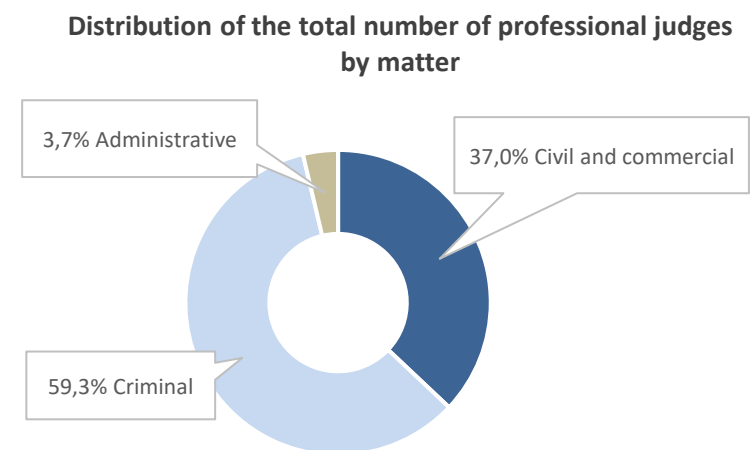

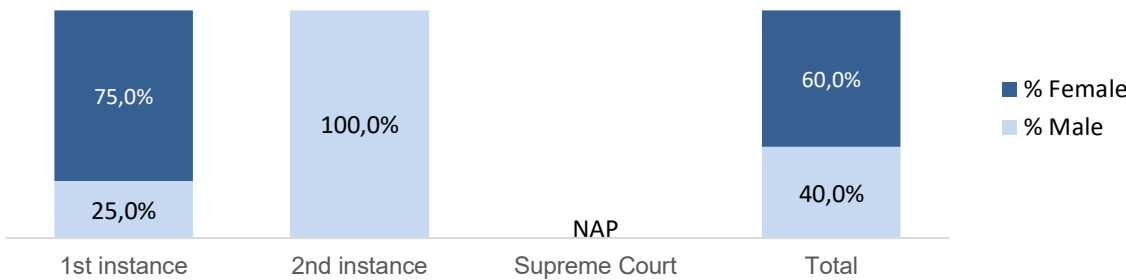

Distribution of court presidents by gender and by instance in Malta



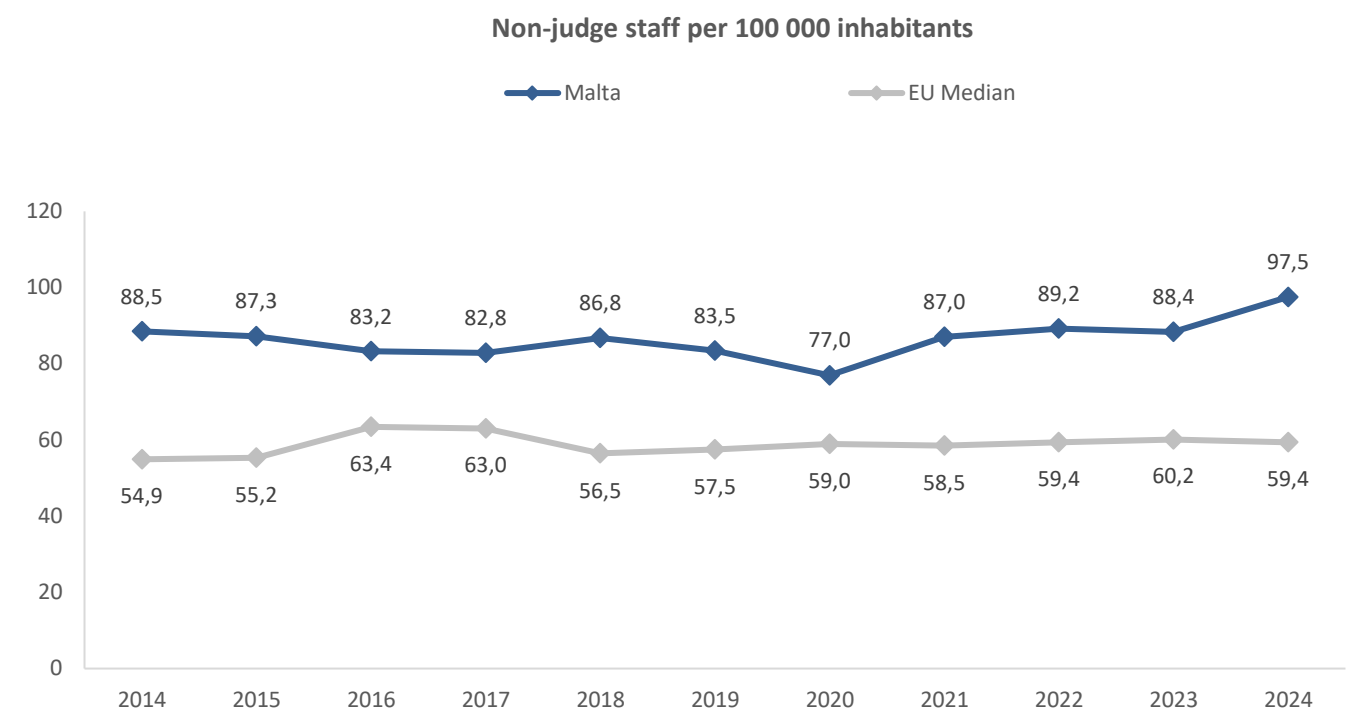
In this cycle, the total number of female court presidents (all instances) is 3, which represents 60,0% of the total number of court presidents.

The total number of court presidents is distributed among the different judicial instances in the following way: 4 are sitting in first instance courts (no female) and 1 male is sitting in second instance courts.

The Constitutional Court, then, is presided over by the 3 judges who compose the Court of second instance also known as the Court of Appeal in its Superior Jurisdiction.

In 2024, Malta has 560 non-judge staff (of whom 333 are Female). The total number of non-judge staff in comparison with the previous cycle reveals an increase of 12,4%.

In 2024, the number of non-judge staff per 100 000 inhabitants has increased (from 88,4 in 2023 to 97,5 in 2024).

During the same period, the number of judges per 100 000 inhabitants evolved from 9,1 judges per 100 000 inhabitants in 2023 to 9,4 in 2024.

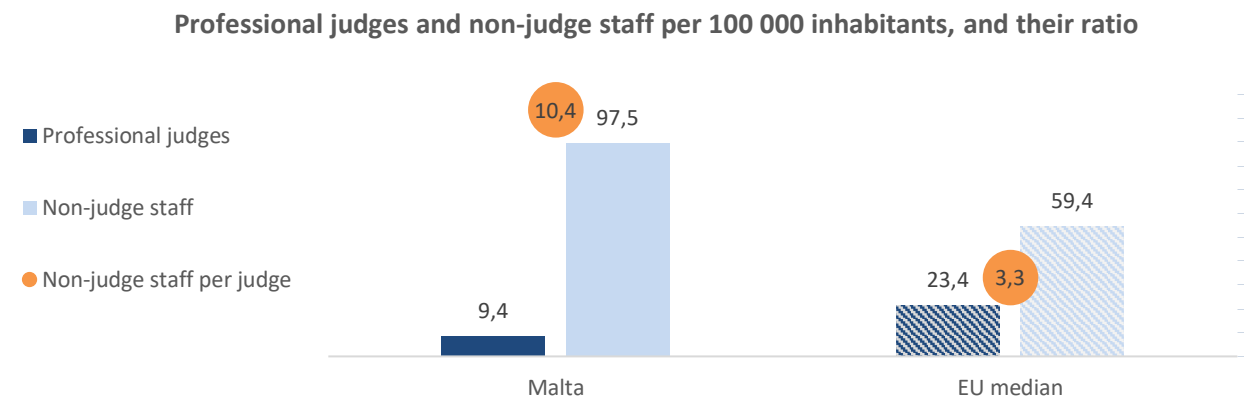

- 361 non-judge staff whose task is to assist the judges such as registrars (of whom 259 are Female);
- 55 staff in charge of different administrative tasks and of the court management (of whom 32 are Female);
- 14 technical staff (of whom 4 are Female);
- 130 other (of whom 38 are Female);

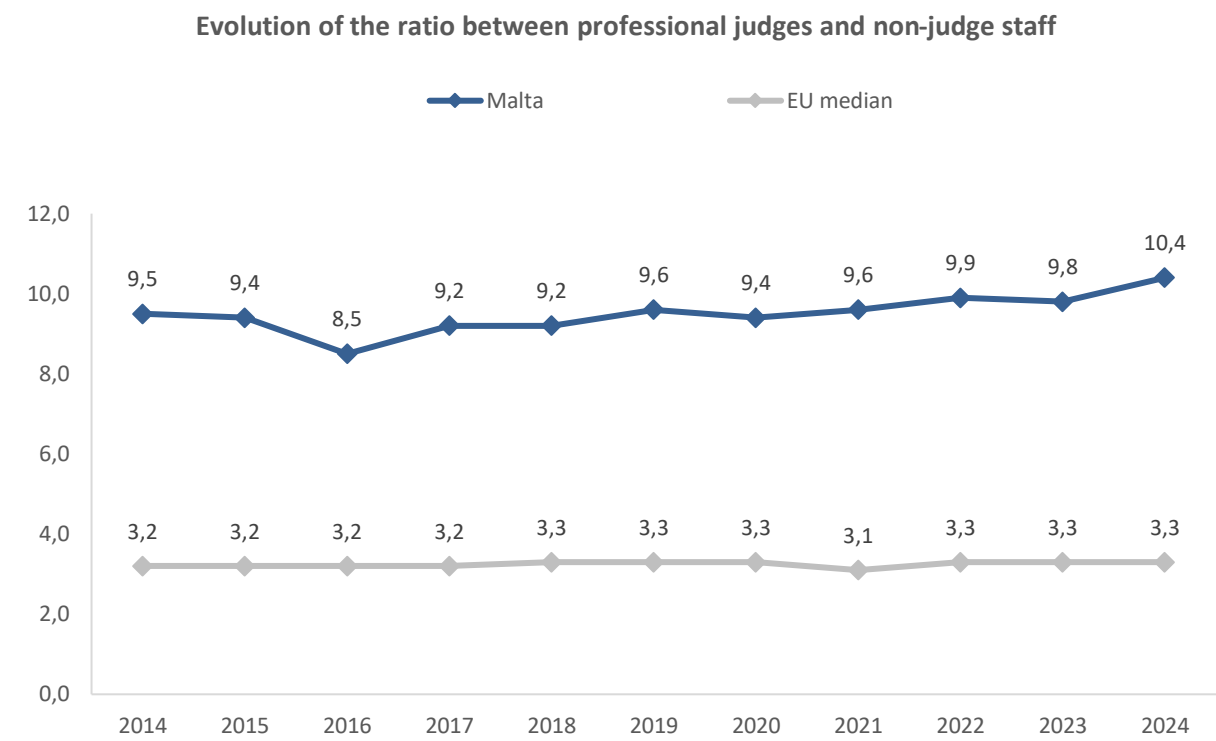


In Malta, there are 9,4 professional judges per 100 000 inhabitants (this figure is below the EU median of 23,4 judges per 100 000 inhabitants) and about 10,4 non-judge staff per judge.

There has been a significant increase compared with the previous cycle when this ratio was at 9,8 non-judge staff per judge.

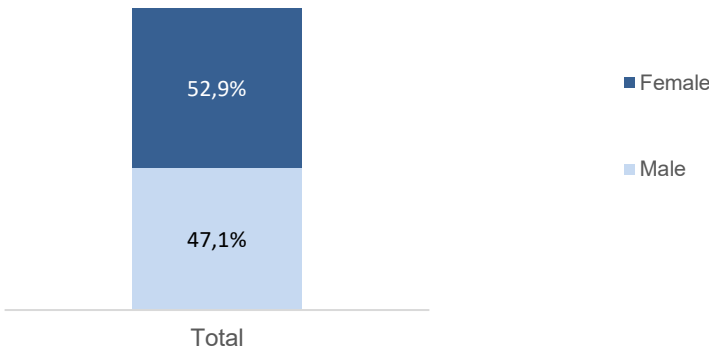

In this cycle, the total number of Female prosecutors (all instances) is 37, which represents 52,9% of the total number of prosecutors.

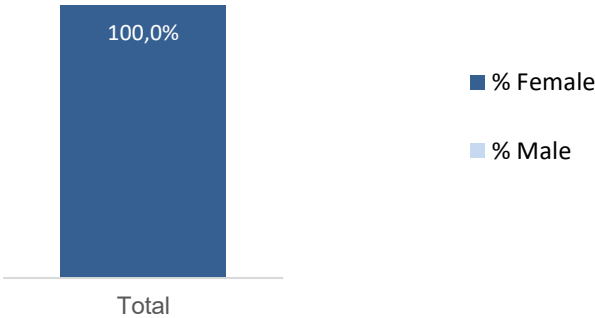

Distribution of Heads of prosecution services by gender in Malta

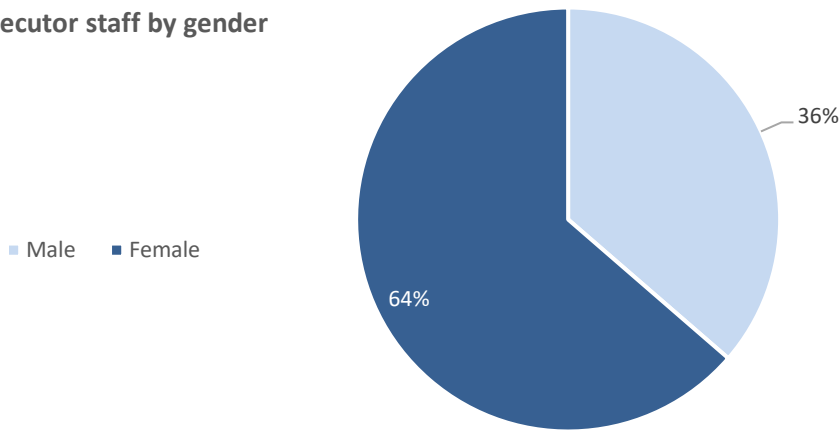

Non-prosecutor staff by gender

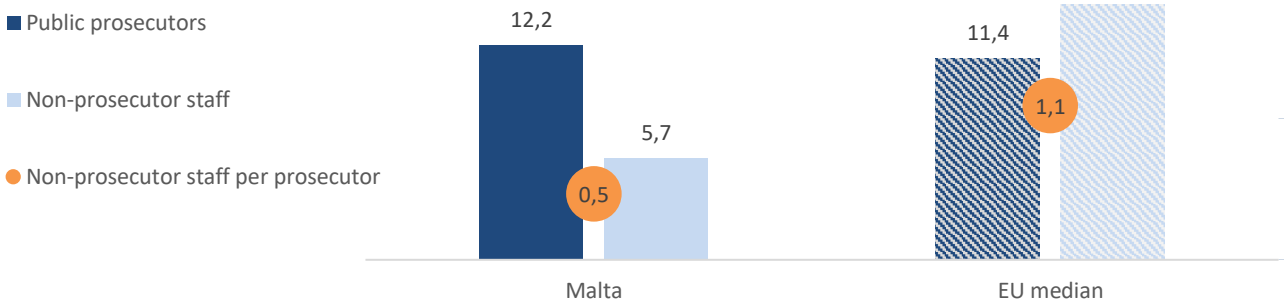

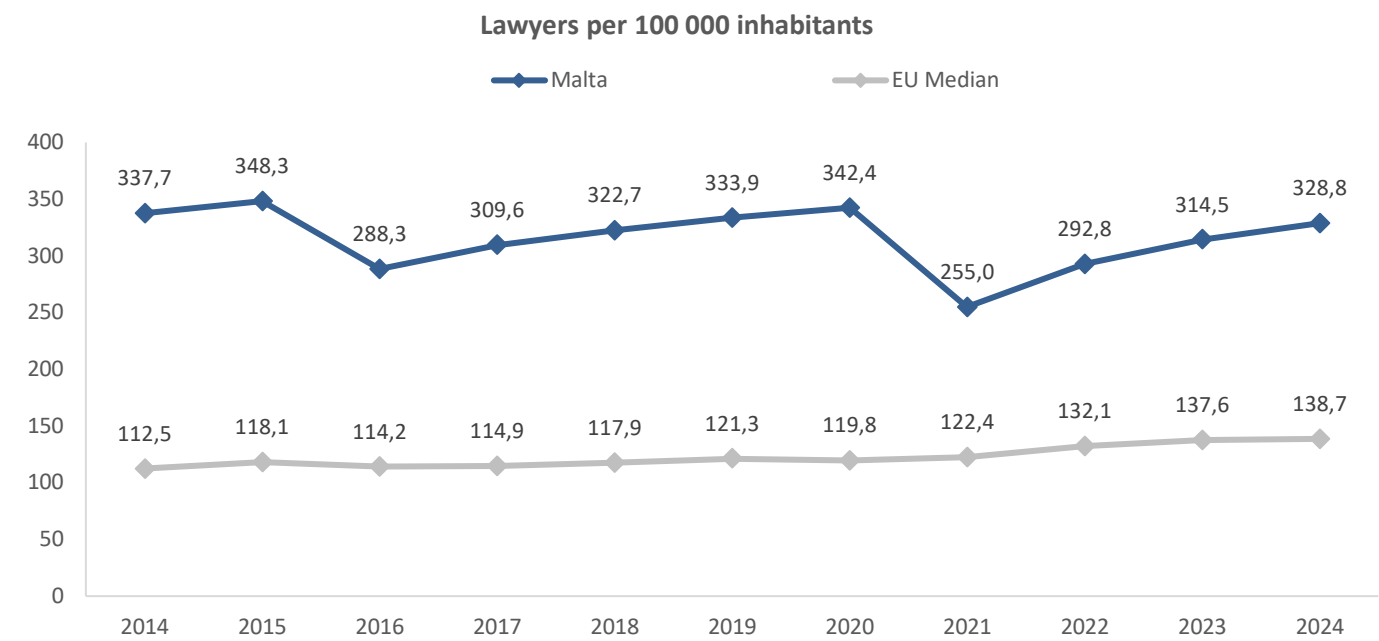
Public prosecutors and non-prosecutor staff per 100 000 inhabitants, and their ratio

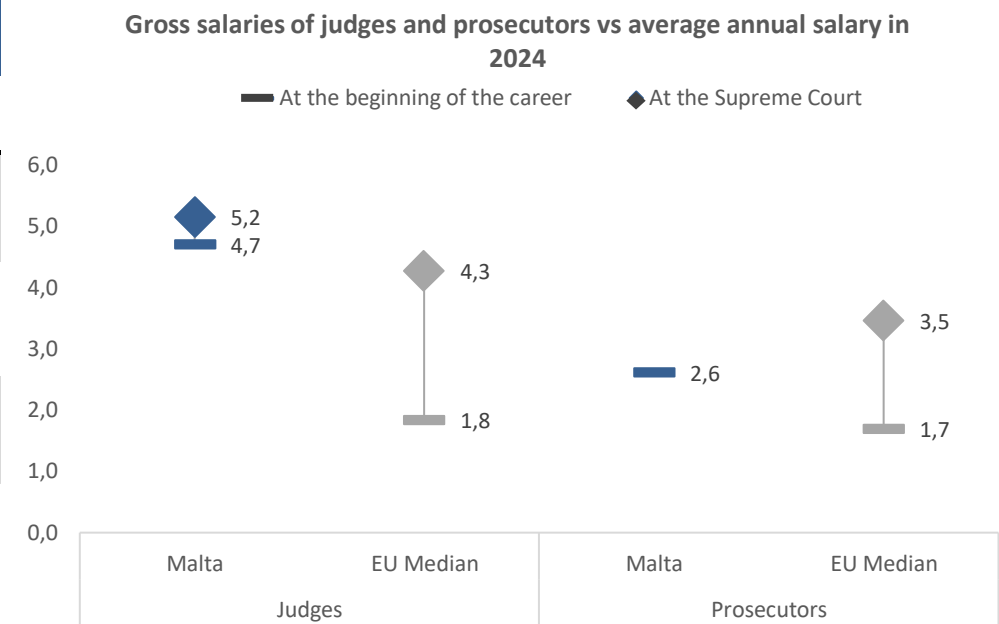

In the European Union, the absolute gross salary for a judge at the beginning of career ranges from a minimum of 24 043€ to a maximum of 153 676€.

According to the 2024 data, the absolute gross salary of a judge at the beginning of his/her career in Malta is 111 099€, which is significantly above the EU median of 61 347€ (81% above).

Compared with the annual average salary in the country, the salary of a judge at the beginning of his/her career is 4,7 times higher (the EU median is 1,8).

At the highest level, the range of the EU absolute gross salary of a judge is from 54 719€ to 298 911€. Malta is the country that is at the median level of the absolute gross salaries for judges at the highest level (121 591€).

For public prosecutors, the range for the absolute gross salary at the beginning of career is from a minimum of 24 043€ to a maximum of 106 135€.

In 2024, the absolute gross salary of a public prosecutor at the beginning of his/her career in Malta of 61 754€ is rather above the EU median of 52 969€ (17% above).

Compared with the annual average salary in the country, the salary of a public prosecutor at the beginning of his/her career is 2,6 times higher (the EU median is 1,7).

At the highest level, the minimum absolute gross salary for public prosecutors in the European Union is 51 013€ and the maximum is 254 088€. The EU median is 93 759€.

Under article 3 of the 7th protocol of the European Convention on Human Rights individuals have the right to compensation in cases of wrongful conviction. Similarly, Article 5(5) of the Convention, as incorporated into Maltese law through Chapter 319, establishes the right to compensation for unlawful detention. However, there is currently no available data on the application or implementation of these rights within Malta.

Anyone who has experienced an injustice can seek redress in the Courts of Justice. The Laws of Malta provide for compensation in cases of wrongful conviction and unlawful detention (Chapter 319 of the Laws of Malta), while S.L. 9.12 of the Criminal Code establishes a compensation system for victims of crime. However, data on these cases is not currently available.

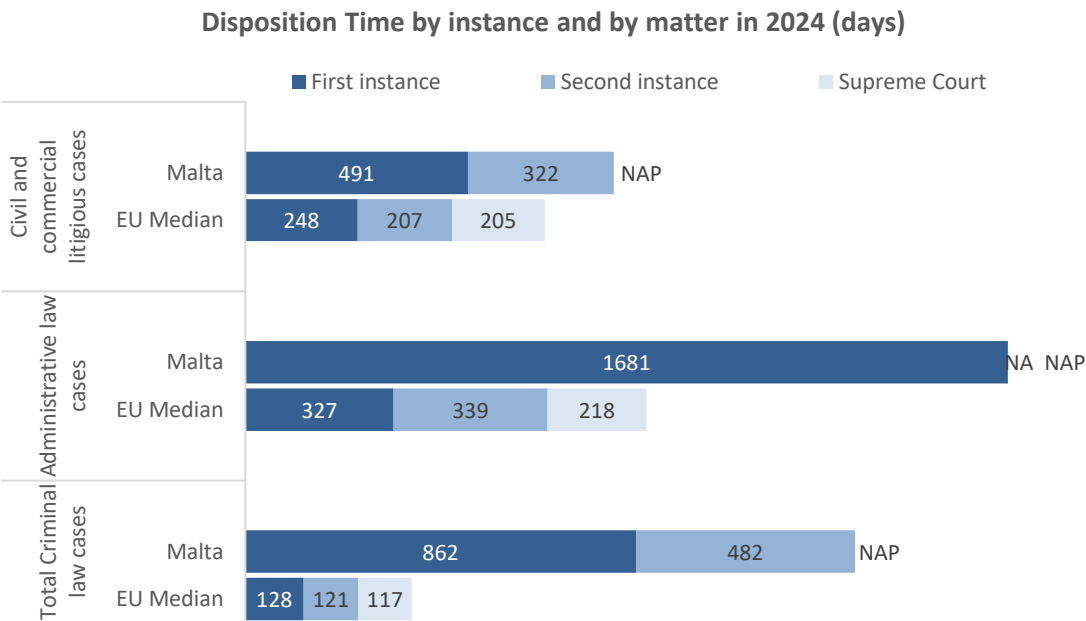
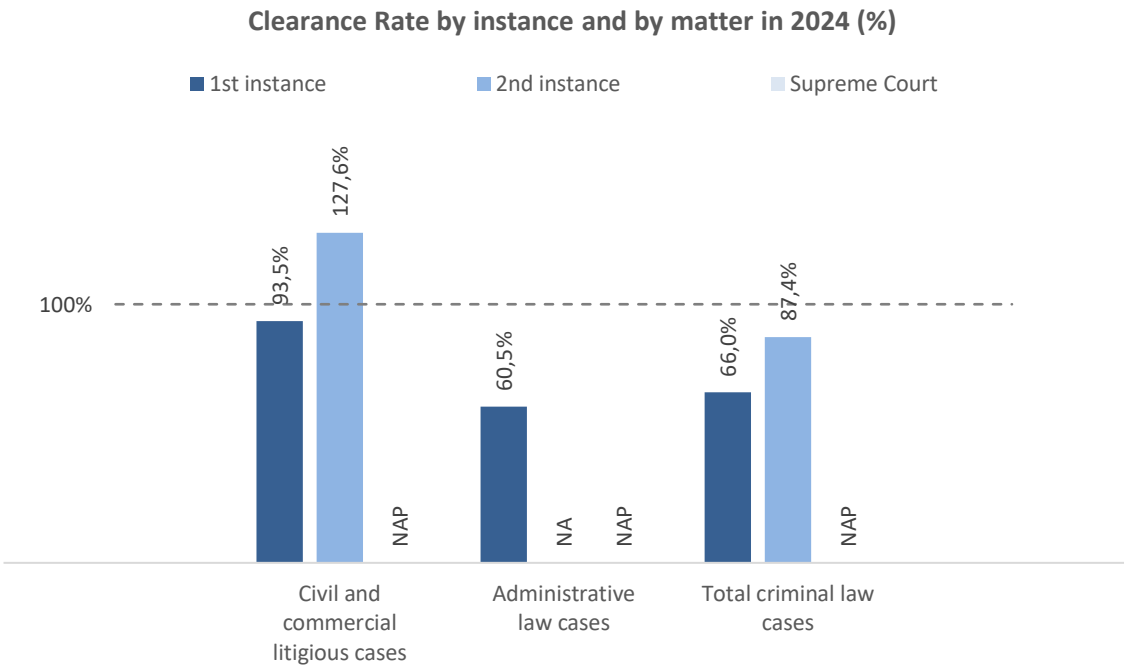

In civil and commercial litigation, the clearance rate at first instance is at 93.5%, indicating that the number of resolved cases did not fully match incoming cases during the year and suggesting a continued risk of backlog accumulation. In contrast, the second instance records a clearance rate of 127.6%, well above the treshhold. Following legislative amendments, the efficiency of this court improved as a result of faster case processing time. Disposition times in this category remain lengthy when compared with EU medians. First-instance proceedings in Malta take an average of 491 days, approximately twice the EU median of 248 days, while second-instance cases average to 322 days, compared with an EU median of 207 days.

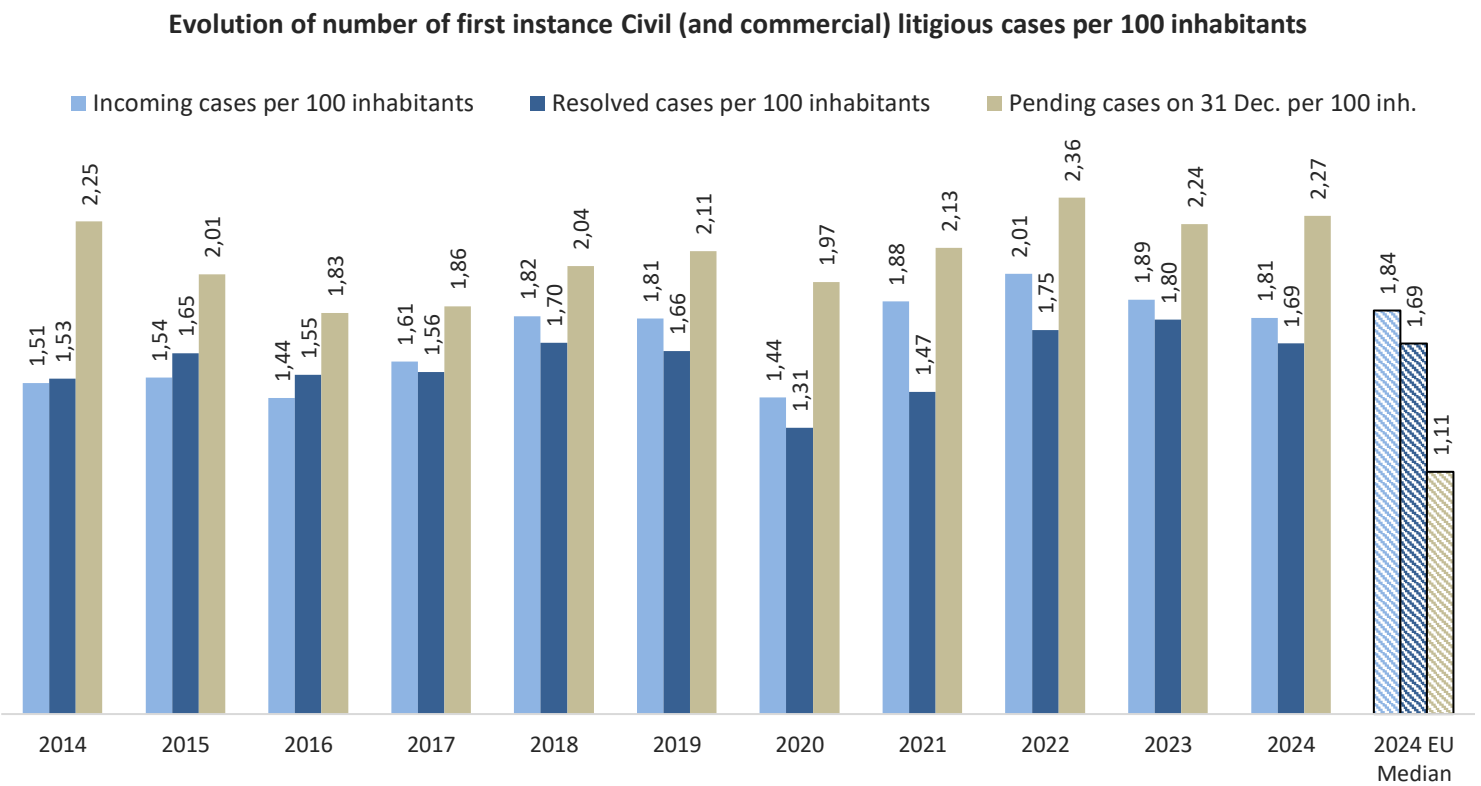
Administrative law cases present the most pronounced challenges. The first-instance clearance rate is 60.5%, a level that points to a substantial imbalance between incoming and resolved cases and a strong likelihood of growing backlogs. This is reflected in the exceptionally long disposition time at first instance, with 1 681 days, exceeding the EU median of 327 days by a wide margin.

In total criminal law cases, clearance rates are also below 100% at both first and second instance, at 66% and 87.4% respectively. Disposition times reinforce this assessment, with first-instance criminal cases taking an average of 862 days and second-instance cases 482 days, compared with EU median values of 128 and 121 days respectively.

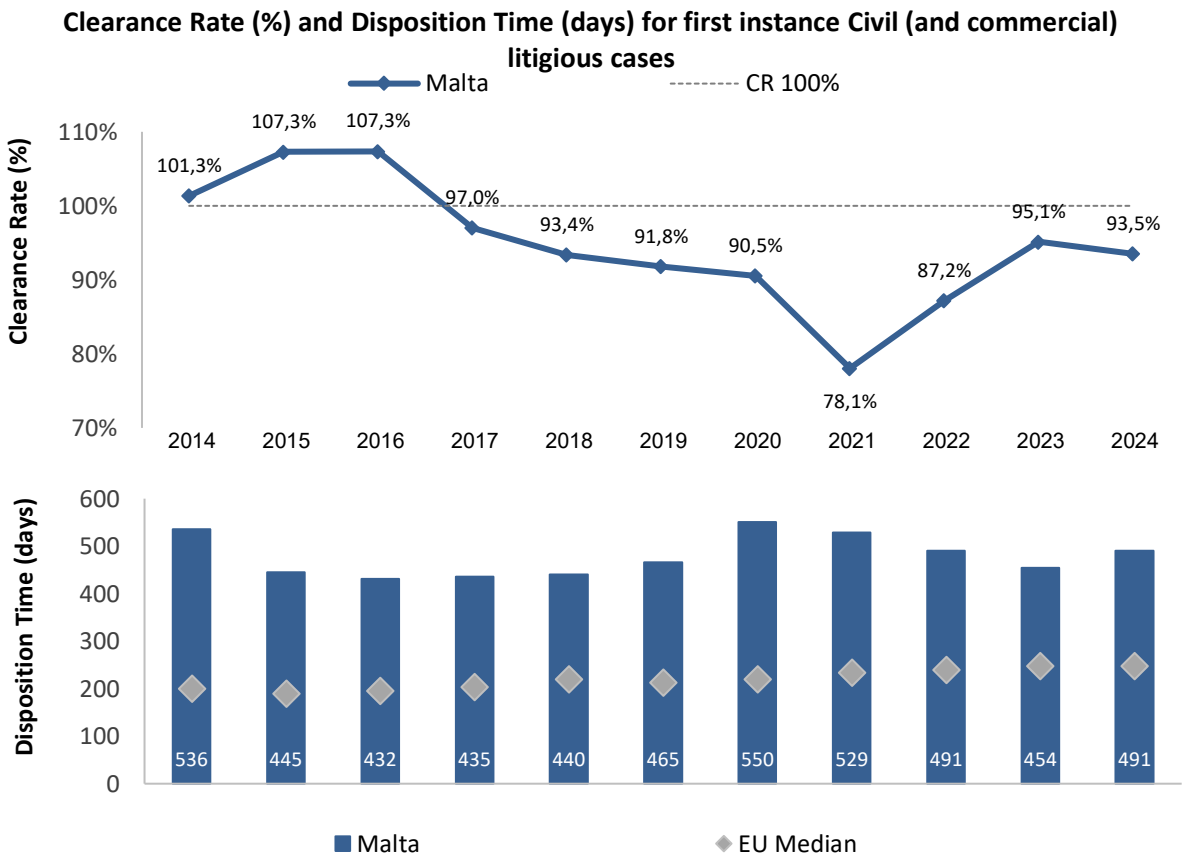

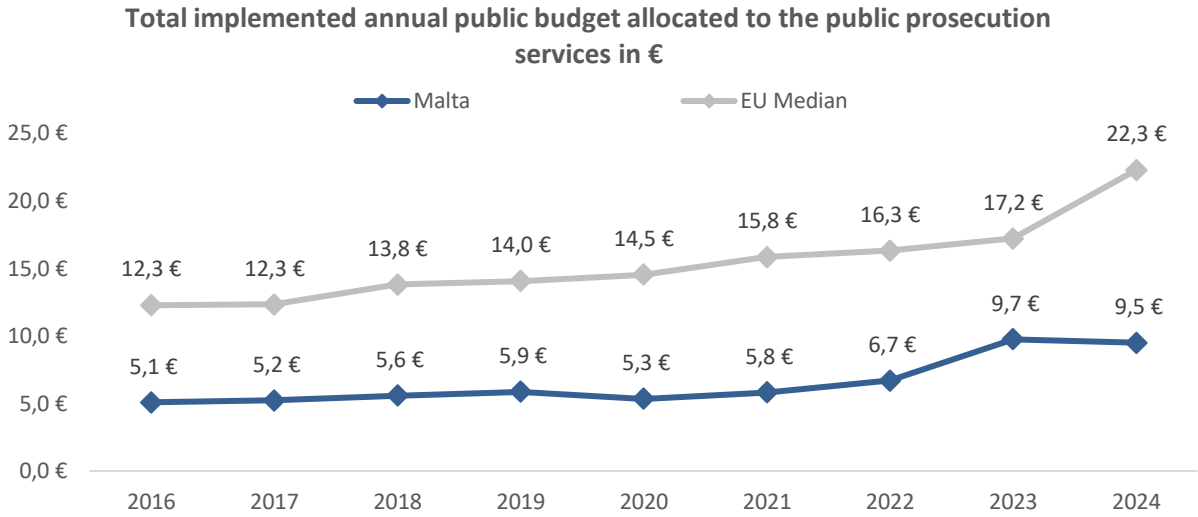
In the Maltese legal system, all proceedings which appear before the Court of Magistrates may be punishable with a fine or imprisonment, except for a few contraventions which still appear before the Court of Magistrates and for which it is not possible to obtain data relating to these few cases.

Nevertheless, all cases which lead to an imprisonment of ten years or more can only be heard by the Criminal Court whilst cases between 2 and 12 years may be heard by the Court of Magistrates only once the procedure before it as a Court of Criminal Inquiry is completed. Since in Malta the vast majority of the cases contemplate the possibility of imprisonment, barring a few contraventions, the cases indicated as misdemeanors/minor offences, are those cases which are heard by the Court of Magistrates (excluding those being heard as a Court of Criminal Inquiry) having a maximum punishment of 2 years imprisonment while the cases indicated as 'severe criminal offences' are those having a punishment of over 2 years (Criminal Court & Court of Criminal Inquiry).

The public prosecution services are carried out by the Attorney General's office. The Attorney General not only acts as a public prosecutor but also as the principal legal advisor of all the Government Departments. As a result, the amount budgeted cannot be considered as being funds allocated solely for public prosecution services, but also for other purposes relating to legal work and advise for the Government, both locally and internationally.

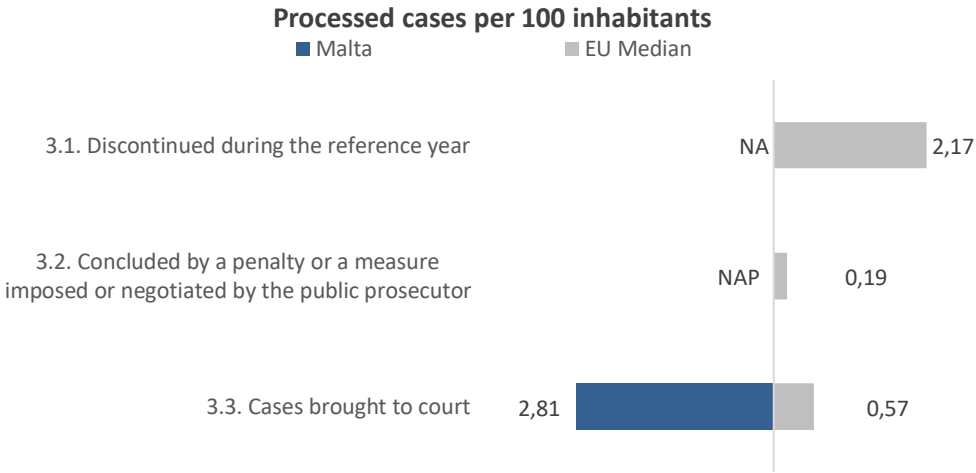
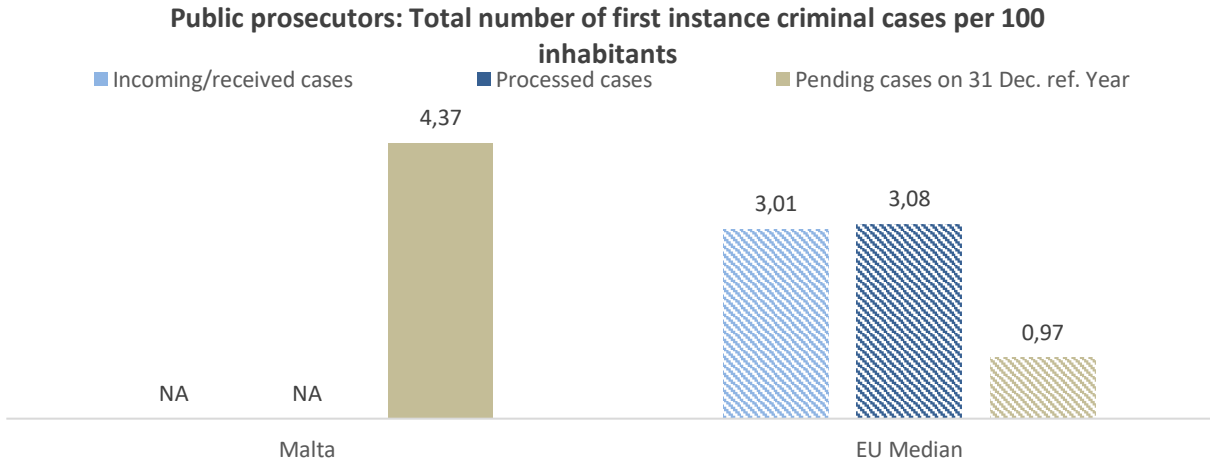

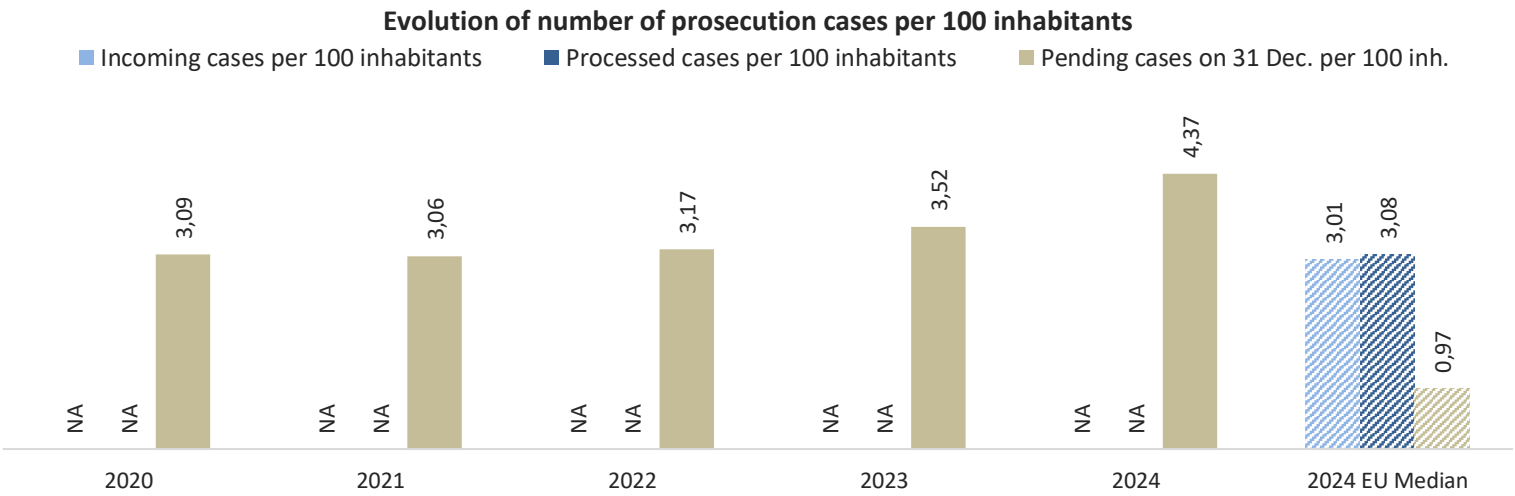

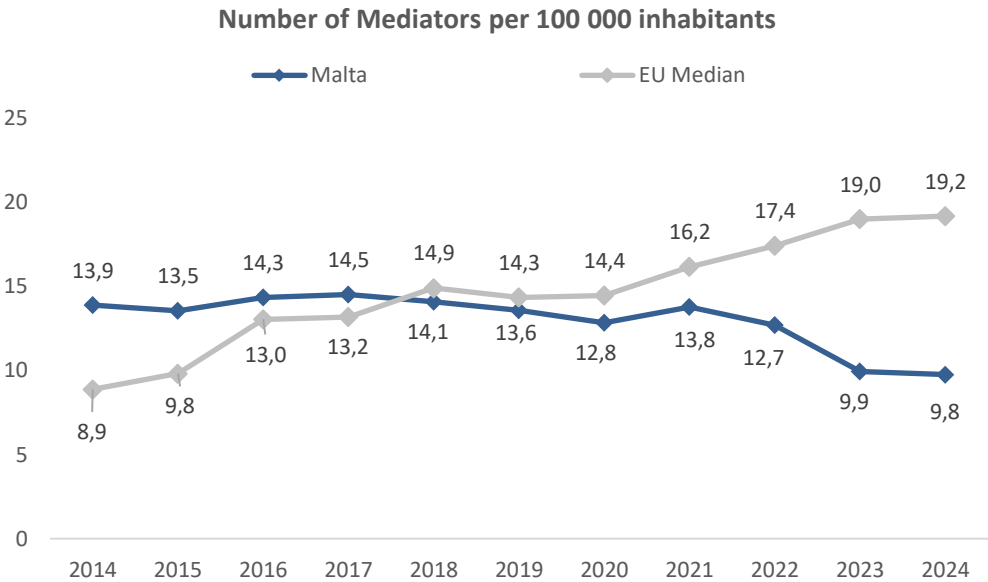

In 2024, there are 392 notaries which represents 68,3 notaries per 100 000 inhabitants.

The Notary is a Public Officer and as such is an emanation of the State. At the same they are free professionals with a personal office, independent of the State and of the parties. This dual-nature ensures the right balance between the legal-fiscal functions for which the Notary is the ultimate reference point.

Conveyance (property sales, purchase, leasing, etc.), financing collateral (hypothecation of immovable), succession (wills, trusts, etc.) and matters pertaining to civil status (matrimonial regimes, personal separations, etc.) are all within the ambit of the profession and form the portfolio of a notary’s day-to-day work. It is only through a notarial act that most transactions related to the above are given legal effect and this adds certainty and improves efficiency. Being a necessary passage at Law, the notarial requirement makes for a very cost-effective way of crystallizing a state of certainty in that notarial tariffs are stipulated by law and the citizen is all the more protected. The notarial intervention is thus imposed by law to safeguard legality and ensuring at all times that the autonomy of the private citizen never goes beyond what is legally and statutorily permitted.

#### Comments on writing assistance tools

In the current system, DigiCourts, the main writing assistance tools deployed are templates of standard documentation used by the court staff. Most of these templates reflect official court documents that are also annexed to the Code of Civil Procedure, Chapter 12 of the Laws of Malta. The proposed new case management system will have enhanced writing assistance tools and will include the use of the electronic signature to facilitate the transition to a fully digitalised system.

#### Comments on recording of court hearings

In terms of 'automatically indexed recording', the recordings made during the sittings are automatically organised by sitting, which simplifies storage and retrieval in a specific order. The Court Services Agency have also implemented an advanced audio-digital system that will enable the judiciary and court officials to record hearings seamlessly, securely store and organise files, and quickly retrieve and manage recordings. This makes the audio-visual recordings more efficient, reliable and transparent in the handling of the judicial proceedings.

## 8. Systems for measuring and evaluating the performance of courts and public prosecution services in Malta (2024 data)

In Malta, quality standards are determined for the judicial system at national level (e.g. quality systems for the judiciary and/or judicial quality policies). However, there is no specialised personnel within the courts or the public prosecution services entrusted with implementation of these national level quality standards.

There is a Code of Ethics for the members of the Judiciary which, though not providing for the organisation and quality of the judicial work, lays upon the members of the Judiciary certain obligations, important in ensuring the transparency and independence of the judicial process.
