BUREAU OF THE STEERING COMMITTEE ON ANTI-DISCRIMINATION, DIVERSITY AND INCLUSION 2nd meeting, 4-5 October 2021

Strasbourg, Agora Building, Room G 05 and BlueJeans videoconferencing platform

Report

1. The Bureau of the Steering Committee on Anti-Discrimination, Diversity and Inclusion (CDADI) held its second meeting on 4-5 October 2021, with Triantafillos Loukarelis (Italy) in the Chair. The list of participants appears in Appendix I.

ITEM 1: Opening of the meeting and adoption of the agenda

2. The Bureau adopted the agenda as it appears in Appendix II.

ITEM 2: Developments since the 3rd CDADI plenary meeting

- 3. The Chair recalled that after the 3rd CDADI plenary in June 2021, the public consultations on the draft CM Recommendation on multi-level policies and governance for intercultural integration and the draft CM Recommendation on combating hate speech had taken place. The Chair further recalled that the CDADI adopted, through written procedure, observations on the recent Recommendations of the Parliamentary Assembly, namely 2206(2021) on "The impact of the Covid-19 pandemic on children's rights" and 2207(2021) "For a European policy on diasporas".
- 4. Adrienn Tóthné Ferenci (Hungary) provided information on the <u>activities</u> of the current Hungarian Presidency of the Council of Europe's Committee of Ministers and in particular on the presentation of the CDADI <u>Study on the active political participation of national minority youth in Council of Europe member states</u> at the conference "National minority rights on the agenda of NGOs and research institutes", which took place on 7 September 2021. Adrienn Tóthné Ferenci further highlighted the conference on Roma inclusion "From early childhood to profession", which took place on 22-24 September 2021, and the fact that Hungary will host the upcoming 4th ADI-ROM meeting, which is scheduled for 27-28 October 2021.
- 5. The Chair informed the Bureau on the priorities of the future Italian Presidency of the Council of Europe's Committee of Ministers: women's rights and the fight against gender-based violence; children's rights; the impact of artificial intelligence on human rights, democracy and the rule of law; and the protection of cultural heritage. The Chair recalled that the 5th CDADI meeting would take place on 15-18 March 2022 in Rome

ITEM 3: Future work

- 6. Jeroen Schokkenbroek, Director of Anti-Discrimination, informed the Bureau about the negotiations on the terms of reference of the CDADI for the years 2022-2025, including the suggested substructures. Furthermore, the Director gave an overview of the process and calendar for their adoption by the Committee of Ministers, which is expected to take place at the end of November 2021.
- 7. The Bureau discussed the planning and scheduling of CDADI meetings in 2022 and 2023, the establishment of the necessary substructures for preparing the proposed deliverables and the appointment of members to those substructures once the new terms of reference are adopted.

ITEM 4: Preparation of the agenda for the 3rd CDADI meeting

a. Draft Agenda

8. The Secretariat presented, for revision by the Bureau, the preliminary draft agenda of the 4th CDADI meeting (7-9 December 2021) and recalled that the CDADI should, at that meeting,

hold elections of the Chair, Vice-Chair, Bureau members, appoint Rapporteurs and, subject to the adoption of its new terms of reference, designate members to the substructures that will be set up for the biennium 2022-2023. The Bureau agreed with the preliminary draft agenda, which will be sent out together with the convocation to the 4th CDADI meeting.

b. Work on main deliverables by expert committees and working groups

i. Working Group on Intercultural Integration (GT-ADI-INT)

9. Ivana D'Alessandro, Secretary of the GT-ADI-INT, recalled that a public consultation on the draft CM Recommendation on multi-level policies and governance for intercultural integration had been held from 28 June to 14 August and that the draft had been widely disseminated through the website of the GT-ADI-INT, posts on social media and individual emails to various stakeholders. The draft was updated and discussed at the 5th meeting of the GT-ADI-INT on 28-30 September in Valencia and would be presented to the CDADI during its 4th meeting in December, for adoption and transmission to the Committee of Ministers.

ii. The Committee of Experts on Combating Hate Speech (ADI/MSI-DIS)

10. The Co-Secretary of the ADI/MSI-DIS, Menno Ettema, informed the Bureau that the public consultation on the draft CM Recommendation on combating hate speech had been launched on 23 June and ended on 8 August. The call to participate in the public consultation had been made available on the Expert Committee's website and announced as a news item on the sites of the CDMSI and the CDADI. In addition, it was sent by email to various CoE steering committees and monitoring bodies, International Organisations, the members of the CoE platform with Internet Businesses and other stakeholders in the fields of digital rights and anti-discrimination. During the summer, the Secretariat and the Rapporteurs drafted the explanatory memorandum and revised the main text in light of the comments of the CDADI and CDMSI members, participants and observers, as well as the comments received in the framework of the public consultation. After the 4th and final meeting of ADI/MSI-DIS on 6-7 and 21-22 October 2021, the text of the Recommendation and its Explanatory Memorandum would be transmitted to the CDMSI and the CDADI for discussion and adoption at their forthcoming plenaries in December, and submission of the draft Recommendation for adoption by the Committee of Ministers, which would also take note of the Explanatory Memorandum.

iii. Information on progress of implementation review of CM/Rec(2010)5

11. Eleni Tsetsekou, Head of the SOGI Unit, informed the Bureau on the preparation of a first thematic review on the implementation of CM/Rec(2010)5, which deals with legal gender recognition and serves as a pilot for the new review methodology. The reports that will be drafted following roundtables in the four participating member States and the summary report will expectedly be ready for the 5th CDADI meeting in March 2022. At the 4th CDADI meeting, the European Governmental LGBTI Focal Points Network's (EFPN) will give an oral report on this process. The Bureau was also informed about the EFPN Roundtable which would be held together with the EU High Level Group meeting on 22-23 November 2021.

iv. The Committee of Experts on Roma and Traveller Issues (ADI-ROM)

12. The Chair of the ADI-ROM, Tatjana Andelić, informed the Bureau about the upcoming ADI-ROM meeting in Budapest on 27-29 October 2021, in the framework of which the Hungarian authorities will also organise a field visit to two settlements. The Study on the causes, prevalence and consequences of antigypsyism, and possible responses will be submitted for

adoption at the 4th ADI-ROM meeting and subsequently presented to the CDADI. Furthermore, the ADI-ROM scheduled a thematic visit on the issue of begging in Bosnia and Herzegovina for 13-15 October 2021. Another thematic visit on the topic of substance abuse and trafficking is foreseen for mid-December in Poland. The ADI-ROM will examine the thematic reports emanating from those visits at the beginning of 2022 and subsequently submit them to the CDADI for decision on the follow-up.

13. The 12th Dialogue meeting with Roma and Traveller civil society on "Teaching the history of Roma and Travellers" will take place as a hybrid event in Strasbourg on 2-3 November 2021. Furthermore, the ADI-ROM will contribute to the organisation of the 8th International Roma women conference (IRWC) on "Protecting the human rights and dignity of Roma and Traveller women in times of crisis", which will take place as a hybrid event in Strasbourg on 24-26 November 2021.

ITEM 5: Working methods

14. The Bureau exchanged views on the working methods of the CDADI based on its document on that topic, which had been revised on the basis of the discussions during the 3rd CDADI plenary and agreed to submit a revised version for discussion at the 4th CDADI meeting.

ITEM 6: Relations with civil society and requests for observer status

15. The Chair recalled that it had been agreed during the 3rd CDADI meeting to continue the discussion concerning the relations with civil society and requests for observer status. The Bureau examined the practice of various Council of Europe Steering Committees in this regard based on an updated working document prepared by the Secretariat. It agreed to submit this updated working document to the CDADI for comments and that it should serve as a basis for discussion and the handling of the pending requests for observer status.

ITEM 7: Date of the next Bureau meeting

16. The Bureau agreed to prepare the 4th CDADI meeting on 6 December and to hold its next meeting on 24-25 January 2022, ahead of the CDADI plenary in March 2022.

ITEM 8: Any other business

17. No other business was discussed.
