3. Which Council of Europe committees and other activities is this committee mainly involved in?

Our committee is engaged in a range of cross-cutting initiatives addressing a wide spectrum of migration issues. We focus on maritime rescue operations, combating human trafficking, and opposing the criminalization of NGOs and volunteers who assist migrants, while also examining challenges in countries where migration is weaponized (such as Finland and Poland) and advocating for improved access to education and integration. These activities intersect with broader concerns under the Social Charter, including Children's Rights, Women's Rights, LGBTQ+ Minority Rights, and Education, with our transversal study theme centering on the accommodation of migrants.

4. How has this committee linked with other CINGO committees in the last year?

Over the past year, our committee has actively collaborated with other CINGO committees. Specifically, Christine Baur has served as the liaison between our committee and the Sport and Human Rights Committee. As part of this collaboration, we requested a contribution from them concerning the issue of housing for migrant athletes.

Additionally, we have established connections with the Artificial Intelligence Committee to share information regarding AI and migration.
