REPUBLIC OF MOLDOVA

New law on employment promotion and unemployment insurance is being implemented since February, 2019. It regulates a set of new measures intended to create new job opportunities. In addition, the Low covers a set of unemployment benefits regulations. The unemployment benefit is calculated based on the insured income of the unemployed person, received in the last 12 month, before registering at NEA. Unemployment benefit is paid from social insurance budget.

Basic principles

ALBANIA

Social insurance system linked to the payment of contributions. The

National Employment Service is responsible for the payment of unemployment benefit, the active employment programme, training, retraining programme and labour mediation

Unemployment benefit is a flat rate benefit unrelated to previous earnings, determined by the Council of Ministers and ensures at least a minimum standard of living.

ARMENIA

The state employment regulation policy aims to ensure sustainable employment for persons who are uncompetitive in the employment market.

The Unified Social Service (USS) offers jobseekers:

- consultation and information on rendered services;
- consultation on professional orientation;
- free mediation during job placement;
- participation in employment programs and events;
- education for retraining and quality increase.

AZERBAIJAN

Compulsory public unemployment insurance system.

BOSNIA AND HERZEGOVINA

Federation of BiH

In the Federation of Bosnia and Herzegovina, employees ensure their material and social security during unemployment, primarily through

unemployment insurance. Material and social security means financial allowances, in accordance with law, and contributions for health and pension insurance, in accordance with the law.

Republika Srpska and Brčko District of BiH

A social insurance scheme financed by contributions of employers and employees that provides an earnings-related benefit, payment of contributions for health insurance and pension.

GEORGIA

No social insurance system. Benefits are subject to negotiation and labour contact between employee and employer.

Severance payments are governed by the Labour Code. When an employment agreement is terminated by an employer and notified to the employee in written at least 30 calendar days in advance, the employee shall be granted severance pay in the amount of at least 1-month's remuneration. However, in case when the employer notifies the employee on the terminates the employment agreement and notifies the employee only 3 calendar days in advance, the employee shall be granted severance pay in the amount of at least 2 month's remuneration.

MONTENEGRO

Social insurance scheme which is based on the principle of economic activity.

Financed from contributions of employers and employees through payment of contributions.

Compulsory unemployment insurance provides the unemployed with entitlement to cash benefits and coverage with health insurance, pension disability insurance during the entitlement to cash benefits.

NORTH MACEDONIA

Compulsory social insurance scheme financed by employer's contributions which provides earnings related benefits.

REPUBLIC OF MOLDOVA

The amount of unemployment benefit is based on the ensured income . It is paid from the State social insurance budget (in case on unemployment benefit).

SERBIA

Social insurance system based on contributions by employees and employers, and self-employed persons. Earnings-related benefit.

TÜRKIYE

Triple system with contributions based on insurable gross earnings (those subject to contribution):

- 1% insured,
- 2% employer
- 1% State share

In 2023:

Minimum limit of daily earnings is 333.60 TRY.

Upper limit of daily earnings is 2,502.00 TRY.

The minimum monthly earnings subject to premium is 10,008 TRY.

The maximum monthly earnings subject to premium is 75,060 TRY.

Benefit depends on income. As the insurable gross earnings increase, higher contributions will be raised and hence the benefit will increase.

UKRAINE

The compulsory nature of unemployment insurance for all persons working under an agreement (contract) of employment or on other grounds provided by labour legislation, and also the voluntary nature of such insurance for persons who are self-employed and entrepreneurs.

Differentiation of the amounts of payment of unemployment benefit depending on the period for which the person has been insured and the duration of unemployment.

1. Employers will be available for one year of 100% of the compensation of a single social contribution for employment for newly created jobs for following categories of citizens: young people in their first job, the unemployed aged over 50, disabled, single parents, parents with children under 6 and disabled children, orphans and persons released after serving their sentences.2. Reducing at 50% for the period of one year of the single social contribution for those employers who in the previous year, created new high paying jobs with a salary of not less than 3 minimum. 3. Small businesses that create new jobs and employing them unemployed for a year receives a monthly payment of

compensation to a single social contribution for each job created in the priority sectors of the economy. The law of 2002 also simplifies the procedure of registration of the unemployed and the appointment of his unemployment benefits, provides specific and institutional transformation. Determine the status of the State Employment Service- as a central authority, new powers and tools of the body in implementing policy on employment and labor migration. Payment of service of employment agency will carry only the employer, not the person who is looking for work.

Unemployment insurance contribution:

- at the expense of contributors, from the base 1.50%;
- at the expense of the employer, based on 0.50%.

ALBANIA

Able-bodied,

- unemployed person seeking employment,

- registered with the Unified Social Service and formally recognised as an unemployed person, willing to take up suitable work.

Employable age (aged between 15 years of age and pensionable age), registered with the state employment services, actively seeking work and willing to work.

BOSNIA AND HERZEGOVINA

Article 3 of the Law on Mediation in Employment and Social Security of Unemployed Persons considers an unemployed person in terms of this Law as a person capable of working who is not employed and who:

- does not have a registered company or other legal entity, ie does not realize a dividend on the basis of a share in a company or other legal entity;
- has no registered trade;
- is not engaged in agricultural activity;
- is not a beneficiary of a pension according to the regulations on pension and disability insurance;
- is not a full-time student;
- which does not generate income on any basis;
- is actively looking for a job.

Republika Srpska

- unemployed due to the luck of jobs or need for certain qualifications,
- age of 15-65 -capable or limited capable for work,
- actively seeking employment and available for work;
- $\ \text{registered with the Employment Service which shall develop individual employment plan}; \\$
- active job seeker is also seeker of other employment in accordance with his/her qualifications,
- owners of commercial or agricultural activity, which regulated by agricultural regulations;
- is not a full-time student or a pensioner,
- persons with suspended employment rights for certain period,
- owner or co-owner with more than 50% share in legal subject of profit activity.

Brčko District of BiH

- Unemployed due to the luck of jobs or need for certain qualifications
- actively seeking employment;
- registered with the Employment Service;
- does not perform any independent professional and economic activity;
- is not a full-time student or a pensioner.

An unemployed person aged 15-67, being a Montenegrin citizen, registered with the Employment Office of Montenegro, who is capable or partially capable to work, who is not employed and who is actively seeking employment and who is available for work.

- d) does not study in a form of full-time education;
- e) is actively looking for a job both individually and through the territorial subdivision and is available to start work;
- f) is registered as unemployed at NEA.

Conditions of Benefiting from Unemployment Benefit:

AZERBAIJAN

In general, the minimum qualifying period is 12 months of insurance record in the period of the 24 calendar months preceding the date of becoming unemployed. For persons with the insurance record of less than 12 calendar months during the period of 24 calendar months preceding the date of becoming unemployed, a minimum benefit is paid if they have at least one year of insurance record.

Persons who became unemployed upon termination of a fixed-term employment contract concluded for a duration of 36 for 36 consecutive calendar months are eligible for benefit if they have an insurance record of at least 30 months.

BOSNIA AND HERZEGOVINA

Paid contributions without any interruption during minimum 8 months or with interruptions over a period of 8 months in the last 18 months before unemployment took place.

Republika Srpska and District Brčko of BiH

Paid contributions for unemployment continually over a minimum period of 8 months in the last 12 months or of minimum of 12 in months with interruptions in the last 18 months before unemployment.

GEORGIA

MONTENEGRO

- 1. Entitled to cash benefits are insured persons whose employment had been terminated without his/her consent or guilt, and who prior to the termination of employment had a continuous insurance period of at least 9 months or with interruptions in the last 18 months.
- 2. A participant who was employed in part-time employment is entitled to cash benefit, if he/she meets the conditions under point 1 based on redistribution of working hours to full-time working hours.
- 3. Entitled to cash benefits are also insured persons who, pursuant to a special law, have ceased to perform entrepreneurial, professional or other activity as a core occupation without his/her guilt, and who at the time of termination of the activity, had a continuous insurance period of at least 9 months or with interruptions in the last 18 months.

NORTH MACEDONIA

Minimum 9 consecutive months in employment /insurance or 12 months with interruption during the last 18 months of employment/insurance.

REPUBLIC OF MOLDOVA

Applicants must have been in paid employment for at least 12 of the 24 months prior to registering with the employment office.

SERBIA

12 months of continuous insurance (including self-employment) or at least 12 months of insurance with interruptions in previous 18 months.

- Having paid unemployment insurance premiums for minimum 600 days in the last three years prior to the termination of the labour contract.

- For the calculation of the insurance indemnity, the lost average monthly salary of the insured is established by dividing the sum of the salary of the 12 calendar months preceding the date of the insured event by 12.
- If the insured person did not work all months of the previous 12 calendar months (but has insurance experience of at least 12 calendar months during the 24 calendar months preceding the date of the insured event), the average monthly salary of the insured is calculated for a period equal to the number of months actually worked for the previous 24 calendar months, divided by the number of months actually worked.
- The amount of the average monthly salary for the calculation of insurance payments is determined on the basis of information on the monthly salary of the insured in the reports on insurance premiums in the electronic information system of the body (institution) determined by the relevant executive authority.

The rate of first-time insurance benefit varies depending on the duration of the unemployment period (but is not less than the minimum insurance benefit):

For 5-6 calendar months: 70 percent.

In case of repeated application, the minimum insurance benefit is paid.

Unemployment benefits/cash benefits are not linked to earnings and currently amount to 40% of the average net salary paid in the Federation of BiH in the last 3 months before the termination of employment of the unemployed person, published by the Federal Office of Statistics.

Rate of benefits depends upon insurance record and is paid as percentage of individual's average earnings:

- less than 15 years insurance 45% from average salary which unemployed person realized in the last three months of work
- more than 15 years insurance -50% from average salary which unemployed person realized in the last three months of work
- cash benefits can no be lower than 80% of the lowest salary in the Republic of Srpska nor higher than average salary in Republic after taxation for previous year

Benefit is paid on a monthly basis.

50% of reference earnings for workers who have the right to benefit for up to 12 months, while for workers who are entitled to benefit for longer than 12 months the benefit equals 50% of reference earning in the first year of entitlement and 40% of reference earnings in the remaining time period.

The amount of the benefit cannot be higher than 80% of the national average monthly net salary in the past month (29,943 MKD/483€).

By rule the benefit is paid monthly.

REPUBLIC OF MOLDOVA

The amount of unemployment benefit is determined by the circumstances in which the person has ceased work:

- Due to employer decision 50% of the average monthly insured income of the person in the last 12 months of the last 24 calendar months preceding the date of registration;
- Due to employees decision 40% of the average monthly insured income of the person in the last 12 months of the last 24 calendar months preceding the date of registration;

The monthly amount of the unemployment allowance can not exceed the average monthly salary for the previous year and it is paid monthly.

Net amounts: Minimum – 16,712 RSD (20% of the average wage in Serbia in January 2023), Maximum – 38,741 RSD (47% of the average wage).

TÜRKIYE

The amount of daily unemployment benefit is 40% of the average gross earnings over the last 4 months. The amount of benefit cannot exceed 80% of the monthly gross minimum wage for workers.

Payments are made monthly. Amount of payment for those whose earnings are gross minimum wage in 2023 for the last 4 months is 3,972.82 TRY, maximum payment is 7,945.63 TRY.

The total duration of payment of insurance benefit for one person may not exceed 9 months within 24 months from the time of initial application.

Cash benefit is granted to an unemployed person for a period of:

- 3 months, if he/she has insurance service from 9 months to 5 years;
- 6 months, if he/she has insurance service from 5 to 15 years;
- 9 months, if he/she has insurance service from 15 to 25 years;
- 12 months, if he/she has insurance service from 25 years to 35 years;
- until re-employment or until fulfilment of the conditions in terms of years of age and insurance service for exercising the right to an old-age pension, if he/she has over 35 years of insurance service.

NORTH MACEDONIA

Duration of benefits depends on the time the insured person has been employed and has been paying insurance contributions.

For example:

- 1 month duration for those with 9 consecutive months of employment insurance or 12 months with interruptions during the last 18 months (minimum duration);
- 6 months duration for those with 10 to 12.5 years of employment insurance;
- 12 months payment for those with more than 25 years of employment insurance.

Unlimited duration, i.e. until a new status occurs (pension, employment, etc) for persons who have been more than 15 years in employment and who are at the most 18 months short to qualify for an old age pension.

Duration of benefit is extended for women during pregnancy and for persons on training for the time of its duration.

REPUBLIC OF MOLDOVA

1-10 years of affiliation: 5 months 10-15 years of affiliation: 7 months 15 or more years of affiliation: 9 months.

SERBIA

Between 3 to 24 months scale dependant on age and contribution period:

3 months, if insured up to 5 years;
