MONITORING COMMITTEE: WORK OVERVIEW¹

This paper contains a brief presentation and a draft calendar of future meetings and activities, and a list of adopted documents prepared by the Monitoring Committee.²

Introduction: brief presentation of the Monitoring Committee

The Monitoring Committee was established in 1997 by the Parliamentary Assembly. It is chaired since 6 March 2024 by [Ms Zanda Kalniņa-Lukaševica](#) (Latvia, EPP/CD) and comprises 93 seats. You will find the list of members [here](#).

The Assembly's monitoring helps Council of Europe member States to fulfil their promises to uphold the highest democratic and human rights standards. The procedure works in four ways:

- **Full monitoring procedure:** This involves regular visits by a pair of rapporteurs, who conduct an ongoing dialogue with authorities, and occasional plenary debates to ensure that a State's progress and problems are honestly assessed. This currently applies to ten States (Armenia, Azerbaijan, Bosnia and Herzegovina, Georgia, Hungary, Republic of Moldova, Poland, Serbia, Türkiye and Ukraine).
- **Post-monitoring dialogue:** States that have made progress may pass on to this stage, a less intensive procedure involving a limited number of remaining issues. This currently applies to four States (Albania, Bulgaria, Montenegro and North Macedonia).
- **Periodic reviews:** The Committee is seized to prepare regular periodic reviews on all Council of Europe member States that are not under a full monitoring procedure or engaged in a post-monitoring dialogue. The order and frequency of these reports is decided upon by the Committee in accordance with its internal working methods based on substantive grounds, with the objective of producing over time, periodic review reports on all member States. The Committee is currently preparing periodic monitoring reports on Greece, the Netherlands, Spain and Sweden.
- **Specific report on the Functioning of Democratic Institutions:** Finally, the Committee can prepare a report on the functioning of democratic institutions in any member State when particular developments warrant.

Decision on revised internal working methods for the selection by the Monitoring Committee of countries for periodic review on the honouring of membership obligations

Prepared by the Chairperson of the Committee

1. According to its terms of reference, the Monitoring Committee is tasked to ensure and assess the fulfilment of obligations assumed by all member States under the Council of Europe Statute, the European Convention on Human Rights and all other conventions concluded within the organisation to which they are party. To that extent, the Committee shall prepare regular periodic review reports on the honouring of membership obligations for all member States that are not under a full monitoring procedure or engaged in a post-monitoring dialogue. In line with [Resolution 2261 \(2019\)](#), the Monitoring Committee shall select the countries for periodic review according to its internal working methods, on substantive grounds, while maintaining the objective of producing, over time, periodic reviews on all member States.
2. Each year the Committee will hold a regular selection procedure in which it will select three countries for periodic review.
3. The selection of countries for periodic review will take place on substantive grounds based on:
 - 3.1. findings of the Assembly, in particular contained in resolutions and reports prepared by other Committees of the Assembly;
 - 3.2. the findings and conclusions of reports of other monitoring bodies of the Council of Europe;
 - 3.3. questions raised by members of the Committee, international and national civil society and the media regarding developments related to the functioning of democratic institutions, the human rights and the rule of law.
4. When starting the selection procedure, the Chairperson will invite all members of the Committee to propose countries for inclusion on a short list. Members should submit their proposals in writing with detailed reasoning. The deadline for submission of proposals shall be set by the Chairperson of the Committee. It shall be not less than four weeks after inviting members to propose candidates for periodic review and not less than two weeks before the subsequent meeting of the committee. In order to ensure the high quality of the selection process, no proposals will be accepted after the deadline. A Member State that has been subject to periodic review less than 3 years previously may not be proposed.
5. On the basis of the grounds mentioned in paragraph 3, the Chairperson of the Committee will then prepare a reasoned shortlist of, at least, 5 member States.
6. A shortlist will be sent to all members within the deadlines provided for by the Rules of Procedure i.e. one week before the meeting. Article 10 of Resolution 1115 (1997) reads: "When a monitoring procedure is initiated, two members of the parliamentary delegation of the member State concerned (to represent the governing majority and the opposition) shall be invited to take part, without the right to vote, in the relevant debates of the committee unless one or both are already represented on the Committee."
7. Following a general discussion, a vote will be held to select three countries out of the shortlist prepared by the Chairperson. Before the voting begins, the Chairperson shall ascertain whether there is a quorum. If there is a quorum it shall be considered present for the total duration of the vote. If no quorum is present, the vote shall be postponed to the next meeting of the Committee. If also during that second meeting no quorum is present, the vote shall be postponed to the following meeting of the Committee, during which no quorum will be required.
8. The countries will be selected by secret ballot. Each member will select on their ballot three countries. Ballots with more or less countries selected will be considered invalid. The countries that receive the most votes shall be considered selected. In the event that, as a result of countries receiving equal numbers of votes, more than 3 countries are selected, the secret ballot shall be repeated between the runners up that receive the same amount of votes, until 3 countries are selected.⁸

9. The Committee decision shall be ratified by the Assembly in the framework of the Progress Report of the Bureau and the Standing Committee. If the decision is successfully challenged in the Assembly, it is referred back to the Committee for reconsideration. Following the Assembly's confirmation of the selected countries through the ratification, in line with [Resolution 1115 \(1997\)](#) as amended, the Committee shall appoint two co-rapporteurs for each country selected. They will prepare the periodic review reports in line with the deadlines set by the Rules of Procedure and relevant provisions in [Resolution 1115 \(1997\)](#).

C and D each 5 votes. A secret vote shall be held between countries C and D. Another example: Country A receives 10 votes, countries B, C and D receive both 8 votes. A secret vote shall be held where members can select two countries from among B, C and D.
