

## Olivera Lakic, investigative journalist of Vijesti has been shot and wounded

On May 8, 2018 in Podgorica, journalist Olivera Lakić was attacked.

In cooperation with police officers, as well as with relevant expert witnesses, the Prosecutor performed the scene investigation and provided timely instructions to the police on the actions within their jurisdiction that needed to be undertaken.

In addition, the Prosecutor has conducted numerous exhibits in this case but concrete details may not be presented at this moment, in order to prevent the investigation to be jeopardized.

The previous case regarding the attack on journalist Lakić processed before courts is considered to have been finished.
