According to the art. 5 of the Law on Judicial Council and judges , judges in Montenegro are entitled with the right to professional association.

The Association of Judges of Montenegro has a Statute, as an legal act that governs activities area of Association, Association Objectives, activities for achieving objectives, membership and membership fee, rights and obligations of members, organisational structure of Association, association bodies and assets.

Since our Association is organized and registered as an NGO, the Law on NGOs also applies .

The Association of Montenegrin judges is a voluntary, professional and independent form of joining of judges in Montenegro, that strives for establishing of independent, professional, efficient and responsible judiciary by affirmation of law as profession, improvement of regulations, strengthening the reputation, professional ethic and dignity of judges and establishment of material and social security of judicial profession and that is subjected to the rules regulated in its Statute, for protecting and achieving of common objectives.

Administration of the Associations of Judges

13. How are the governing bodies, the secretariat and officers of the Associations of Judges selected? What is their term of office?

Permanent Association bodies are: Association Assembly, Executive board, Association President and Secretary. The permanent Association bodies members shall be elected to a four-year term of office and can be re-elected several times. The temporary Association bodies shall be established by Executive board, upon nomination by the Association President.

The Assembly is the supreme body of the Association, it is composed of representatives of all courts in Montenegro: one representative from courts numbering to 10 judges, two representatives from courts numbering to 20 judges and three representatives from courts numbering more than 20 judges.

The Executive Board is the body managing the Association, formed of elected members of Association - 7 (seven) members. Nomination for election of members of the Executive Board is constituted by Association Assembly. The Executive Board member is appointed to a four-year term of office.

The Association has a President. He/She shall provide the correct and legal work of Association, and is elected by the Association Assembly to a four-year term of office. The Association President has a Deputy who shall replace him/her when s/he is absent.

The Association Secretary shall be appointed to a four-year term of office.

They all can be re-elected.

The President of the Association is a member of : Council for monitoring the implementation of the Judicial reform strategy 2019-2022, Commission for the Judicial Code of Ethics, Working group for the negotiations with EU for Chapter 23 –Judiciary and Fundamental rights.

22. How do the Associations of Judges interact with NGOs?

The Association of Judges of Montenegro is engaged as a partner in several projects implemented by the NGO Civic Alliance and NGO Center for Democratic Transition (CDT).

NGO CIVIC ALLIANCE (partnership): ANONYMOUS SURVEY OF CITIZENS AND JUDGES ON THE SITUATION IN THE JUDICIARY –Inline with measure 1.1.5.6. from the Action Plan for Chapter 23, the Association of Judges of Montenegro, in partnership with the Civic Alliance, conducts an anonymous survey of citizens and judges on the situation in the Judiciary. This survey has been conducted seven times so far. Project "IMPROVING THE OPPORTUNITIES OF CRIMINAL LAW INSTITUTIONS TO COMMUNICATE ABOUT THEIR WORK WITH CITIZENS " -Within this project, the Association of Judges, in partnership with the NGO Civic Alliance, have organized five public events for the final year students of two high schools and the students of three Law faculties.

NGO CENTER FOR DEMOCRATIC TRANSITION(CDT) (partnership): The Association started a partnership with the NGO Center for Democratic Transition –CDT for the project "Transparency of Criminal Justice System in Montenegro." The project was aimed to establish a methodology for monitoring of the transparency of the three main pillars of the criminal justice system, ie. courts, prosecution and police administration. The focus of monitoring was transparency, as one of the basic preconditions for the fight against corruption. Based on an analysis of key shortcomings, recommendations for improvement have been created, in accordance with international standards and good practices. This project was supported by the US Embassy in Podgorica. This project continued in 2019, when the transparency of Montenegrin judicial institutions was measured according to new indicators.

This NGO and the Association are partners on the project "Transparency Judiciary Initiative project" which is implemented by the Center for Democratic Transition -CDT, with the support of the Delegation of EU in Montenegro. In the first phase, partners organized two trainings on media relations, aimed at fostering cooperation and constructive dialogue with the institutions of the legal system, contributing to more transparent court proceedings, better access to justice, greater quality of judicial proceedings, and increasing public trust in the judicial system. The second phase involved a public campaign and the development of five brochures on Criminal Procedure, Civil Procedure, Free Legal Aid, Organization of Courts and Judicial Responsibility. These brochures were distributed to citizens in all Montenegrin municipalities via info-points, and since the end of 2017 they have been available in all courts in Montenegro.

23. How do the Associations of Judges interact with foreign or international organisations?

Within the Horizontal facility for the Western Balkans and Turkey implemented by the Council of Europe, the Association of Judges of Montenegro has been recognized as an equal partner through membership of the steering committees of the projects "Accountability in the Judicial System" and "Accountability and Professionalism in the Judicial System of Montenegro".

The Association is a member of the International and European associations of judges, as well as member of the MEDEL –European association of Judges and Prosecutors
