MEETING REPORT

Opening and agenda

- The Committee of experts on quality journalism in the digital age (MSI-JOQ) met in Strasbourg on 26 September 2019. The meeting was opened and chaired by Ms Katharine Sarikakis. Mr Jan Kleijssen, Director of Information Society – Action against Crime, welcomed the members and participants and thanked them for their committed and engaged work on the three deliverables under their charge. Mr Kleijssen furthermore provided some information on the future activities of the Council of Europe, notably of the establishment of the intergovernmental Ad-hoc Committee on Artificial Intelligence (CAHAI) tasked with examining the feasibility and potential elements of a legal framework related to AI-development.
- 2. The Committee adopted the agenda (see Appendix I) without any changes. The draft annotated agenda and the list of participants appear in Appendix II and in Appendix III, respectively. Of the 21 participants, there were 12 women (57%) and 9 men (43%).

Conclusions and decisions

- 3. The MSI-JOQ had finalised the Draft recommendation on promoting a favourable environment for quality journalism in the digital age, after having provided comments in writing in July/August 2019, in parallel with the Steering Committee on Media and Information Society (CDMSI). This procedure ensued from the CDSMI's position expressed in the 16th plenary meeting (4-6 June 2019) that in view of its maturity the text should be approved in written procedure to speed up the process and have it finalised by the end of 2019. Following a number of written comments by both the members of the MSI-JOQ and the CDMSI, the expert committee made a few minor editorial changes to the document and approved the text.
- 4. The MSI-JOQ further discussed the Draft study on supporting quality journalism through media and information literacy, as prepared by the rapporteurs, welcomed the study's approach and findings, and provided a number of insightful comments. Since the draft study includes a number of valuable practices, the rapporteurs

followed up with the respective organisations and acquired more detailed information about the audience reach, budget, duration of projects and their scaleability. They revised the text, which was presented for final comments in writing and finalised by 15 November.

Any other business

- 5. The fourth being the last meeting of the MSI-JOQ, the members expressed their satisfaction with the work carried out by the group and emphasised its timeliness and its importance for more sustainable and trustworthy journalism. Having been informed by the Secretariat about the plans for future media- and digital governance- related activities, a number of them expressed interest in a continued cooperation with the Council of Europe.
- 6. The MSI-JOQ decided that the Secretariat would prepare a draft meeting report to be sent to the Chair and the Vice-Chair for consideration. Thereafter the Secretariat will send the draft report to the MSI-JOQ with a deadline of five full working days allowing for comments. In the absence of comments within the deadline, the report will be deemed adopted by the MSI-JOQ and will be transmitted to the CDMSI.
