MSI-RES(2021)03 19 April 2021

Meeting report

Opening and agenda

- 1. The meeting was opened by Mr Jan Kleijssen, Director, Information Society Action against Crime, who informed the members and participants about the recent developments in the Council of Europe. Mr Kleijssen evoked the Committee of Ministers' decision of 16 March 2022 to exclude the Russian Federation from the Council of Europe due to its aggression against Ukraine, adding that despite the difficult situation which led the Organisation to adjust some of its activities, its main objectives have not changed. In the area of media and information, issues surrounding journalists' safety, media sustainability and innovation are high on the agenda, and the two expected deliverables of the MSI-RES are to make an important contribution to these objectives. The Council of Europe has already accomplished a substantial body of work on the issue of AI; based on the elements of a legal framework on AI prepared by the former Ad-Hoc Committee on Artificial Intelligence, a new intergovernmental committee is discussing a convention on the issue. Given the mounting evidence about the risks posed by certain AI applications, it is important to find solutions that will help member states and other relevant stakeholders towards human rights-compliant and safe use of AI, transversally as well as in specific sectors of industry.
- 2. The Committee of Experts was welcomed by Mr Taavo Lumiste, Chair of the Steering Committee on Media and Information Society (CDMSI) which guides and oversees the work of the MSI-RES. Mr Lumiste encouraged regular coordination and open exchanges with the CDMSI, stressing that in the world of many unexpected developments it is crucial to maintain a strategic view and provide coordinated responses to the arising challenges. Both the empowerment of independent pluralistic media and the use of digital tools including AI are urgent topics and it will be important for the MSI-RES to prepare advanced texts by autumn 2023, with clear and implementable guidance for the member states. Another two expert committees have been set up under CDMSI's supervision; the Committee of Experts on the integrity of online information (MSI-INF) is preparing a guidance note on fact-checking and platform design solutions to counter the spread of online mis- and disinformation and the Committee of Experts on strategic lawsuits against public participation (MSI-SLP) is preparing a draft recommendation on SLAPPs.
- 3. The agenda (Appendix I) was adopted without change. According to the list of participants (Appendix II), of 23 members and participants, there were 11 women (48%) and 12 men (52%). The meeting was attended by twelve members (nine in person and three online) as the Committee is currently awaiting replacement election to fill a vacancy.

Elections and appointments

- 4. The MSI-RES unanimously elected Mr Ramón Salaverría, Professor of Journalism at the Center of Internet Studies & Digital Life, University of Navarra, as Chair, and Mr Manuel Puppis, Professor of Media Structures and Governance in the Department of Communication and Media Research, University of Fribourg, as Vice-Chair. Ms Ludmila Andronic, Lecturer in the Department of Journalism and Communication Sciences of the Moldova State University, was appointed Gender Equality Rapporteur. In line with Article 12e of Resolution CM/Res(2021)3 on intergovernmental committees and subordinate bodies, their terms of reference and working methods, the term of office of the Chair and Vice-Chair is one year, renewable once.
- 5. The Committee also designated two drafting rapporteurs to work on each of the two documents it is tasked to prepare. Ms Natali Helberger, Professor in information law at the Institute for Information Law, University of Amsterdam, and Mr Richard Fletcher, Senior Research Fellow at the Reuters Institute for the Study of Journalism, University of Oxford, were entrusted with the preparation of the Draft guidelines on the use of digital tools including artificial intelligence for journalism/by journalists. Ms Elda Brogi, Professor (part-time) at the European University Institute, Florence, and Scientific Coordinator at the Centre for Media Pluralism and Media Freedom, and Ms Helle Sjøvaag, Professor of Journalism at the University of Stavanger, were entrusted the with the preparation of Good practices for sustainable media funding.

Conclusions and decisions

- 6. The MSI-RES took note of its <u>Terms of Reference</u> and Resolution <u>CM/Res(2021)3</u>. It discussed the scope, elements and structure of the two deliverables it is expected to finalise by the end of its mandate in December 2023:
 - Draft Guidelines on the use of digital tools including artificial intelligence (AI) for journalism/by journalists
 - Good practices for sustainable media financing
- 7. The Draft Guidelines on the use of digital tools including artificial intelligence (AI) for journalism/by journalists will explore how digital technologies including AI can help increase media resilience. MSI-RES decided to focus on news media and formulate useful guidance for both journalists as the producers of news content and, in a wider perspective, for journalism as a public good as well as a business.
- 8. The Guidelines will build on several existing instruments including the Committee of Ministers' recommendations CM/Rec(2020)1 on the human rights impacts of algorithmic systems (regarding the design, development and deployment of AI systems), CM/Rec(2022)4 on promoting a favourable environment for quality journalism in the digital age (regarding the basic principles of ethical use of AI in media production and dissemination), CM/Rec(2022)11 on principles for media and communication governance (regarding the procedural principles for enacting frameworks on AI in journalism, as well as principles of transparency, explainability and accountability of AI in content production/dissemination), etc. The MSI-RES will also follow the work of the Committee on Artificial Intelligence (CAI) which will in parallel negotiate a legal instrument (a convention) on the development, design and application of artificial intelligence systems based on the Council of Europe's standards. In so far as relevant, the MSI-RES will align its approaches to those outlined in the instrument prepared by the CAI.
- 9. The Guidelines will address primarily states and the media sector but also include guidance to other relevant actors involved in different stages of the AI development lifecycle. As to the material scope, the Guidelines will encompass the AI lifecycle as applied to the media processes: newsgathering, production, dissemination and use. The structure of the document can combine this categorisation with one that follows different levels of impact: individual level (the use of AI by journalists), organisational/newsroom level (AI in journalistic processes) and societal level (AI benefiting public debate).
- 10. Regarding the elements to be included in the Guidelines, it was emphasised that the design and development of Al-powered tools used in journalism should comply with certain universal principles related to the ethical use of Al including contestability, accountability and explainability. The

instrument should explore how to augment and improve journalistic processes with AI. It should further analyse the interdisciplinary nature of the AI lifecycle and the involvement of various other professions (engineers, data scientists) in these processes, also examining where human intervention is most relevant in the AI lifecycle and how to mitigate its potential failures. Another important issue to address is procurement, as many news outlets do not have the scale and resources to develop their own technology and therefore cannot obtain tools adapted to their needs. In this connection, the Committee discussed the role of public service media (PSM) in the development of AI-powered tools serving the public interest and how to embed in them the values of universality, diversity, inclusion, relevance, serendipity etc. It was decided that references to the existing ethical guidelines and best practices in the use of AI in journalism would be appended to the Guidelines.

- 11. A number of opportunities and challenges for the use of AI have been identified by the Committee across different stages of journalistic processes. The most important impacts of AI in journalism were considered to concern editorial decision making and the dissemination of news content. The Expert Committee members pointed to the changing role of journalists and editors and the consequent weakening of their autonomy, while AI developers are gaining relevance in the automatic editorial decision-making processes. Also, Al systems are not only used for content creation; the Guidelines will need to consider their role in gathering data, processing, fact-checking, transcribing, translating, etc. Regarding media dissemination, personalisation technologies (news recommender systems) will be a focus, with possible distinctions between guidance for commercial media and PSM which have different responsibilities and whose role in innovation should be emphasised. One of the main questions is how to optimise the recommender systems for editorial values, such as diversity and objectivity, and how to ensure their uptake. The Guidelines will also address the dissemination infrastructure and explore how infrastructure "for public good" could be created and what obligations states might have in this regard, especially through investments in innovation and education. In terms of media use, the media audiences' interests need to be properly addressed in the Guidelines, particularly regarding the role of AI in accessing news, the inclusion of the technical components and education on AI in media and information literacy programmes and ways to enhance exposure diversity in light of the multi-platform media consumption. Al-related components should also be included in journalism studies and training programmes.
- 12. The MSI-RES is furthermore tasked with drafting **Good practices for sustainable media financing**, a document which is to focus on selected funding models and schemes that have proved impactful, exploring their potential to be multiplied in other Council of Europe member states. In addition to analysing successful funding practices, the report will define persistent challenges and provide recommendations on how to mitigate them. The collection of Good practices will be based on desk-based analysis of the existing research, a survey among the Council of Europe member states (circulated in the CDMSI and possibly EPRA) and specific targeted research. Different systems will be compared, since the same measures can produce different effects in different countries; however, the document will not aim to provide a comprehensive review, but rather to highlight the most important models and trends.
- 13. The Committee identified a number of problems in media financing that require responses, ranging from the reduced ability of the media sector to monetise its products distributed on digital platforms to insufficient willingness of the audiences to pay for news and the limited viability of new funding and ownership forms. Particular challenges are posed by state funding which can be beneficial but also create various dependencies and imbalances. Direct and indirect media subsidies can provide valuable support only if allocated in a transparent, independent and non-discriminatory manner, pointing to the relevance of procedural principles for media governance. Several other possible solutions and examples of concrete funding models/schemes were shared by the members; targeted subsidies can help revive local or regional media, support innovation, and be used to finance publications in minority languages. States can also provide legislative and regulatory frameworks conducive to the sustainable media ecosystems, especially in the areas of taxation and competition. The trends in advertising revenue and especially the shift of this revenue to platforms should be explored, as well as different ways of funding provided by platforms. The media are experimenting with several alternative sources of funding and ownership; however, their impact can vary.

- 14. It will be important for the collection of Good practices to define some indicators for successful funding models and, in this context, articulate the concept of resilience encompassing financial viability and other conditions such as employment security, level of redundancy, ability to perform in various uncertain situations, to hold political systems accountable, to enjoy trust in news sources, etc. Regarding the media consumption side, different national realities were emphasised; in some markets alternative sources of revenue can be important, while in others the audiences are less inclined to pay for their news. It will be important to explore whether good practices could be found or, based on the available research, recommendations made concerning MIL approaches which may increase people's motivation to pay for news. Nevertheless, quality information should be available to everyone, and the PSM plays a crucial role in that regard. However, in many countries the rules on PSM remit and funding no longer fit the purpose and should be revisited. In this connection, potential obligations to share innovation and skills with certain privately-owned media could allay the concerns about anti-competitive behaviour.
- 15. Drafting rapporteurs will provide outlines of the documents based on the discussions and conclusions mentioned above, which will be completed on the basis of comments received from other members. The MSI-RES will proceed with its work in line with the MSI-RES Roadmap (Appendix III) agreed in the meeting.

Any other business

16. The MSI-RES agreed to hold its next meeting in Strasbourg on 29-30 September 2022. In line with established practice, the Secretariat will prepare a draft meeting report to be sent to the Chair and Vice-Chair for consideration. Thereafter, the Secretariat will send the draft report to the MSI-RES, allowing for comments within five full working days. In the absence of comments, the report will be deemed adopted and will be transmitted to the CDMSI for information.
