#### 1. Themes and Schedule

Within the framework of the Greek Chairmanship of the Council of Europe, the 16th Council of Europe Conference of Ministers responsible for Sport is organised by the Enlarged Partial Agreement on Sport (EPAS) in co-operation with the Ministry of Culture and Sports of Greece.

Participants will assess progress achieved since the last Conference (Tbilisi, October 2018) and will discuss two highly topical and interrelated issues:

Theme 1: A European approach to Sport policies: the revision of the European Sports Charter

Theme 2: Human rights in Sport

The conference will be held by remote connection only, using the KUDO platform, and separated into five sessions, spread out over a period of several weeks. The schedule is as follows:

CLOSING SESSION: Thursday 11 February 2021 (10h00-10h30)

All times are Central European Time.

# 2. Participation in the conference

# 3. Registration

Due to technical restrictions, delegations should count up to no more than five persons. We would like to remind national delegations that, as mentioned in the invitation letter, they are kindly invited to include a representative from their national sports movement.

# 4. Interactive participation

During the introductory sessions, the moderators will use the "Mentimeter" online tool and ask the participants to contribute to the discussions in an interactive way. The mobile application for Mentimeter can be downloaded from the usual mobile application stores.

Activity from the Council of Europe's Sport twitter account (@sport\_coe) has already started and will continue throughout all five sessions as well as in between session dates. Participants are encouraged to use the hashtag #Coe4Sport when posting on Twitter.

# 5. Ministerial Round Table on 15 January 2021 - methodology

Ministers/Heads of delegation may take the floor during the round table to make their statements (no more than 3 minutes per person and may cover theme 1, theme 2 or both). All those wishing to connect to the session must register, including Ministers/Heads of Delegation wishing to enroll on the list of requests to speak, via the registration form for this session (https://www.coe.int/en/web/sport/registration-round-table).

The Chair of the Conference of Ministers will only give the floor to those Heads of Delegation who have enrolled to do so and the speaking order will be granted by giving priority to Conference participants first (see section 2.1 of this factsheet), followed by observers (see section 2.2).

Participants who plan to read out written statements <u>must</u> provide them to the secretariat (Despina.tramountani@coe.int) for the interpreters by Monday 11 January 2021 at 12h00 CET. A written communication is more compact than a speech delivered spontaneously and can therefore quickly become unintelligible if technical problems occur. On the other hand, if interpreters have had the time to read the texts beforehand, they will be better able to faithfully convey the speaker's message in all its details and complexity. This is true even if the speaker departs from the original text.

If the Head of Delegation is not available on 15 January, it is possible to send the Secretariat (heather.stewart@coe.int), before 11 January, a pre-recorded video (mp4 format) containing his/her statement. Such statements will be published on the Conference website (after the conference) in the same way as those delivered live, but depending on the timely running of the session, the pre-recorded statements may not be aired on 15 January since priority will be given to maintaining the timeslots confirmed to those who will give their statements live.

# 6. Interpretation

Simultaneous interpretation for all sessions will be provided in English and French. In addition, for the Ministerial Round Table session (15 January 2021) and the Closing session (11 February 2021), passive interpretation into these two languages will be available from German, Greek, Italian, Turkish<sup>1</sup> and Russian.

# 8. Technical questions linked with the use of the Kudo platform and trainings

# **Training**

Before the event date, any invitee (participant, speaker, moderator) must take part in one of the global training sessions scheduled by the Council of Europe Multimedia department.

These trainings are very important as they not only clarify how the Kudo platform works, but also ensure that the participants are seen and heard properly during the meeting as they can test their audio and video equipment, record a test video and test the internet connections. This is essential to ensure a continuous interpreting session.

# Instructions regarding Remote Simultaneous Interpretation (RSI)

During meetings, the Multimedia technicians and the interpreters of the Council of Europe do their utmost to ensure that the statements made by the participants are perfectly audible and interpreted with the utmost accuracy. However, remote interpreting depends on a number of specific technical prerequisites.

# Technical requirements for all participants

- A recent computer with a built-in camera
  - ⇒ Use a USB webcam if your device does not have a built-in camera
  - ⇒ If you use a laptop, use make sure it is connected to power mains.
- The latest version of the most commonly used browsers (Google Chrome, Mozilla Firefox, Edge, Safari, etc...)

⇒ Use **Chrome** preferably

# • A wired headset with a built-in microphone

- ⇒ Do <u>not</u> use Bluetooth earphones or earbuds as they may cause interference with the remote system.
- ⇒ Make sure your headset (both earphones AND microphone) is recognised by your computer before using it with an interpretation system

# A good internet connection

- ⇒ A **wired connection** (ethernet cable between your computer and your internet box) is the preferred option.
- ⇒ If you have to use a wireless connection, keep as close as possible to your internet box.
- During the meeting, **do not** connect more than one device to your internet box. Please ensure that no-one is using your network for gaming or streaming during the meeting;
- $\Rightarrow$  Please switch off any other applications, Outlook, notifications etc.

#### Good acoustic conditions

- ⇒ Join the remote meeting from a quiet, echo-free room. Close all doors and windows. Turn off the ventilation/air conditioning.
- Beware of apparently insignificant noise next to your microphone. Any kind of noise pollution may make your message impossible to understand for your listeners and the interpreters.
- ⇒ Disable all sound notifications ('pings') as they can be highly disruptive for listeners.
- ⇒ Put your telephone on silent mode.

When connecting to KUDO, please complete the field "Display Name" as follows:

• Your country (if you are part of a national delegation) or your Organisation (if you are an observer), followed by your first name and surname.

If the screen freezes during the session, press F5 to refresh the page or leave the session and return again.

Your microphone and camera can only be activated when your request to speak is accepted by the moderator. Firstly you have to send a request by clicking on the button "Request to speak". When your request is accepted you can activate your microphone and your camera, but not before.
