## *Tuesday 8 October 2024* 10th Anniversary of the Macolin Convention

#### SETTING THE SCENE

#### Bjørn Berge Deputy Secretary General, Council of Europe

Mr Bjørn Berge serves as the Council of Europe's Deputy Secretary General since 1 March 2021.

As the Deputy Secretary General he is involved in a number of key areas of the work of the Organisation, including advising and overseeing the implementation of the Secretary General's reform agenda, in line with the decisions and priorities of the Committee of Ministers.

His priorities include shaping the Programme and Budget, while ensuring that the Organisation's activities have maximum impact in advancing democracy, human rights and the rule of law. He also oversees the Council of Europe's staff policy, as well as other key areas of the work of the Organisation.

Before taking up his post, Mr Berge was for a period of four years Director General and Secretary to the Committee of Ministers of the Council of Europe.

Between 2009-2017, he served as Director of the Private Office of the Secretary General and the Deputy Secretary General, helping to prepare, co-ordinate and implement a number of comprehensive reforms of the Organisation.

Mr Berge has over thirty years of international professional experience.

As a former Norwegian diplomat, he served as International Adviser to the Prime Minister and as Deputy Director of the Foreign Minister's Cabinet responsible for all matters related to Parliament. He also served as speechwriter to three Norwegian Foreign Ministers.

Mr Berge has published several books on a range of issues relating to speech writing and speeches, as well as articles on the Council of Europe's mandate and work.

He was a Fulbright Scholar and holds a M.A. in International Relations from the Paul Nitze School of Advanced International Studies (SAIS), Johns Hopkins University, Washington D.C., USA.

#### Pedro Dias Secretary of State for Sport, Portugal

Pedro Dias was born in Vila Nova de Gaia, on August 31, 1968.

He has been Sports Manager since 1995, having worked at the University of Beira Interior (from 1995 to 1998), the University of Minho/SASUM (from 1998 to 2011) and at the Portuguese Football Federation (from 2011 to 2024).

He was a federated athlete in Basketball, Handball, Football and Futsal.

At the University of Beira Interior, he took the course of Textile Engineering (1988) and Management (1995), attended the course of Public Administration at the University of Minho (1998).

At the Universidad Autónoma de Barcelona - Escola de Doutorat de Formació Continuada, he participated in the academic year 2000/2001 in two specialization courses: "Strategic planning in municipals sports entities" and "Management skills for managers of sports facilities".

He was a member of the Installing Committee of the Academic Federation of University Sports-FADU (1989, 1990). He was Vice-President (1991–1993) and President (1993–1995) of the board of FADU.

At the International University Sports Federation (FISU) he was a member of the International Control Commission (1997–2003) and a member of the FISU Executive Committee between 2003 and 2011.

He was a member of the board, with executive functions, at the Portuguese Football Federation (FPF) between 2011 and 2024, having been part of the FPF Emergency Committee during that period.

He was a member of the FIFA Beach Soccer Committee (2014 and 2015), and since 2014 he has been a member of the UEFA Futsal and Beach Soccer Committee where he was Vice-Chair, Vice-President and Member.

Furthermore, he was a member of the General Council of the University of Beira Interior between (2017 and 2020).

He was a Member of the Physical Education and Sports Commission at the School of the Olympic Committee of Portugal between 2017 and 2022.

He was named "Personality of the Year in University Sport" at the Gala of the Portuguese Sports Confederation in 1997, 2007 and 2013.

Furthermore, he was awarded the degree of Commander of the Order of Merit by the President of the Portuguese Republic on December 15, 2015.

In 2021 he was named "Sports Manager of the Year" by the Portuguese Association of Sports Management (APOGESD).

#### André Villas Boas President of FC Porto

Luís André de Pina Cabral e Villas-Boas was born in Porto, on October 17, 1977. His family roots are closely linked to the founding of FC Porto, in 1893, both through António Nicolau de Almeida and José Monteiro da Costa. The connection goes back to José Gerardo Villas-Boas, great-grandfather of

the blue and white leader, whose heir, Gonçalo Manuel, married Margaret Neville Kendall, daughter of Edward Kendall and niece of Albert and Alfred Kendall, merchants living in the city, who helped António Nicolau d'Almeida to found FC Porto and who participated in the club's first ever game, against Clube Lisbonense. Later, in 1906, José Monteiro da Costa resumed the sports activity of the institution and José Gerardo Villas-Boas was one of the first partners to join. His family roots are closely linked to the foundation of FC Porto in 1893, both through António Nicolau de Almeida and José Monteiro da Costa, as his great-grandfather, Edward Kendall, and great-uncles, Albert and Alfred Kendall, were part of the first teams of the club. The pride in being a blue and white fan and the passion for football infected André Villas-Boas from an early age and his presence at Estádio das Antas was common. The young man, passionate about the sport, had brief appearances, as a player, in local clubs, such as Ramaldense and Marechal Gomes da Costa. The technical aspects of the game and training quickly entered the life of the teenager who, in a planned and thoughtful act, questioned the then coach of FC Porto, Bobby Robson. The topic of the conversation was none other than Domingos Paciência, then an idol of Villas-Boas. Surprised by what he had heard, Sir Bobby Robson introduced the 17-year-old to the world of football, encouraging him to attend coaching courses in Portugal and the United Kingdom, where he accompanied Ipswich. At the age of 21, he applied for a position with the Federation of the British Virgin Islands, an ad he had seen in the quarterly magazine of the FA Coaches' Association, becoming the technical coordinator for the development of youth football in the small Caribbean country. Later, he would rise to technical director of the local federation. He returned shortly after to FC Porto, where he guided all levels of the blue and white youth squads, from the starters to the juniors, performing various technical functions at the club, from scouting to observation. José Mourinho's arrival at FC Porto brought him new responsibilities and, during the two seasons in which the club won several national and international titles, such as the 2002/03 UEFA Cup and the 2003/04 Champions League, Villas-Boas joined the coaching team of the main squad. In 2009, he made his debut as head coach at Académica de Coimbra and soon showed his potential. This path led him to receive an invitation to coach FC Porto a year later. The officialization came on June 2, 2010 and a season was enough for Villas-Boas to win the SuperCup Cândido de Oliveira, a National Championship –confirmed, without defeats, with an epic victory at the stadium of the greatest rival –, a Portuguese Cup and the Europa League. He also became the youngest coach ever to win a European event. In recognition of his success, but, above all, praising his love for the club in his heart, FC Porto decided to award him, in 2011, a Golden Dragon. After receiving the trophy from the hands of Jorge Nuno Pinto da Costa, he gave a speech that remains in the memory of all fans. He continued his career in several renowned emblems of European and Asian football, such as Chelsea, Tottenham, Zenit, Shanghai SIPG and Marseille. He began preparing his candidacy to the presidency of FC Porto in 2022. Having received the support and encouragement of many members and fans, André Villas-Boas set as goals for the club modernity, original values, rigor, planning, work, dedication and work, to keep the club triumphant. On April 27, 2024, the list he led received 80% of the votes in the most attended elections in the blue and white history, in which almost 27,000 club members participated. André Villas-Boas took office as 32nd president of FC Porto on May 7, 2024.

#### Pâquerette Girard Zapelli Chief Ethics and Compliance Officer, IOC

Pâquerette Girard Zappelli has been the IOC Ethics and Compliance Officer since September 2002. She is in charge of updating the IOC Code of Ethics, as well as implementing provisions, including the rules regarding manipulation of competition at the Olympic Games. Pâquerette also investigates and submits the cases related to possible breach of ethical principles to the IOC Ethics Commission with a view to recommend sanctions to the IOC Executive Board. She supports the Olympic Movement regarding the fight against attempts to harm the integrity of sport and the prevention of risks of corruption through the International Partnership Against Corruption in Sport (IPACS). Finally, she also leads the IOC Compliance, Risk and Internal Control Unit.

Before joining the IOC, Pâquerette was a judge in France from 1983 to 2002. She was also President of the International Association of Judges (IAJ) from 1998 to 2000 and President of the European Association of Judges (EAJ) from 1994 to 1996. She has written a number of publications in the field of French law and the international judiciary.

#### **George Mavrotas**

# Chair of the Follow-up Committee of the Macolin Convention and Secretary General of Sport, Greece

George Mavrotas was an international water polo player (1984-2000) with 511 caps, participation in 5 Olympic Games (captain 1995-2000). Concurrently with his athletic career, he received his degree in the School of Chemical Engineering in the National Technical University of Athens (NTUA). He received his PhD diploma in 2000 with expertise in Operational Research and today he is an Associate Professor in NTUA. He is in the Stanford list of top 2% scientists for 2024 based on the impact of their scientific publications. In 2015-2019 he was member of the Hellenic Parliament and from 2016 to 2019 member of the Parliamentary Assembly of Council of Europe. In July 2019, he was designated as Secretary General of Sport and renewed his term in July 2023, being also Chairman of the Greek National Platform (EPATHLA) In June 2021 he was elected the Chairman of the Follow Up Committee of the Macolin Convention and he was re-elected in the same position for a second term in May 2023.

#### MAJOR ACHIEVEMENTS OVER THE PAST DECADE

#### Cláudia Cruz Santos Academic professor, University of Coimbra, Portugal

Professor at the Faculty of Law of Coimbra. Author of several published works, supervisor of dozens of master's dissertations, supervisor and examiner of doctoral theses at various universities. Member of the Portuguese Parliament and Vice-Chair of the Committee on Constitutional Affairs, Rights, Freedoms and Guarantees. Member of the Permanent Delegation of the Europol Joint Parliamentary Control Group. Member of the Jury for the Assembly of the Republic Human Rights Prize. President of the Disciplinary Board of the Portuguese Football Federation since July 2020.

#### Jean-Luc Moner-Banet General director, Lotterie Romande

Jean-Luc Moner-Banet is CEO of Loterie Romande in Switzerland. After joining Loterie Romande in 1998, he was appointed Deputy Director General in 2001, rising to his present position in 2007. Prior to serving at Loterie Romande, he spent a decade working in various roles for gaming industry suppliers, including a stint at GTECH Corporation (now IGT).

Beyond his responsibilities at Loterie Romande, he has served as President of the World Lottery Association (WLA) from 2012 to 2018. Since 2008 he has been a member of the WLA ExCom; from 2009–2012 and again since 2021 he is a member of the Executive Committee of the European Lotteries Association (EL). He is also Chair of the WLA Betting Integrity on Sports & Horse Racing Committee and Chair of the EL Sport Working Group.

Mr. Moner-Banet holds a Master's degree in Public Administration from the University of Lausanne, Switzerland.

#### Madalina Diaconu

#### Professor, University of Neuchâtel, Switzerland

A Swiss-Romanian lawyer and academic, Dr. Diaconu specializes in Sports Law and Gambling Law. She has over 24 years' experience in the practice of law, having worked notably for the International Olympic Committee, the European Court of Justice, the Swiss lottery and the UEFA CEDB. As a lawyer, Madalina has extensive practice in integrity, contractual and disciplinary disputes in international sports. In parallel to her activity at the bar, she is a professor at the University of Neuchâtel, where she has been teaching, since 2009, courses in Economic Law and Sport and the Integrity, notably as first co-author of the *Commentary of the Macolin Convention against Competition Manipulation* (Helbing & Lichtenhahn, 2024) and as author of the first compilation of the Swiss Supreme Court's jurisprudence on sports (*Sports Case Law of the Swiss Federal Supreme Court (1980-2022)*, Egis Law 2023)".

#### Guy Reinenbergh National coordinator sports fraud, Federal Police, Belgium

Guy Reinenbergh joined the Belgian Gendarmerie Academy in 1984, where he graduated in 1987.

The last 23 years he worked as leading officer at the Federal Judicial Police in Brussels.

His passion for sports fraud investigations started in 2006, when he was confronted with the first Belgian extensive match fixing network concerning Chinese businessman Zheyun Ye. Under his progressive lead, the network was dismantled and successfully brought to court.

In 2020, Guy Reinenbergh was appointed as National Coordinator for the Belgian National Platform and nominated as Belgian SPOC for Europol, Interpol and the Group of Copenhagen.

Frequently invited as practicioning expert and keynote speaker for international organisations as UNODC, Interpol, Europol, GoC and universities around the world.

His motto: 'To solve apparently unresolvable investigations'

#### Vincent Ven Head of Anti-Match-Fixing, UEFA

Vincent Ven is a Swiss/Hong Kongese sports lawyer who has undertaken several roles within football governing bodies since 2012. From 2017 to 2020 he held the position of Head of Integrity at FIFA and in August 2020, Vincent joined UEFA as Head of Anti-Match-Fixing.

His and his unit's core responsibilities and activities are to promote and preserve the integrity of European football matches and competitions. More specifically, Vincent's role is to develop UEFA's anti-match-fixing strategy through preventive measures, integrity related investigations and the establishment of integrity programs in coordination with various stakeholders such as the 55 UEFA National Associations, international organisations and law enforcement agencies.

Besides, Vincent has been elected as a member of Tennis Europe Ethics Commission in 2023.

#### **OBSTACLES FACED AND CHALLENGES OVERCOME**

#### **Corentin Segalen**

#### Chair of the Group of Copenhagen and Coordinator of the National Platform, France

Corentin Segalen joined the French Gambling Authority (ANJ) in 2015 and has been coordinator of the French national platform against match fixing since it was set up in 2016. The same year, he participated to the creation of the international network of national platforms, the Group of Copenhagen, and was elected Chairman of this network in 2021 and re-elected in 2023. From 2012 to 2014, as the adviser to the Minister of Sport, he was involved in negotiating the Macolin Convention. Before that he worked in the European and French Parliaments between 2006 and 2012. He graduated from the Sorbonne with a Master 2 in History and also holds an MSc in Criminal Justice Policy from the London School of Economics.

#### Luca Esposito

#### General director, World Lottery Association and General Secretary, ULIS

Luca Esposito holds a master's degree in computer science and telecommunications from the University of Calabria and has worked as a technological consultant for companies, including Accenture, McKinsey and Cambridge Technology Partners. Joining the lottery sector in 2009, as IGT Technology Director for central Europe, he handled gaming-industry clients in Switzerland, Germany, Belgium, and Luxembourg. Later recognized for his vast knowledge of operators in the lottery and sports betting sector and their unique needs, Luca began the role of Executive Director of the World Lottery Association (WLA), where he continues to serve. His deep understanding of sports betting and achieving sports integrity led to his other role, serving as General Secretary of the United Lotteries for the Integrity in Sports (ULIS), formerly GLMS, from January 2022. Additionally, in May 2023 he was appointed as Council Member of the Asian Racing Federation Council on Anti-Illegal Betting and Related Financial Crime.

#### Philippe Auclair Investigative journalist

Auclair is the England football correspondent for Eurosport, Swiss national radio RTS, and a regular contributor to The Guardian, for which he specialises in governance issues and the geopolitical dimension of football. His investigations are published by Josimar magazine and on the websites of the BBC. He won the 2012 Football Book of the Year prize both in the UK and in France for his biography of Eric Cantona, The Rebel Who Would Be King, as well as France's 'Scoop Of The Year' Press Award for his investigation into the 'Qatargate' dossier, to which he also devoted two books, published in France and Belgium in 2015 and 2022. He has spent most of the past three years investigating multi-club ownership in football and the sports betting industry as part of a multinational team which won the Investigative Journalism For Europe's Impact Award in 2023.

#### SPOTLIGHT ON THE EUROPEAN SPORTS CHARTER

#### **Thomas Bach**

#### President of the International Olympic Committee, Olympic Champion in Fencing

Thomas Bach was born on 29 December 1953 in Würzburg, Germany. Married and a lawyer by profession, he has had a successful career in sports both on and off the field of play. He became an Olympic champion when he won a gold medal in fencing (team foil) at the Games of the XXI Olympiad in Montreal in 1976 and in 2006, he was named as the founding President of the German Olympic Sports Confederation (DOSB).

Thomas Bach was an athletes' representative at the XI Olympic Congress in Baden-Baden (1981) and a founding member of the IOC's Athletes' Commission. He became an IOC member in 1991, was elected as a member of the IOC Executive Board in 1996 and served as an IOC Vice-President for more than 10 years. He has also chaired several IOC Commissions.

On 10 September 2013, Thomas Bach was elected as the ninth President of the IOC. He was reelected for a second four-year term on 10 March 2021.

#### Pedro Duarte Minister for Parliamentary Affairs responsible for Sport, Portugal

Pedro Duarte was born in Porto on July 12, 1973.

A man of conviction and consensus, committed to his region, Gil Avérous was awarded the Chevalier de la Légion d'Honneur in 2021.

#### **Cécile Chaussard**

#### Specialist in sports law and senior lecturer in law, University of Bourgogne, France

Cécile Chaussard is a Senior lecturer at the University of Burgundy, qualified to direct research and co-director of the Master 2 *Professions juridiques du sport* at the same university. She has been a member of the Dijon Sports Law Laboratory (CREDIMI) since she wrote her doctoral thesis on sports law (*Les voies de règlement des litiges sportifs - Essai sur la coexistence des différentes formes de justice*, Diffusion ANRT, 2006), a subject which remains at the heart of her research. In parallel, she has developed other areas of research, including anti-doping and special international sports law. Since May 2020, she has been a research associate at the University of Sherbrooke's Chair on anti-doping in sport. #### Bjørn Berge Deputy Secretary General, Council of Europe

Effective January 2020, Witold Bańka commenced in his role as President of WADA. Prior to this, since May 2017, Mr. Bańka served as the European representative on WADA's Executive Committee in his capacity as Minister of Sport and Tourism, Poland.

In November 2015, Mr. Bańka was appointed Minister of Sport and Tourism, Poland, to the cabinet of Prime Minister Beata Szydło; and, in December 2017, he was reappointed to the cabinet of Prime Minister Mateusz Morawiecki. In this role, Mr. Bańka initiated the amendment of the Act on Sport that's main objective was to increase transparency of the work of Polish sports associations; and, to eradicate corruption and nepotism from sport. He is the author of the bill on the Fight Against Doping in Sport, which comprehensively regulates all matters relating to combating doping in Poland.

Prior to entering politics, Mr. Bańka worked in the public relations sector, delivering training courses in media relations and reputation management. In this capacity, he also created advertising campaigns and built PR strategies with leading Polish companies.

As a 400-meter runner, Mr. Bańka represented Poland internationally from 2005 – 2012, with career highlights that included: silver medals in 2005 and 2006 at the Polish Athletics Junior Championships; a relay gold in 2005 at the European Athletics Junior Championships in Erfurt, Germany; a gold and a silver medal in 2007 and 2009 respectively at the Summer Universiade in Bangkok, Thailand and those in Belgrade, Serbia; and, a bronze medal in 2007 at the World Athletics Championships in Osaka, Japan.

Mr. Bańka was born in October 1984 in Tychy, Poland; and, graduated with a degree in political science from the Faculty of Social Sciences of the University of Silesia in Katowice, Poland. While he retired from elite sport in 2012, he is still very active in sport, including running marathons.

She served as Chairman of British Rowing from 2013 to 2018, where she played a pivotal role in shaping the strategic direction of the organization. In 2017, she became Vice-Chairman of the British Olympic Association, contributing to the governance and strategic planning of British Olympic sports. Annamarie was appointed Chair of the British Horseracing Authority in June 2019, a position she held until June 2022. Annamarie serves as the President of European Rowing, advocating for the sport at a continental level. She is a member of the Olympic Gender Equality Commission, working towards gender equality in sports globally. IWG is a global network dedicated to advancing gender equality and promoting women's participation in sports. Established in 1994, the IWG works to create a sustainable sporting culture that embraces diversity and inclusivity. It conducts and disseminates research on issues related to women in sports, providing valuable insights and data to inform policy and practice. The IWG organizes the World Conference on Women and Sport every four years, bringing together stakeholders from around the world to share knowledge, experiences, and strategies. It fosters collaboration among governments, sports organizations, educational institutions, and other stakeholders to drive systemic change. The

IWG's work is guided by the Brighton Plus Helsinki 2014 Declaration, which outlines principles and actions to promote gender equality in sports.

#### Paoline Ekambi

#### President and Co-founder of Sportail Community and Ex Captain of the French Basketball team

Paoline Ekambi: President and co-founder of Sportail Community, an ESUS-accredited SSE company whose mission is to connect Top Athletes with companies to help them make efficient after sports career changes. Sportail Community revolutionizes recruitment by connecting this exceptional sports talent with visionary companies, to transform their corporate culture and boost their performance. Prior to her current position, she had a career as a professional basketball player and was Captain of the French Basketball Team. Ekambi began playing basketball at an early age and quickly rose through the ranks to become one of France's most prominent players. She played for the French national team from 1980 to 1993, winning numerous medals. During and after her sporting career, she has been involved in several causes close to her heart, such as Gender Equality, the fight against sexist and sexual violence in sport and beyond. In addition to her work with Sportail Community, Ekambi is also a speaker and co-author of the book "Ma promesse en héritage", published in April 2024. Her story underlines her desire to make a positive impact on society.

She was a four-time WNBA All-Star and a three-time All-WNBA selection. She led the league in assists seven times and won a WNBA championship with the Monarchs in 2005. Before her professional career, she played for Old Dominion University from 1994 to 1998. She helped lead the Lady Monarchs to the 1997 NCAA Championship game and was named to the Final Four All-Tournament team. Penicheiro also played for several European clubs, winning numerous national and international titles, including the EuroLeague and various national championships in Poland, Italy, France, Russia, Latvia, and the Czech Republic. After retiring in 2012, Penicheiro transitioned into a successful career as a sports agent. She represents athletes through the On Time Agency, leveraging her extensive experience and knowledge of the game. The On Time Agency focuses on representing athletes, helping them navigate their professional careers both on and off the field. They provide a range of services including contract negotiations, career planning, and personal branding. In 2019, she was inducted into the Women's Basketball Hall of Fame, defining her legacy as one of the greatest point guards in women's basketball history.

#### André Seabra

#### **Director of the Portugal Football School**

André Seabra is the Director of the Portugal Football School, an initiative by the Portuguese Football Federation aimed at promoting education and research in football. Seabra holds a PhD in Sports Sciences and has two master's degrees, one in Public Health and the other in High Performance Training. He is also an auxiliary professor at the Faculty of Sport, University of Porto. He has authored and co-authored over 150 scientific papers published in national and international journals. His research often focuses on sports science, physical activity, and public health. As the Director, Seabra oversees various educational programs, research projects, and initiatives aimed at improving the quality of football coaching and management in Portugal. The school provides training for coaches, referees, and sports managers, and conducts research to advance the sport. Among some initiatives of the school, there is: focus on applying data analytics to football and futsal. The program includes both virtual and physical components, promoting hands-on activities and collaborative work; The Football Observatory, that aims to forecast demand in sports management and involves critical analysis of the work context and related literature; the school is also involved in research examining the effects of football training on physical fitness, heart health, and bone health among schoolchildren aiming at improving the overall health and fitness of young athletes through structured football training programs.

#### Francine Hetherington Raveney Deputy Executive Secretary of EPAS

Francine Hetherington Raveney is an expert in the fields of: sport policy, gender equality, diversity, project management, script analysis, audiovisual co-productions, and communication, amongst others. She obtained a Masters Degree in English and French Literature at The Queen's College, Oxford University (1992-1996), a Masters Degree in Women's Studies at The Queen's College, Oxford University (1996-1997) and then carried out doctoral studies in France in politics and literature at Strasbourg University (1997-1998).

Since 2000, she has worked in a number of international organisations, including the Council of Europe, where she was a project manager for the Eurimages film fund for 11 years (2009-2020), and WHO Europe (2004-2005) where she was a Managing Editor. She is the founder, former Executive Director and currently an Honorary Member of the European Women's Audiovisual (EWA) Network. She is also a member of the New Dawn Film Fund jury and regularly teaches pitching and gives presentations at festivals and universities throughout Europe.

Since April 2021 she has worked as the Deputy Executive Secretary of the Enlarged Partial Agreement on Sport (EPAS), where she oversees resources, works with the Governing Board and partner organisations to ensure that topical thematic activities (such as gender equality, diversity, integrity and good governance in sport) and conferences (e.g. on combating gender-based violence in sport) are dealt with smoothly and effectively.

#### Duarte Nuno Fernandes Lopes Expert on dual career, Chief of Staff, Secretary of State for Sport, Portugal

Duarte Nuno Fernandes Lopes, currently Chief of Staff to the Secretary of State for Sport, has a career largely dedicated to sport and public administration, emphasising his involvement in promoting dual careers, a balance between academic and sporting success. He has a solid academic background, including a Master's Degree in Sports Science from the Faculty of Sport of the University of Porto (FADEUP) and a Postgraduate Diploma in Business Management from ISCTE. He is currently studying for a PhD in Public Policy at ISCTE.

His professional experience is vast and diverse, with the most notable being as National Technical Director and Secretary General of the Academic University Sports Federation (FADU) between 1996 and 2001. In this role, he developed initiatives to support student-athletes, promoting dual careers. As a manager at the University of Lisbon's Social Action Services and Lisbon University Stadium between 2001 and 2018, he was directly involved in sports management and programs aimed at developing university sports.

In the area of sport, his involvement was even deeper, as vice president and later President of the European Network of Academic Sport Services (ENAS), where he contributed to promoting dual careers on the European stage. He has participated as Portugal's Head of Delegation in various international events, such as the CPLP Sports Games and the World University Games, reinforcing his commitment to the development of young athletes in parallel with their studies.

His career reflects a commitment to valuing sport in the academic context, encouraging the all-round development of student-athletes and promoting public policies that favour the reconciliation of sport and education.

#### Gévrise Emane Lifestyle Athletes Manager, National Institute for Sport, Expertise and Performance (INSEP), France

Gévrise Emane is a renowned French judoka and a key figure at the Institut National du Sport, de l'Expertise et de la Performance (INSEP) in France. She has had an illustrious career in judo, winning an Olympic bronze medal in 2012. Gévrise has won three world championship titles in judo (2007, 2011, 2015) and numerous European titles. As the Lifestyle Athletes Manager at INSEP, Gévrise Emane is responsible for supporting athletes in balancing their sports careers with personal and professional development. Her role includes: providing guidance and support to athletes in their socio-professional development, helping them plan their careers both during and after their sports tenure; overseeing initiatives that promote the well-being and holistic development of athletes, ensuring they have the resources and support needed to succeed in all aspects of life. INSEP is a premier French institution dedicated to the training and development of elite athletes. It is located in the Bois de Vincennes on the outskirts of Paris. INSEP provides top-tier training facilities and educational programs for athletes, helping them excel in their sports while also preparing for life after their athletic careers. The institute is involved in cutting-edge sports science research, focusing on performance enhancement, injury prevention, and recovery. Athletes at INSEP receive holistic support, including medical care, psychological counselling, and career planning services.

#### Sofia Ramalho SLBenfica Basketball Female Team Manager, alumna of the International Basketball Federation's (FIBA) Time Out 2.0 project

Sofia Ramalho is the Team Manager for the SL Benfica women's basketball team. She has a distinguished career in basketball, both as a player and now in a managerial role. Sofia played a crucial role in helping SL Benfica's women's team reach the top division in the 2013/14 season and has been recognised for her outstanding performance, including being named MVP by the Portuguese Basketball Federation. Sofia is an alumna of the FIBA's Time Out 2.0 project, an initiative by the International Basketball Federation aimed at supporting basketball players in their transition from sports to the labour market. The project focuses on providing basketball players with the skills and knowledge needed to pursue careers outside of sport. This includes training in leadership, management, and other relevant fields. It offers educational and training programmes to help players develop new career paths, ensuring they have sustainable opportunities after their playing careers end. The project also aims to strengthen the governance of basketball organisations by identifying and addressing their weaknesses, promoting better management practices.

#### Andrej Pisl

#### Communications & Project Manager, European University Sports Association (EUSA)

Andrej Pisl is the Projects and Policy Manager at the European University Sports Association (EUSA). In his role, he is responsible for overseeing strategies and managing EU projects that promote university sport across Europe. Andrej leads the EUSA efforts in ensuring effective dissemination of information and engagement with stakeholders. He manages several EU-funded projects aimed at enhancing youth engagement and skills development, facilitating and mentoring young adults. Some of the references include "Sport Employs YOUrope" initiative, European Solidarity Corps volunteering projects, #HealthyLifestyle4All Youth Labs and EUYOUSPORT project. Several of these projects focus on gaining experiences and increasing employability for young people by leveraging the skills and opportunities provided by the sport sector, encouraging entrepreneurial thinking among youth, helping them to develop business ideas and initiatives related to sport. Andrej also plays a crucial role in organising and managing, leading sessions on good governance and youth work.

#### Andy Criere Martin Professional Surfer, Spain

Andy has been crowned the Spanish surfing champion twice, in 2018 and 2023. He is also notably the first Spanish male surfer to qualify for the Olympics. Andy has ventured into the business world, leveraging his surfing fame and expertise. He is involved in projects that promote surfing and a healthy lifestyle. He collaborates with various brands, both within and outside the surfing industry, to promote products and initiatives that align with his values and interests.

#### Laura Capranica European Athlete Student (EAS)

Laura Capranica is a prominent figure in the field of sport sciences. She is a full-time Professor of Sport Sciences at the University of Rome Foro Italico. In addition to her teaching role, she serves as the President of the master's degree on Sport Coaching and is a board member of the Presidents of Italian Degrees in Sport Sciences. She is also known for her work on dual career for athletes, serving as the President of the European Athlete as Student (EAS) network. Her contributions have significantly impacted the development of sport sciences and athlete education. EAS provides a platform for dialogue between educational institutions and sports organisations. This network helps athletes manage their academic and athletic commitments, ensuring they can pursue both without compromising either. The network actively participates in European projects and contributes to the development of dual career policies and practices. It also fosters co-operation among institutions, coaches, teachers, and students to support the holistic development of student-athletes.
