INFORMATION

on execution of the pilot judgment of the European Court on Human rights in case no. 29920/05 *Gerasimov and others v. Russia* (judgment of 1 July 2014, final on 1 October 2014)

Om 27 July 205 the Russian authorities submitted detailed action plan on execution of pilot judgment of the European Court on Human rights on case *Gerasimov* and others v. Russia (DH-DD(2015)772).

This is an updated information concerning adoption of individual measures in order to comply with a decision of national court delivered in favour of applicant Grinko A.A.

As it was informed earlier, Naro-Fominsk Garrison Military Court delivered a judgment in favour of Grinko A.A., where the commander of military unit was imposed with an obligation to provide Grinko A.A. with housing. Before the delivery of judgment by the European Court the Ministry of Defence granted the applicant with housing and Grinko A.A. accepted it, but after that he continually tried to avoid signing tenancy agreement and finally rejected to sing the agreement at all. Further, on the applicant's request, he was provided with another housing and there was initiated preparation of documents, planned to be finished in July 2015.

According to information given by The Ministry of Defence there is a need to prepare documents for alteration of exploitation type for land plots in order to register title to a house, where the flat, distributed to Grinko A.A., is situated. Adoption of relevant order by the Committee on architecture and urban construction of Moscow is planned on September 2015. After the adoption of the order the house is planned to be conveyed to the property of the Russian Federaion, while Grinko A.A. will be proposed to sign tenancy agreement. Noting that Grinko A.A. wishes to live in that certain house, and taking into account that delay of preparation of documents is caused by newly appeared objective circumstances, demanding additional time, completion of work on preparation of documents is planned on December 2015.
