

RESOLUTION (88) 20

on adjustment of the scale of contributions
to the budget of the Partial Agreement on the
Resettlement Fund with effect from 1 January 1989

(adopted by the Committee of Ministers on 28 November 1988
at the 422nd meeting of the Ministers' Deputies)

The Committee of Ministers, under the terms of Article 38 of the Statute of the Council of Europe and with membership restricted to the Representatives of the Council of Europe States which are members of the Resettlement Fund (1),

HAVING REGARD to Resolution (56) 9 of 16 April 1956 concerning adoption of the Articles of Agreement of the Council of Europe Resettlement Fund for National Refugees and Over-Population in Europe;

HAVING REGARD to Resolution (74) 25 as amended by Resolutions (78) 50 and (78) 72 ;

HAVING REGARD to the Secretariat's proposals set out in document CM (88) 102;

CONSIDERING that, in consequence, the scale of contributions by member States to the budget of the Partial Agreement on the Resettlement Fund for the period 1989-1990 needs to be adjusted with effect from 1 January 1989,

RESOLVES AS FOLLOWS:

The scale of contributions by member States to the budget of the Partial Agreement on the Resettlement Fund as appended to this resolution is adopted with effect from 1 January 1989 for the financial years 1989-1990.

(1) Belgium, Cyprus, Denmark, France, Federal Republic of Germany, Greece, Iceland, Italy, Liechtenstein, Luxembourg, Malta, Netherlands, Norway, Portugal, Spain, Sweden, Switzerland and Turkey.
