

**RESOLUTION (63) 21**

*(Adopted by the Ministers' Deputies on 2nd December 1963)*

**PARTIAL AGREEMENT CONCERNING THE RESETTLEMENT FUND**

**- Approval of 1962 Accounts -**

The representatives on the Committee of Ministers of the member States of the Resettlement Fund<sup>1</sup>,

Having regard to Resolution (56) 9 on the adoption of the Articles of Agreement of the Council of Europe Resettlement Fund for national refugees and overpopulation in Europe;

Having regard to the accounts of the Partial Agreement for the Resettlement Fund for the year 1962 as submitted by the Secretary-General, comprising:

- (a) the Appropriation Account,
- (b) the Cash Account,
- (c) the Final Account, all being dated 23rd April 1963;

Having regard to the Secretary-General's memorandum of 15th July 1963, to which these accounts are appended;

Having regard to the Auditors' Report of 27th May 1963,

Resolve as follows:

1. The following accounts, as set out in the tables submitted by the Secretary-General, are hereby approved:

- (a) the Appropriation Account for the financial year 1962,
- (b) the Cash Account for the year 1962,
- (c) the Final Account.

1. Belgium, Cyprus, France, Federal Republic of Germany, Greece, Iceland, Italy, Luxembourg, Turkey.

2. The Secretary-General is discharged from his financial responsibility for the year 1962.

3. The distribution, according to the table set out hereunder, between the member countries of the Resettlement Fund of the total of 11,741.23 francs, as being a surplus for the year 1962 due to those countries, is approved.

A sum of 2,900 francs shall be deducted from the balance and credited to budget receipts for the year 1963 to cover the supplementary appropriations made for that year by Resolution (63) 10.

The remainder, namely 8,841.23 francs, is to be credited to budget receipts for the year 1964 as an advance on contributions due in respect of that year.
