**ACCOUNTS OF THE PARTIAL AGREEMENT ON THE CO-OPERATION GROUP
TO COMBAT DRUG ABUSE AND ILLICIT TRAFFICKING IN DRUGS
(POMPIDOU GROUP) FOR THE FINANCIAL YEAR 1988**

(adopted by the Committee of Ministers on 27 November 1989
at the 431st meeting of the Ministers' Deputies)

The Committee of Ministers, under the terms of Article 16 of the Statute of the Council of Europe, and with membership restricted to the Representatives of the States of the Council of Europe which are members in 1988 of the Co-operation Group (1),

HAVING REGARD to Article 79 of the Financial Regulations ;

HAVING REGARD to the accounts of the Partial Agreement on the Co-operation Group to combat drug abuse and illicit trafficking in drugs (Pompidou Group) for the financial year 1988 as submitted by the Secretary General, comprising :

- a. the budgetary management accounts ;
- b. the balance-sheet as at 31 December 1988 ;

HAVING REGARD to the report of the Board of Auditors
dated 23 June 1989 (CM (89) 6),

RESOLVES AS FOLLOWS :

1. The accounts of the Partial Agreement on the Co-operation Group to combat drug abuse and illicit trafficking in drugs (Pompidou Group) for 1988, as set out in the tables submitted by the Secretary General, are approved.
2. The unexpended balances of the budget appropriations for the financial year 1988, amounting to FF 234,853.60 as shown in the statement submitted by the Secretary General, are cancelled.
3. The Secretary General is hereby discharged from his financial responsibility in respect of the financial year 1988.
4. Approval is hereby given to the manner shown in the appended table of apportioning the financial result of FF 253,548.60 for the financial year 1988 among the member States.
5. The share due to each State from the financial result on the Partial Agreement on the Co-operation Group to combat drug abuse and illicit trafficking in drugs (Pompidou Group) budget will be applied to meet any additional contributions for which that state may become liable should supplementary appropriations be granted in the 1989 budgets, any part of the said share that remains being considered as an advance on its contributions for 1990.
