### **RESOLUTION (76) 50**

#### **CONCERNING THE**

#### PARTIAL AGREEMENT IN THE SOCIAL AND PUBLIC HEALTH FIELDS

#### **ACCOUNTS FOR THE FINANCIAL YEAR 1975**

(Adopted by the Committee of Ministers on 9 December 1976 at the 263rd meeting of the Ministers' Deputies)

The Representatives on the Committee of Ministers of the states signatory to the Partial Agreement in the social and public health fields, <sup>1</sup>

Having regard to Resolution (59) 23, point V;

Having regard to the accounts of the Partial Agreement in the social and public health fields of the financial year 1975 as submitted by the Secretary General, comprising :

a. the budget management account ;

b. the balance sheet at 31 December 1975;

Having regard to the Secretariat memorandum presenting these accounts;

Having regard to the Auditors' report of 2 July 1976,

Resolve as follows :

1. The accounts of the Partial Agreement in the social and public health fields, as set out in the tables submitted by the Secretary General, for the financial year 1975 are approved.

2. The unexpended balances of the appropriations for 1975, amounting to 243 272.12 FF, as shown in the statement submitted by the Secretary General, are cancelled.

3. The Secretary General is hereby discharged from his financial responsibility in respect of the financial year 1975.

4. Approval is hereby given to the manner shown in the appended table of apportioning the credit balance of 246 597.64 FF for the financial year 1975 among the member states. The amount due to the states will be deducted from the contribution to be called for 1977.
