RESOLUTION (85) 19

CONCERNING THE ACCOUNTS OF THE PARTIAL AGREEMENT ON THE CO-OPERATION GROUP TO COMBAT DRUG ABUSE AND ILLICIT TRAFFICKING IN DRUGS (POMPIDOU GROUP) FOR THE FINANCIAL YEAR 1984

*(Adopted by the Committee of Ministers on 22 October 1985
at the 389th meeting of the Ministers' Deputies)*

The Committee of Ministers, under the terms of Article 16 of the Statute of the Council of Europe and with membership restricted to the Representatives of the states of the Council of Europe which were members in 1984 of the Co-operation Group to combat drug abuse and illicit trafficking in drugs (Pompidou Group)¹,

Having regard to the accounts of the Partial Agreement on the Co-operation Group to combat drug abuse and illicit trafficking in drugs for the financial year 1984 as submitted by the Secretary General, comprising :

- a. the budget management account ;
- b. the balance-sheet at 31 December 1984 ;

Having regard to the Secretary General's memorandum presenting these accounts ;

Having regard to the Auditor's Report of 8 July 1985 (Doc. CM (85) 31),

Resolves as follows :

1. The accounts for 1984, as set out in the tables submitted by the Secretary General, are approved.
2. The unexpended balances of the appropriations for 1984, amounting to 65 314,35 FF, as shown in the statement submitted by the Secretary General, are cancelled.
3. The Secretary General is hereby discharged from his financial responsibility in respect of the financial year 1984.
4. Approval is hereby given to the manner shown in the appended table of apportioning the credit balance of 95 986,31 FF for the financial year 1984 among the member states.
5. The share due to each state from the final balance on the Partial Agreement on the Co-operation Group to combat drug abuse and illicit trafficking in drugs (Pompidou Group) budget will be applied to meet any additional contributions for which that state may be liable as a result of supplementary appropriations made in the 1985 budget, any part of the said share that remains being considered as an advance on its contributions for 1986.

1. Belgium, Denmark, France, Federal Republic of Germany, Greece, Ireland, Italy, Luxembourg, Netherlands, Norway, Spain, Sweden, Turkey and United Kingdom.
