

concerning the

**EXTRAORDINARY BUDGET FOR ANNUAL REPAYMENTS
ON THE LOAN CONTRACTED FOR THE ACQUISITION
OF THE NEW PREMISES OF THE EUROPEAN PHARMACOPOEIA
FOR 1993**

(adopted by the Committee of Ministers on 27 November 1992
at the 484th meeting of the Ministers' Deputies)

The Committee of Ministers, under the terms of Article 16 of the Statute of the Council of Europe, and in its composition limited to the Representatives of the States Parties to the Convention on the Elaboration of a European Pharmacopoeia which have opted to participate in the loan to finance the acquisition of the new premises of the Pharmacopoeia (1),

- HAVING REGARD** to Article 38 (b) and (c) of the said Statute;
- HAVING REGARD** to Articles 3, 6, 8, 9, 10, 20, 23 and 28 of the Financial Regulations;
- HAVING REGARD** to Resolution (92) 50 of 27 November 1992 establishing the scale of contributions to the extraordinary budget for annual repayments on the loan contracted for the acquisition of the new premises of the European Pharmacopoeia;
- HAVING REGARD** to the draft extraordinary budget submitted by the Secretary General for 1993 (document CM(92)100, Volume II, Part 5);
- HAVING REGARD** to the Budget Committee's report of 5 October 1992 (document CM(92)164),

RESOLVES AS FOLLOWS:

1. The extraordinary budget for 1993, with expenditure and receipts totalling 5,816,294 F as shown in the appended Tables A and B, is hereby approved.
2. The amount to be paid by member States by way of contribution is 5,816,294 F. This amount is apportioned among member States according to table C appended hereto.

(1) States concerned: Austria, Belgium, Cyprus, France, Greece, Iceland, Ireland, Italy, Netherlands, Norway and Portugal.
