### RESOLUTION (73) 40

#### CONCERNING AMENDMENTS TO THE 1973 PHARMACOPOEIA BUDGET

*(Adopted by the Committee of Ministers on 29 November 1973  
at the 226th meeting of the Ministers' Deputies)*

The Representatives on the Committee of Ministers of the States signatory to the Convention on the Elaboration of a European Pharmacopoeia,<sup>1</sup>

Having regard to Articles 5, 19 and 26 of the Financial Regulations;

Having regard to Resolution (72) 47 of 24 November 1972 approving the Budget of the European Pharmacopoeia for 1973;

Having regard to the Secretariat proposal in Doc. CB (73) 2 (CM (73) 196) concerning the granting and financing of supplementary appropriations for 1973;

Having regard to the Budget Committee's report, Doc. CM (73) 191, paragraph 7;

Whereas certain appropriations and certain estimates of receipts in the European Pharmacopoeia Budget for 1973 need to be increased,

Resolve as follows :

#### Article 1

The appropriations entered in the European Pharmacopoeia Budget for 1973 shall be increased by 130 000 F to be allocated as below :

- Sub-head 1 : Remuneration of permanent staff .....	38 000
- Sub-head 2 : Reimbursements and allowances .....	18 000
- Sub-head 3 : Interpretation and translation .....	60 000
- Sub-head 5 : European Reference Substances Centre .....	14 000

1. Concerns the following States : Belgium, France, Federal Republic of Germany, Italy, Luxembourg, Netherlands, Switzerland and United Kingdom.

## Article 2

The estimates of receipts under Sub-head 4 (contributions by signatory States to the European Pharmacopoeia Budget) shall be increased by 130 000 F.

## Article 3

The Secretary General is hereby authorised to call for a sum of 88 000 F in the form of supplementary contributions from the signatory States towards the European Pharmacopoeia Budget for 1973. That sum shall be apportioned among the signatory States on the same basis as that adopted for the apportionment of the initial contribution entered in the Partial Agreement Budget for 1973 (cf. attached table).

## Article 4

Having regard to the initial figures (Resolution (72) 47 of 24 November 1972) and to the amendments resulting from this resolution, the total of the Budget of expenditure and receipts for 1973 is hereby increased from 2 196 000 F to 2 326 000 F.
