INTERIM REPORT

On application no. 3933/04 *Kopylov v. Russia*, judgment of 29 July 2010, became final on 21 February 2011

Violation

By its judgment in *Kopylov v. Russia*, the European Court of Human Rights found a violation made by the Russian authorities of Article 3 of the Convention for the Protection of Human Rights and Fundamental Freedoms in connection with tortures of the applicant on the part of officers of the Dolgorukovsk Regional Department of the Interior and investigators from the prosecutor's office of the Lipetsk Region in 2001 and ill-treatment with the applicant on the part of escorts in the building of the Lipetsk Regional Court, and failure to conduct an effective investigation into these facts.

The problem of torture and other of ill-treatment of arrested persons and detainees and lack of an effective investigation in this respect in the Russian Federation (the group of Mikheyev cases) had previously been outlined by the European Court and the Committee of Ministers of the Council of Europe (hereinafter - "CMCE"). At present, the Russian authorities carry out a set of measures to address it, on which CMCE is regularly informed.

II. General Measures:

The judgment of the European Court in case *Kopylov v. Russia* was forwarded to the Supreme Court of the Russian Federation, the Constitutional Court of the Russian Federation, the Prosecutor General's Office of the Russian Federation, the Ministry of the Interior of the Russian Federation – for information and applying in practice, for taking measures according to the jurisdiction to eliminate and prevent further violations of the Convention found by the Court.
