



Submission on execution of the judgment of the European Court of Human Rights delivered on 27 November 2014 in the case of <u>AMIROV v. RUSSIA</u>

Moscow April 20, 2016.

On March 24, 2016 the Supreme Court of the Russian Federation dismissed to satisfy the appellate complaints of the attorneys of Amirov S.D. and other convicts.

On the same day the verdict of the North Caucasus District Military Court of August 27, 2015 came into force.

On April 1, 2016 Amirov S.D. was transferred from FKU SIZO-4 FSIN of Russia to FKU IK-6 UFSIN of Russia, Orenburg region, which is named "Black Dolphin" and has the most brutal prison conditions for inmates.

On April 6, 2016 was my visit to Amirov S.D. in this prison.

The state of his health has terribly deteriorated. Because of absence of massage and gymnastic exercises, recommended by doctors, legs of Amirov S.D. have atrophied to a large extent. He also remains concerned about blood sugar level (which fluctuates from 3 to 25 units) and pains in his heart connected with hypertensive disease.

Enemas to empty the bowel, in meaning, are to be done by medical professionals who know how to do it. In this prison cleansing enemas for Amirov S.D. are done by prisoners who have neither experience nor any level of medical education.

I consider it to be inappropriate in such circumstances to draw your attention to the unsanitary conditions in these areas. Currently, it gets the impression that the authorities of the Russian Federation have sent Amirov S.D. to prison not to serve his sentence, but to die, because nothing is done for life and health support of the 1 group disabled man, paralyzed person with inability to self-service.

In connection with the above described I ask to take urgent measures to compel the Russian Federation authorities to execute the judgment of the European Court of Justice and put Amirov S.D. into a hospital for him to have qualified medical treatment.
