As you are aware, the Government submitted an Action Plan on 30 September 2019 and indicated a further Action Plan would be filed on 28 January 2020.

The review of the *ex gratia* scheme, referred to in the Action Plan, remains on going. Due to other domestic considerations, it will not be possible to finalise the next Action Plan before 28 January 2020. I am instructed by my authorities to seek an extension on the date to file an Action Plan to 8 April 2020.
