The Government would like to note that the information provided by the European Human Rights Advocacy Centre in accordance with Rule 9 (1) of the Rules of the Committee of Ministers for the supervision of the execution of judgments and of the terms of friendly settlements relating to measures which are necessary to be taken for implementation of the Court's judgments in *Oleksandr Volkov group* of cases will be translated into Ukrainian and disseminated among all domestic authorities concerned. In particular, this statement concerns the information regarding individual measures taken, *i.e.* examination of the current state of judicial proceedings in the cases pending before the High Council of Justice and the payment of sums awarded by the Court.

Following the comments and clarifications received from the state authorities the Government will further inform the Committee about issues underlined in the European Human Rights Advocacy Centre communication.

The Government of Ukraine would like to assure the Committee of Ministers that the issues raised in the submission will be brought to the attention of the relevant authorities and will keep it informed of all measures taken in this respect.
