Raising the capacities of penitentiary staff in North Macedonia through the development of a structured training

An important focus of the EU and Council of Europe joint support in North Macedonia is to assist public authorities in implementing the prison reform, as well as the protection of prisoners' human rights. In this framework the final draft of Prison Staff Training Strategy and a relevant Programme were designed by a group of experienced representatives from the Directorate for the Execution of Sanctions (DES), probation offices, and various penitentiary institutions.

24 professionals from 5 prisons of Albania and representatives from the Directorate General of Prison Administration increased their capacities on how to provide an in-depth assessment for the development of a multi-disciplinary Individual Treatment Plan. Both medical and psycho-social staff increased their knowledge on disorders in prisons, such as mood, personality, psychotic and post-traumatic stress disorders and related therapies such as Cognitive Behaviour Therapy and Trauma informed care.

Agency for Treatment of Property in Albania capacitated to implement new legislation

The Horizontal Facility programme is assisting public authorities in Albania in the process of aligning the domestic legislation and practice in the field of property rights, with the European Court of Human Rights standards. A two-day workshop was organised in Korça with the staff of the Agency for Treatment of Property (ATP). The purpose of the meeting was to support the capacities of the ATP's staff on concrete measures to comprehensively address the outstanding claims for property return and compensation in view of the new legal requirements and contextual challenges.

Public discussions on amendments to the Law on the Right to Trial Within Reasonable Time take place in Serbia

As a part of the public consultation process aimed at adopting amendments to the Law on the Right to Trial Within Reasonable Time a series of roundtables were conducted in Belgrade. They were organised by the Ministry of Justice in Serbia with the support of the Horizontal Facility programme. The reason for amending the Law is to incorporate provisions aimed at the execution of the European Court of Human Rights' judgment in the case *Kačapor and Others v. Serbia* concerning non-enforcement or delayed enforcement of domestic judicial decisions.

Enhancing Montenegrin law enforcement and prosecution's capacities for cryptocurrency transaction analysis and money laundering typology identification

In co-operation with the Ministry of Interior of Montenegro, a three-day training for the police and prosecutors was organised on 25-27 September 2023. It focused on investigation and seizure of cryptocurrencies and digital assets originating from money laundering. The training provided participants from law enforcement, Financial Intelligence Unit (FIU) and Special Prosecutor's Office with an opportunity to become familiar with the main international standards in this field.

Empowering labour inspectors in North Macedonia to proactively identify and refer potential victims of human trafficking

Labour inspectors and social workers play a fundamental role in the fight against human trafficking for the purpose of labour exploitation and assistance for the victims of human trafficking. To support them, the action on "Strengthening anti-trafficking action in North Macedonia" facilitated a multi-disciplinary training of trainers with 30 selected labour inspectors, social workers, police officers and NGO representatives acting to prevent and combat trafficking cases for labour exploitation.
