This shelter is open to LGBTI victims of domestic violence from all parts of Bosnia and Herzegovina, who need a swift relocation outside their household and a professional and sensitised psycho-social support within a safe environment.

Enhancing prison safety and security in the Western Balkans

One of the main priorities of the programme is to strengthen safety and security in the Western Balkans Beneficiaries by improving management and rehabilitation of prisoners, with a particular focus on violent extremist prisoners and other marginalised and vulnerable prisoners at risk of radicalisation. Through multiple level interventions the actions are continuing to promote and reinforce co-operation, professional networking and exchange of knowledge and best practices between prison, probation practitioners and other stakeholders in the field.

Increasing legal literacy of women in the earthquake-affected regions of Türkiye

A total of 87 women affected by the earthquakes of February 2023 attended a training aiming at empowering them to claim their rights and increased their knowledge on how to access support services.

The trainings were organised in the container cities - housing more than 600.000 people displaced by the earthquakes - of the provinces of Malatya, Adiyaman, Hatay, and Kahramanmaraş.
