Publication of the 2020 edition of the CEPEJ evaluation report on judicial systems



The CEPEJ's evaluation report on European judicial systems, published on 22 October 2020, contains quantified, commented and analysed data on the functioning of the judicial systems of 45 European states and 3 observer states (Morocco, Israel and Kazakhstan), allowing to measure the efficiency and quality for each of them.

It was officially presented at the Online Conference of Ministers of Justice, organised under the Greek Chairmanship of the Committee of Ministers of the Council of Europe on 9 November 2020 and was sent to all the Ministers of Justice of the States that participated in the evaluation exercise.

CEPEJ-GT-QUAL Quality of judicial systems

The **CEPEJ-GT-EVAL** will prepare the 2022 cycle of evaluation of judicial systems aiming at collecting 2020 data from participating member and observer States. Three other data collections in the framework of а collaboration with the European Commission (EU Justice Scoreboard; Western Balkans Dashboard: Dashboard Eastern partnership countries) will be carried out and will lead to CEPEJ reports. Studies on legal professionals will complement the evaluation report - 2020 cycle - and a protocol for the use and transmission of CEPEJ data will be prepared.

The CEPEJ-GT-QUAL will continue its work on a possible operational followup of the CEPEJ Charter on AI, on the basis of a feasibility study adopted at the CEPEJ plenary meeting in December 2020. The various possibilities will be explored by the CEPEJ-GT-QUAL in 2021. Furthermore, the ongoing work on "the centrality of user judicial the in proceedings", "the simplification of language with litigants" and "ensuring gender diversity in the judiciary" will be finalised with the adoption of guidelines and/or a good practice guide for the 47 Member States at the CEPEJ plenary meetings in 2021. Work on mediation and training on CEPEJ tools on quality of justice will be carried out in parallel.

Malta: Supporting the efficiency of Justice in Malta

December 2018 - December 2020

The activities were carried out with funding by the European Union via the Structural Reform Support Programme and in cooperation with the European Commission's DG Structural Reform Support

Support to the development of the Court Administration Agency: CEPEJ experts drafted a report including recommendations on the future development of the Agency and specific recommendations as good practices regards other European from member States were presented by CEPEJ experts.

South Programme III: Ensuring Sustainable Democratic Governance and Human Rights in the Southern Mediterranean

March 2018 – February 2020

The activities were carried out by the CEPEJ in the framework of the joint European Union/Council of Europe programme South Programme III, co-funded by the European Union and the Council of Europe

Training on strategic planning tools and techniques as well as on good administrative and management budgetary practices has been provided for the institutions of judicial governance in Morocco: the CSPJ and the PMP. Training on judicial communication,

particularly in times of crisis, and the use of social networks has been organised for the Tunisian pilot courts and representatives of the judicial press.

Reinforcement of networking and peer-topeer exchanges, with a regional dimension, was offered through regular participation of partners in CEPEJ working group meetings. A new and fruitful cooperation has been developed with the Egyptian Council of State. Following a fact-finding mission to identifv priorities for intervention, capacity-building activities have started to improve the day-to-day

functioning and working methods reduce to procedural delays in the administrative justice system. А user satisfaction survey was conducted with the support of the President of the Council of State, who announced that such surveys would be introduced in his jurisdiction.

Launch of the "Crystal Scales of Justice Prize" awarding innovative practices contributing to the efficiency and the quality of justice

The objective of this Prize is to identify and highlight innovative practices in the organisation of courts and procedures and the functioning of the judicial system in general. These are practices that have been recently implemented. are easilv applicable to other countries or institutions and whose effectiveness can be measured. The competition is open to courts, bar associations, NGOs or any other body competent in judicial matters in a Council of Europe member or observer state. Applications must meet the eligibility criteria as set out in the rules and be sent to the CEPEJ (cepej@coe.int), preferably by electronic means, by 31 March 2021. The award ceremony should take place in Slovenia, at the invitation of the Supreme Court and under the patronage of the Slovenian Ministry of Justice. on 1 October 2021.
