Ses objectifs sont les suivants : améliorer la situation des enfants et des femmes ; faire progresser les mentalités algériennes sur ces questions ; lutter contre la discrimination et toutes les formes de violence ; plaider pour la modification des lois discriminatoires ; assistance psychologique et juridique à des femmes et des enfants en détresse ; réalisation d'études et de recherche sur le domaine des droits de l'enfant et de la femme ; promotion des droits de l'enfant à travers des plaidoyers adressés aux institutions publiques ; information et vulgarisation des droits de l'enfant et de la femme et cela à travers la réalisation de guides, la publication d'une revue trimestrielle et l'organisation de journées d'information et de campagnes de sensibilisation. Le Centre de documentation dispose de plus de 6000 ouvrages qui traitent des droits de l'enfant et de la femme qui sont mis à la disposition des chercheurs et des étudiants.
