Purpose	To improve implementation of standards under the European Convention on Human Rights (ECHR), the standards and findings of the European Committee for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment (CPT) and the Framework Convention for the Protection of National Minorities (FCNM). To bring the legislative framework in the area of human rights, including its institutional aspects, in line with European human rights standards.

Activity	1.2. Support towards the implementation of anti-discrimination legislation
Purpose	Non-discrimination legislation was adopted in Kosovo* in 2004 and its practical implementation is facilitated by a number of Administrative Instructions. However, there is a lack of awareness of its applicability, lack of understanding of its scope and a lack of awareness by the general population on the human right to non-discrimination. The project will combine support to the anti-discrimination mechanisms, technical training for lawyers and NGOs on how to apply the provisions of the anti-discrimination law and draw from the jurisprudence of the European Court of Human Rights (ECtHR). Wider work on public perception will also be carried out.

The project will also seek to develop professionalism, responsibility and respect of ethical rules among journalists. Activity	2.2. JP Project against Economic Crime in Kosovo* (PECK II)
Purpose	The ongoing implementation of PECK I through its identification and assessment tools has so far shown that anti-corruption and AML/CFT systems in Kosovo* remain weak, due to significant deficiencies, particularly in the area of implementation and effectiveness of existing legislative and institutional measures. This is manifested by shortcomings at the level of specific governing institutions and sectors, as well as by major deficiencies of a common and cross-cutting nature such as inefficient interagency cooperation, data gathering, monitoring, lack of resources, etc. There is a need for a sustained and on continuous basis assessment mechanism for Kosovo* in the area of economic crime in order to ensure assessment and measuring of compliance with evolving international and European standards, as well as provide for targeted follow-up assistance based on the gaps and shortcomings identified through the assessment exercise.

Purpose	The overall objective of the proposed project is to increase the efficiency of the judiciary of Kosovo* through strengthening the judges' and prosecutors' capacity as regards the implementation of the ECHR and to bring judicial practice in line with the ECtHR case law. This will increase the possibilities for population of Kosovo* to rely on the ECHR guarantees when seeking the protection of their rights in freedoms in Kosovo* courts. This project will also increase the training capacities of the Kosovo* Justice Institute and to incorporate the CoE HELP Programme into its training curricula.

Activity	2.4. Improving the independence, the quality and efficiency of the justice system of Kosovo*
Purpose	The project aims to support the Kosovo* justice system to better comply with the standards set by the CoE as regards the independence and the professionalism of the judiciary and the prosecution, by ensuring that these standards are known and applied in the day-to-day work of the institutions responsible for the career of judges and prosecutors. In addition, the project aims to improve the day-to-day functioning and quality of the justice system, by making available to the authorities the well-known methodology and tools of the CEPEJ, which have not been applied in Kosovo* so far. Their application should lead to an increased capacity of the responsible authorities to assess the efficiency of the Kosovo* judicial system, as well as to ensure that justice is delivered within a reasonable time and that it meets good quality standards, in accordance with the CEPEJ Checklist.

	The efficiency of the Kosovo* judicial system will be assessed and an evaluation report drawn up. CEPEJ tools on time management and quality will be applied in selected pilot courts and the training curriculum of the Kosovo* Judicial Institute will be reviewed, in particular as regards judicial time management and court management. Trainers will be trained with a view to the full dissemination of CEPEJ tools in Kosovo*.

Activity	2.6. Support to the implementation of CPT Standards
Purpose	Further to the publication of the most recent CPT report, there is an opportunity to develop a project providing capacity-building expertise in this area of CPT standards related to detention and closed institutions. This project shall focus on, inter alia, capacity-building support on the implementation of the European Prison rules, targeting both pre-trial and penitentiary facilities. Such a project would also complement other CoE efforts (through the JP on Enhancing Human Rights Protection in Kosovo*- see 1.1) to support efforts to create an OPCAT-compatible Preventive Mechanism and assist it in developing operational capacities in the field. The project shall focus on prison management (combat the phenomena of corruption and favouritism and ill-treatment) and health care in prisons and procedural safeguards against ill-treatment for police.

The project should also improve the overall capacity of public officials and private sector to understand and implement Internet governance from the human rights perspective. It should also allow to strengthen civil society and media's watchdog role on the Internet and human rights and strengthen the capacity of vulnerable groups, particularly children and youth to exercise their human rights on the Internet.

Activity	3.3. Ensuring Quality Education in Kosovo*
Purpose	The focus of this proposed project will be on the one hand traditional areas of expertise of the Council of Europe: education for democratic citizenship and human rights education, history teaching and inclusive education. It will also touch upon a new area – corruption in education - based upon the conclusions of the Ministers of Education in Helsinki in April 2013. The overall objective of the project is to improve quality education in Kosovo*; to promote democratic citizenship and human rights in schools and to support multi-perspectivity in history teaching as a source for reconciliation between communities; to foster inclusive education approaches in the education system; to combat corruption in education and contribute to a pan-European platform of exchange of information and best practices on ethics and integrity in education and to contribute to the “Helsinki agenda for quality education in Europe”.

Activity	3.4. Development of local democracy and governance in Kosovo*
Purpose	The overall objective of the proposed project is to develop local self-government in Kosovo* in accordance with the principles of local and regional democracy. Based on an assessment of the state of implementation of the principles of the European Charter of Local Self-Government, the Congress will organise a seminar in Pristina so as to facilitate discussions among stakeholders, and advise Kosovo* municipalities and authorities on ways how to further strengthen local authorities. The project will also include a capacity building dimension aimed at strengthening the leadership capacities of mayors and members of municipal councils and by this increase confidence and trust of citizens in local authorities. This will be based on a peer-to-peer approach and best practices, involving members of the Congress. (N.B.: The project will be adapted in the light of developments in the field of local and regional democracy).
