# 2023 – 2025 Work Programme

# 'Human Rights at the heart of drug and addiction policies'

### INTRODUCTION

The Pompidou Group provides a forum for open debate to discuss different approaches to drug policy, offers innovative solutions, and facilitates capacity building across disciplines to enhance knowledge for better informed and evidence-based drug policy choices. Given the global nature of drug problems, the Group, as an enlarged partial agreement, has established itself as a bridge between European and other world regions. Through this international co-operation the Pompidou Group has proven competence and capability to move human rights-oriented drug policies forward thus helping to reduce drug use and the associated negative social and health consequences.

The adoption of a revised statute by the Committee of Ministers in 2021 set the impulse for important changes by strengthening the focus on human rights, extending the Pompidou Group's scope of action beyond illicit drugs and fostering synergies within the Council of Europe. Lessons learnt from the COVID-19 crisis have also inspired the Pompidou Group to use new working methods and activity formats. All of which is reflected in this work programme.

Over the next three years the focus will be on promoting sustainable drug and addiction policies in conformity with human rights, safeguarding democratic societies by addressing addictions that impact on human autonomy and decision-making, protecting the rights of persons belonging to vulnerable and risk groups, as well as reducing trafficking of illicit drugs and preventing the diversion of precursors. The regional networks in Europe and beyond will be further developed through sustainable activities such as MedNET, the Mediterranean network, the Criminal Justice and Health in Prisons Programme and the South-East Europe Cooperation.

The over-arching goal of any policy in the field of drugs and addictions is that of well-being as described by the World Health Organization (WHO) in the preamble to its 1946 constitution – "Health is a state of complete physical, mental and social well-being and not merely the absence of disease or infirmity". The Pompidou Group seeks to contribute to accomplishing this goal in all its actions.

#### 1. PROBLEM DESCRIPTION AND ROLE OF THE POMPIDOU GROUP

**Problem description:** People who use drugs or suffer from addictions should not experience attrition of their human rights. Apart from the human rights and public health dimensions of the drug problem, illicit trafficking raises rule of law issues because of its adverse effects for society. The Special Session of the United Nations General Assembly on the World Drug Problem in 2016 (UNGASS 2016) marked the paradigm shift towards a public health approach and human rights centred approach. More effective and humane responses to the problems of drugs and related disorders need to be explored.

**Role of the Pompidou Group:** Being an integral part of the Council of Europe, representing the organisations core values, the Pompidou Group as an enlarged partial agreement can make significant contributions to developing and enhancing drug and addiction policies that guarantee a balance between public safety and the protection and promotion of the individual's rights. The Pompidou Group is recognized at international level for its expertise in promoting humane and sustainable policies by providing multidisciplinary responses to address consequences resulting from use and addictive behaviours. This way it can provide new insights, guidance and tools for policy makers, managers and practitioners involved in drug and addiction policy development, implementation and evaluation.

## 2. STRATEGIC PRIORITIES AND FOCUS

The priorities for the Pompidou Group have been set by the Committee of Ministers of the Council of Europe in the *Council of Europe Strategic Priorities* 2022 – 2025 (<u>doc. CM (2022) 1, p. 100</u>) as follows:

- Promoting sustainable drug and addiction policies in conformity with human rights
- Safeguarding democratic societies by addressing addictions that impact human autonomy
- · Protecting the rights of persons belonging to vulnerable and risk groups
- Reducing trafficking of illicit drugs and preventing the diversion of precursors

In line with the new mandate defined in the Resolution of the *Committee of Ministers of the Council of Europe on the Council of Europe International Co-operation Group on Drugs and Addictions* (<u>doc. CM/Res (2021) 4</u>) the Pompidou Group in executing its mission is focused on:

- Promoting human rights compliance in drug policy responses and exploring strategies to address addictions including those related to the use of communication and information technologies and applications.
- Avoiding overlap of work with other actors in the field and finding synergies in cooperating with international partner organisations, in particular EMCDDA, WHO, UNODC and CICAD with whom the Pompidou Group has cooperation arrangements.
- Achieving further synergy effects and increasing visibility and relevance by engaging with and contributing to related activities of other Council of Europe entities, notably on issues concerning women, children, vulnerable and risk groups, information society, health in prison, money laundering and cybercrime.
- Addressing human rights, gender and civil society participation as transversal aspects in all Pompidou Group's activities.
- Enhancing capacity building activities that, where appropriate, may be implemented by the newly created International Drug Policy Academy to provide added value.
- Continue the regional sustainable networks such as the Mediterranean network MedNET, the Criminal Justice and Health in Prisons Programme and the South-East Europe Cooperation.

### **3.** ACTION

In the pursuit of accomplishing its mission and addressing the binding priorities set by the Committee of Ministers, the work programme has been developed along the following lines of action:

#### **Outcome – The intended and expected effects:**

- 1. **Short term**: Governments have enhanced capacity to make informed and evidence-based drug and addiction policy choices in line with human rights standards.
- Public authorities and non-state actors cooperate across sectors and disciplines.
  2. Medium term: Member States have developed drug and addiction strategies ensuring coherence and cooperation between different sectors involved increasing the effective responses to the
