1. Opening of the meeting by the Chair

Mr James Williams, Chair of the *Ad hoc* Working Group on Reporting opened the meeting and welcomed the participants (see Appendix 2).

2. Adoption of the agenda

The agenda was adopted without change (see Appendix 1)

3. Conclusions of the third meeting of the *Ad hoc* Working Group on Reporting and objectives of the fourth meeting

The Chair recalled the outcomes of the third meeting of the Working Group which took place on 27 June 2023. The Working Group had examined 4 options for reducing the reporting workload and agreed to proceed with a full reporting format aligned with the EU reporting under Article 17 of the Habitats Directive but to report on a reduced number of features.

The Group supported that:

• birds should be excluded as it would be possible to obtain information from other sources such as the Pan European Common Birds Monitoring Scheme.

• the habitats to be reported on should be limited to those where there is a 1:1 correspondence between Annex I of the Habitats Directive and Resolution No. 4 (1996) of the Bern Convention. The Working Group will still have to agree on whether or not to consider marine habitats.

The chair also informed that the expected outcomes of the meeting were to examine and reach a consensus on a way forward for the checklists of species and habitats as well as for the reporting format.

Last but not least, the Working Group would also be invited to elect a new Chair.

4. Checklists of species and habitats

The consultant, Mr Marc Roekaerts, reminded members of the Working Group that the draft checklists were based on the Emerald Network Reference Lists. He presented an Excel file shared with participants ahead of the meeting containing the draft checklists for all the non-EU Contracting Parties having Emerald Network sites. Therefore, Parties such as Monaco which have not submitted Emerald Network sites are not yet included.

He stressed that the checklists will be used to assess the completeness of the reporting and that Parties should therefore carefully review them to ensure they only include features which occur on their respective territories.

Based on the draft checklists presented, 1962 reports on species and approximately 230 reports on habitats would be expected. The breakdown of the reports per species group and per country can be seen in the tables below.

The members of the Working Group acknowledged that the size of countries, and the number of biogeographical regions within countries significantly influence the number of reports. There are considerable differences between Parties and the capacity of the most impacted Parties needs to be taken into consideration. To reduce the reporting burden, these Parties might report a deficiency of data for a number of features.

The Working Group requested Contracting Parties to review their draft checklists by the end of January 2024.

The subsequent discussion was structured along the following headings:

> Marine regions, species and habitats

In principle, reports on features present in the Marine Regions as adopted by 38th Standing Committee (see the <u>map of Marine Regions</u>) are expected to be submitted. The UK and Norway are however the only Parties with features listed against marine biogeographic regions, although some other Parties have marine species listed against their terrestrial regions.

Because Parties are reporting on marine features within the frame of other Conventions or because data on marine features are the responsibility of other departments than the ministry in charge of environmental matters, members of the Working Group were overall in favour of excluding marine species and habitats from the checklists. Nevertheless, some Parties such as Monaco, might have significantly more data available for marine than for terrestrial features. Furthermore, considering that EU Member States surrounding Monaco would report on marine features, there could be some benefit from Monaco including marine features in its checklists.

The Working Group supported that, as a principle, marine features would not be included in the checklists but that Parties could decide to report on marine features on a voluntary basis. The checklists would need to be adjusted accordingly.

> Species subject to reservations

The Working Group acknowledged that when reservations exist, Parties do not have conservation obligations towards the species concerned. Nevertheless, it would be sensible to assess through the reporting under Resolution No. 8 (2012) whether these species require conservation measures to be implemented or not. Therefore, the Working Group supported that Parties are *invited* to report on species subject to reservations.

> Species marked with (#)

Species marked with (#) in Resolution No. 6 (1998) do not require specific habitat protection measures because they are considered as common in a number of Parties. In other words, Parties having marked species with (#) are not required to designate Emerald Network sites for the species concerned.

The Working Group acknowledged that the reporting under Resolution No. 8 (2012) had a broader scope than the Emerald Network and aimed to assess the national resources. Therefore, the Working Group supported that species marked with (#) should be included in the checklists.

5. State of preparation of the reporting under Article 17 of the Habitats Directive and status of ReportNet 3

The representative of the European Topic Centre for Biodiversity and Ecosystems (ETC/BE), Ms Rafaella Canessa Mesías, informed members of the Working Group of state of play of the preparation of the reporting under Article 17 of the EU Habitats Directive.

She stressed that the reporting format, the explanatory notes and guidelines, the list of conservation measures and the list of pressures and threats had already been reviewed by EU Member States and were available from the <u>Reference portal for reporting under Article 17 of the Habitats Directive</u>. Further resources were still in preparation such as Population units and Checklists of species and habitats.

The reporting mechanism was also in development. It was expected to be tested, finalised and made available to EU Member States by the end of 2024. The delivery deadline of the reports under Article 17 is set as 31 July 2025.

The representative of the European Environment Agency (EEA), Ms Eleni Tryfon, informed members of the Working Group of the major changes to the reporting format and of the rationale behind the changes. Both are summarised in the table below.

6. Reporting format

The consultant, Mr Marc Roekaerts, introduced the draft reporting format (document T-PVS/PA(2023)04). He stressed that the reporting format was grounded on the format used for the 2019 reporting cycle amended so as to reflect the changes in the format of the reporting under Article 17 of EU Habitats Directive. He also stressed that all the sections concerning birds had been deleted.

He drew the attention of the members of Working Group to the simplifications resulting from the revision of the format of the reporting under Article 17 of the EU Habitats Directive to avoid the duplication of data collection and to some fields such as "change and reason for change" which would not apply to the reporting under Resolution No. 8 (2012) as no baseline had yet been set.

The subsequent discussion was structured along the following headings:

General Reporting format

The Working Group welcomed the simplifications and changes imported from the revised format of the reporting under Article 17 of the EU Habitats Directive. Members supported the further deletion of the sections 2.8 to 2.12 as well.

Favourable Reference Values

While the Working Group took note of the replacement of the operators by pre-defined ranges to set favourable reference values needed for assessing the conservation status, members questioned the availability of the data to set numbers, though it will be possible to record the quality of the data.

> Range when the Convention came into force

The Working discussed several options namely the date the Convention entered into force for Parties, the date of adoption of Resolutions No. 4 (1996) and No. 6 (1998) and the date of adoption of Resolution No. 8 (2012). In the end, members of the Working Group supported to consider 2012 as reference date.

> Species population reporting units

Members of the Working Group expressed their concern regarding the replacement of the 1x1 km grid reporting unit by individuals to measure the populations of vertebrates. They appreciated the possibility to use another reporting unit (field "additional population size") in case individuals were unknown, and also noted that lack of information on number of individuals would not be a blocker to report submission.

Percentages estimates for trends

The Working Group took note of the pre-defined ranges for defining the short-term trend magnitude and appreciated the possibility to report "unknown". Members of the Working Group acknowledged the need for guidelines.

Pressures and threats

The Working Group took note of the changes for reporting on the Pressures and threats. Some members expressed concern regarding the availability of data and would prefer that the fields were optional. Others supported the new way pressures and threats would be reported. The Working Group acknowledged the different perspectives and that reporting on pressures and threats would need considerable attention by Parties.

Invasive Alien Species

The format of the reporting under Article 17 of the EU Habitats Directive included a section on Invasive Alien Species (IAS) and referred to a list of IAS of Union concern. The Working Group discussed whether the creation of a list of IAS for non-EU Bern Convention Parties should be considered for the reporting under Resolution No. 8 (2012). Members of the Working Group noted the long development needed for the list of IAS of Union concern and agreed to ask for the advice of the Group of Experts on Invasive Alien Species under the Bern Convention.

> Next Steps

Further discussion of validation rules and whether fields are optional or mandatory will be needed in the next meeting. Looking further forward, Parties were supportive of having training sessions on how to use the online reporting tool.

7. Election of the Chair

Following the resignation of Mr James Williams (United Kingdom) from the position of the Chair, the members of the Working Group elected Ms Salome Nozadze (Georgia) as Chair of the *Ad hoc* Working Group on Reporting as from 2024.

8. Any other business

The Secretariat informed that the 5th meeting of the *Ad hoc* Working Group was provisionally scheduled online on 30 April 2024 and that a 6th meeting was planned later in the autumn 2024. The Chair invited members of the Working Group to already save the date in their calendars.

9. Conclusions of the meeting

The Chair thanked the participants for their constructive inputs and closed the meeting. Members of the Working Group thanked the outgoing Chair for his dedication and leadership.
