
## PILOT COURT ORGANIZATIONAL CHART

# Name of the Court: Baku City Khatai District Court First instance court

Number of judges: 10 (ten) judges, one of which is a president (chairman) of the court.

Administrative posts: head adviser, head-clerk (executive), head of archives, 9 (nine) assistant of judges, 9 (nine) advisors (the court clerks), 9 (nine) senior specialists (operators), 1 (one) advisor (computer programmer).



#### **CIVIL CASES**

- Family cases (Cases connected with marriage contract, violation and invalidity of marriage, definition of paternity and the fact of recognition of paternity, adoption and cancellation of adoption, deprivation of law of parentage, restriction of law of parentage, alimony demand and etc.);
- Labor disputes (job restoration, request on payment of salary, compensation and etc.);
- Housing disputes;
- Property disputes ownership, including disputes on intellectual property law;
- Land disputes;
- Disputes on obligations from agreement (buying and selling (sale), lease, debt, loan, freight (transporting), insurance and etc.)
- Disputes on inheritance law;
- Special proceeding cases (determination (establishment) of facts of legal importance, Declaration of a Person as Missing, Declaration of a Person as Deceased and etc.).
- Protection of Honor and Dignity.

#### **CRIMINAL CASES**

#### 1. Crimes which do not represent big public danger

Crimes which do not represent big public danger shall be deliberate and careless actions for committing of which by the Criminal Code of Azerbaijan Republic, admitted punishment, but not connected to imprisonment, and also deliberate and careless actions for committing of which the maximal punishment provided by the present Code, shall not exceed two years of imprisonment.

#### 2. Less grave crimes

- Less grave crimes shall be deliberate and careless actions for committing of which the maximal punishment, provided by the Criminal Code of Azerbaijan Republic, shall not exceed seven years of imprisonment.

#### **CASES ON OFFENCES**

Consideration of cases of such category is considered in the Code of Offences of the Azerbaijan Republic. Cases considering by our court like a violation of traffic rules by drivers of vehicles, management of vehicles by persons driving the vehicle without the right to drive, sale of products (goods) without excise mark, minor hooliganism, deliberate insubordination to legal demand of police or military servicemen are prevailed.

### CASES CONSIDERED BY THE CONTROL PROCEDURE OF COURTS

- Obligatory Investigation Acts (examination of place of residence, office or industrial buildings, search, seizure, Survey of the persons against there will, except persons caught or arrested, making arrest on property, mail, telegraph, exhumation and etc);
- Procedural coercive measure (detention of a person considered in the law, arrest of a person as a restrictive measure, dismissal of a person from post as a restrictive measure and etc.)
- operational-search measures (listening to phone talks, verification of postal, telegraph and other posts, observation of a flat by using technical meanings and in other way, spy on a people and etc.)
- Complaint from the procedural actions of bodies conducting criminal procedure (refusal from adoption of application on (about) criminal, seizure, detention, violation of rights of seized persons, torture of or cruel treatment against person arrested, rejection from beginning of criminal case.

#### CASES CONNECTED WITH EXECUTION OF SENTENCE AND OTHER FINAL DESISIONS

- Postponing of the punishment, Conditional - prescheduled release from serving a punishment, Replacement of deserved punishment by mitigating kind of correctional and educational intuitions and etc.
