Temporary protection for Ukrainians fleeing the war







# Persons eligible for protection

## Persons who lived in Ukraine before 24.02.2022:

- Ukrainian nationals and their family members (spouses, unmarried minor children or dependent relatives living in the family), and do not hold a Pole's Card
- nationals of third countries, stateless persons and their family members who benefited from any form of international protection in Ukraine before 24.02.2022
- foreigners who stayed based on the permanent residence permit, but cannot return to their country of origin due to the life threat

# Decision-making authority

Office for Foreigners of the Republic of Poland.

A certificate of temporary protection is issued upon request.

# Documents to be furnished

- **application**
- biometric foreign travel passport or other official identification document

# Duration of the status

one year, automatic extension for the following six months (no more than for a year)

# Actions ensuring return to the country of origin

With the assistance of the Head of the Office for Foreigners of the Republic of Poland

#### **Compensation for utility expenses**

- Assistance for accommodation and meals: to persons with disabilities, pregnant women and families with many children. An application is submitted to gmina in person/in soft copy (via e-PUAP).

- The persons enjoying temporary protection who work under an employment contract with the Ukrainian employer are tax residents of Poland if they stay in Poland for more than 183 days.

## Persons who can be provided medical services

#### Conditions for medical aid

- Free medical aid under the same conditions as the Polish nationals
- Fact of the person crossing the border after 24.02.2022 as certified by the Polish services

#### Types of medical services provided

- Free state medicals services: basic medical aid; specialised outpatient aid; diagnostic tests prescribed by the doctor; inpatient treatment; psychiatric treatment; rehabilitation (except for resorts); dental services.
- Mandatory preventive vaccination of the children who stay in Poland for more than three months after the

border is crossed, or confirmation of the child's vaccination under the Preventive Vaccination Programme 2022.

- Medicines will be sold at a pharmacy with a discount by the doctor's prescription.

## **Social support**

#### Social assistance

Exempted from the humanitarian aid tax for the period from 24.02. 2022 until 31.12.2022

# Psychological support of persons affected by the war

- Right to free psychological assistance: +48 222 552 202 (in Ukrainian)
- Free assistance by the psychologist designated by the wójt, burmistrz or president of gmina where the person resides.
- The Ukrainian psychologist may work with the other Ukrainians without diploma nostrification.

### **Education**

# Access to the school education system

Mandatory and free school education for children aged 7 to 18. Knowledge of the Polish language is not a mandatory condition. The students older than 18 can enter senior school on their own.

# Representation of the unaccompanied minors enjoying protection

The Head of the Office for Foreigners applies to court to designate a guardian for the minor who has no guardians and is deprived of adult care.

A child stays in the special fostering institution until the guardian is designated by court.
