Getting to the AGORA Building of the Council of Europe



From the city center, by public transportation :

Strasbourg's public transportation system (CTS) primarily consist of tramway and buses. Tickets can be acquired from ticket vending machines located at stations or through the

mobile application ([Apple/Android](#)). There are also options for daily or weekly passes for frequent travellers. After purchasing your ticket, make sure to validate it if required.



Tramway (CTS): Tramway E (towards *Robertsau l'Escale*) / **Stop at Droits de l'Homme**

For your kind consideration: you need to validate your ticket on the tramway platform, OUTSIDE the tramway.

Bus (CTS): **Stop at Droits de l'Homme**

- Bus C6 (towards *Pont Phario*)



- Bus 30 (towards *Robertsau Chasseur / Robertsau Saint Anne*)

- Bus 72 (towards *La Wantzeneau Le Golf*)

Taxi:



The taxi line is located next to the train station arrival hall and at *Place de la République*, in Strasbourg's city centre. A taxi can also be booked via the official [mobile app](#).

Parking:



There is no public parking at the Council of Europe premises. Metered parking at [Parking Relais Tram](#) (*allée René Cassin*) is an option. Very limited free parking slots are available along the Parc de l'Orangerie.

Badges to enter the Council of Europe



The main entrance of the AGORA Building opens at 8:00am. Participants should arrive with an **identity document** to be presented at the reception, for them to receive nominative badges that will allow them to access the building and to gain the meeting room. Attendees who have pre-registered for the meeting will receive a badge. For security reasons, ad hoc badges will take longer to be issued at the entrance.
