

Security at the Council of Europe

All participants will need a badge to enter any Council of Europe building. For those who do not have a permanent badge, a visitor's badge will be prepared for you once you have confirmed your participation. You will need to have some photo-identification with you to collect this badge at the Agora entrance. Please allow some time to enter the building as there may be other meetings going on the same day.

A visitor's badge will also allow you to access the main building (Palais) of the Council of Europe where you are free to use the canteen, restaurant, newsagents/gift shop and bank. For information, there is a cash machine in the AGORA building on Floor 2 (entry level), as well as in the main building.

Seating in the venue

Seats will be allocated for speakers (by name), for GEC members (by country), for Committee of the Parties of the Istanbul Convention (by country), for GREVIO members (by country) and for international organisations and NGOs (by name). There will be free seating for all other participants.

Meals and refreshments

Refreshments and snacks will be offered by the Council of Europe during coffee breaks in the morning and in the afternoon on 24 May.

A buffet lunch will be offered by the French authorities in the Parliamentarians Bar on the 1^{st} floor in the main "Palais" building of the Council of Europe.
