1 PROJECT BACKGROUND

The project on "Protection of the Rights of Entrepreneurs in the Russian Federation from Corrupt Practices at the Municipal Level" - PRECOP II is a continuation of the project "Protection of the Rights of Entrepreneurs in the Russian Federation from Corrupt Practices – PRECOP RF".

The objective of the project on "Protection of the Rights of Entrepreneurs in the Russian Federation from Corrupt Practices at the Municipal Level" - PRECOP II is to address potential corruption risks faced by entrepreneurs at the municipal level in select geographic regions of the Russian Federation, given that it is in the municipalities where in particular small and medium-size enterprises face the biggest obstacles created by various administrative and other practices that are perceived as presenting high risk for corruption.

The main beneficiary institutions of PRECOP II are the Office of the Federal Business Ombudsman in the Russian Federation and the Offices of Regional Business Ombudspersons, more specifically the 15 pilot regions referred to below.

In overall PRECOP II is directly addressing corruption risks in 15 pilot regions: Republic of Bashkortostan, Republic of Karelia, Udmurt Republic, Republic of Tatarstan, Krasnodar Krai, Primorsky Krai, Stavropol Krai, Arkhangelsk, Kursk, Irkutsk, Rostov, Smolensk, Tver, Tyumen and Yaroslavl regions. However, the outreach of the project goes beyond the 15 pilot regions as confirmed by the fact that stakeholders from 43 non-pilot regions of the Russian Federation have already participated in discussions and provided their feedback on a number of substantial issues dealt with by the project.

The project activities focus on key issues such as corruption typologies affecting the business sector; procurement practices; municipal and government level oversight and control over businesses; rules and regulations governing businesses at the municipal level and strengthening capacities of municipal authorities to deliver public services in a transparent manner. PRECOP II also will seek to find ways of establishing a mechanism through which businesses can report corruption confidentially (anonymously) through the institution of the Business Ombudspersons.

All project activities strengthen the knowledge base of the institution of the Federal Business Ombudsman and the Regional Business Ombudspersons, and thus increase its credibility, legitimacy, and capacity.

Due to the sequential availability of funding the project could not initiate activities in all pilot regions from the beginning of the project, as it would have been done in other circumstances. Instead the project started activities with a smaller group of regions from the pilot group and then, later, as more funding became available the project expanded to include in its activities the other pilot regions, in addition to initiating new types of activities in line with its workplan.

3 IMPLEMENTATION ARRANGEMENTS

Overall project management supervision and quality control is ensured by the Economic Crime and Cooperation Division (ECCD) at the Department of Action against Crime – Directorate General Human Rights and Rule of Law of the Council of Europe in Strasbourg.

For the purpose of implementing the day to day activities the ECCD as envisaged during the development of the project proposal has established a project team consisting of: two Senior Project Officers, a Linguistic Assistant and Project Assistant based in the Council of Europe Programme Office in Moscow. The project team works directly with the beneficiaries and is supervised and supported by a part-time charged team of a Programme Manager, Programme Coordinator and Project Assistant in Strasbourg at the Economic Crime and Cooperation Division.

Furthermore, based on the activity needs and intervention profiles, a number of international and local consultants and experts, service providers and suppliers are directly engaged by the Council of Europe to ensure proper implementation of the project activities.
