



Security and normalisation

Relevant Article 33:

To ensure child protection and well-being, every effort shall be made to enhance mutual respect and tolerance and prevent potentially harmful behaviour between prisoners, their children and families, prison staff or other persons working in or visiting the prison. Good order, safety and security, in particular dynamic security, underpin all efforts to maintain a friendly and positive atmosphere in prison.

- → Security must aim to be dynamic & child centred. Normalisation of contact is key goal
- → Main implementation suggestion: Training of staff

Relation with NGO's

- Interdisciplinary & multi-agency approach: Build interfaces between the authority and civil society
- Involvement in planning sentences & getting ready to leave
- Organise support for the child and the family on the outside, but also after the sentence to the entire family

- → Articles 6, 7, 19, 27, 28, 41, 42, 43, 44, 49 and 51
- → Cooperation with NGOs a way to implement the Recommendations

Engagement with the Justice family

- Cross-organisational structures & Whole-of-government approach: Agencies & government institutions
- IT- & Communication Department (Art. 25 & 26)
- Arrest, prosecution, individual sentencing depends on Police, prosecution authorities and judges (Art. 2, 8, 10)

Child's voice & Data collection

Children of Prisoners expert group reflect on Council of Europe (CM) (2018)5 Recommendation

- Stable and functional social release situation for prisoners, family has crime preventive function
- Preventive work & support due to multiple effects on the children (psychological, physical, social, attachment, environment)
- → Trained staff e.g. "family responsible officer" per prison (visiting hours & rooms, communication, information material)
- → Task for society as a whole: cooperation between various ministries, municipalities, youth welfare offices, NGO's...
